Dear Vice Chancellor,

After several months of discussions with the RUSA authorities,

The Project Approval Body (PAB) of RUSA has approved allocations for four Universities in Kerala, namely the University of Kerala, the Sree Sankaracharya University of Sanskrit, the Mahatma Gandhi University and the University of Calicut. The RUSA authorities kept changing the eligibility criteria and priorities and we had to keep changing our proposals accordingly. Disappointingly, the allocation made is not in accordance with the grand vision of RUSA, but just an Infrastructure Grant. You will get Rs.10 crores each during the current financial year and Rs.10 crores each during the Twelfth Plan period. The next allotment will be based on how the fund is utilized during the current year.

A workshop for the Vice Chancellors of the four Universities will be held on April 30th 2015 in the presence of a RUSA representative. You are requested to prepare a Detailed Project Report (DPR) on utilizing the funds which will be provided to you by the Kerala State Higher Education Council and submit it during the Workshop organized by the Council. The DPRs may give adequate attention to quality improvement programmes/projects etc. The allotment of funds will be as follows: 35% for infrastructure, 35% for renovation and 30% for purchasing lab equipment, computers, library books, sports equipment etc. The DPR should adhere to the norms of allotment strictly.

I hope that you have put in place the structures necessary for implementing RUSA. The names and other details of the RUSA team in your university may please be sent to me.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into by the **State Project Directorate for RUSA** and the benefitting **institution**. The State Project Directorate under the Government is the disbursing agency and the 15 Government colleges and four Universities selected for the infrastructure grants are the benefitting institutions.

Purpose

The smooth implementation of the **RUSA** scheme in the state. The RUSA Mission Authority has sanctioned 110 crores as infrastructure grants to the selected 15 Government Colleges and four Universities to improve the RUSA norms such as access, equity and excellence in the state.

Roles and Responsibilities

To be followed by the **partaking institutions**:

1. Accountability for the funds received.
2. Timely submission of Utilization Certificate (within 2 months) to the RUSA State Project Directorate.
3. Keep Government norms and regulations for purchasing, construction and renovation of infrastructure.
4. Timely audit of the funds spend.
5. Periodic monitoring of the project by the Project Monitoring Unit established by the institution.
6. Establishment of the Board of Governors in the institutional level.
7. Establish a separate account for RUSA in a nationalized bank(preferably Canara Bank which is also the bank preferred by MHRD for RUSA Accounts).

To be followed by the **State Project Directorate for RUSA**:

1. Overseeing project implementation at the state level.
2. Engage project auditors as required.
3. Financial sanction.
4. Disbursing the funds.
5. Overall monitoring of the Project.
