Sub : Election of Twelve members (out of Thirteen members under section 21(a)) and One member under sub-section (b) of section 21 under 'Other Members' of the Calicut University Act, 1975 by the members of the Senate from among themselves to the Syndicate of the University of Calicut - Publishing schedule of Election - reg.

**NOTIFICATION**

It is hereby notified that an election to reconstitute the Syndicate of the University of Calicut according to the principles of proportional representation and in accordance with the procedure laid down in the Statutes on Election will be held as per the schedule shown below to the following categories under the sub section (a) & (b) under "Other Members" of the Section 21 of Chapter IV of the Calicut University Act, 1975, without postal ballot.

- a. Twelve members elected by the Senate from among themselves of whom;
- i. seven shall be persons who are not teachers, of whom one shall be a person belonging to a Scheduled Caste or a Scheduled Tribe.
  - ii. one Principal of First Grade College other than the Principal of a Government college.
  - iii. four shall be teachers who are not Principals, of whom one shall be a University Teacher and one shall be a Teacher of a Government College.

Though the number of principals of first grade colleges to be elected under item (ii) of the sub section (a) of section 21 of Chapter IV of the Calicut University Act, 1975 is 2 (Two), election of one Principal of Government Colleges is not notified since there is no representation for Principals of Government College in the Senate.

- b. One member elected by the members of the Senate from among the members referred to (i) in item (15) under the heading Ex-Officio Members, (ii) in item (12) under the heading Elected Members and (iii) in item (4) under the heading Other Members, in Section 17 of the Calicut University Act, 1975.

Nomination paper in the prescribed form can be had free of cost from the Registrar & Returning Officer, on application by an elector whose name is in the Electoral Roll. The nomination paper shall reach the Returning Officer, University of Calicut, Calicut University P.O or cause to be deposited in the box specifically provided for the purpose in the office of the Returning Officer between the hours of 11.00 am and 03.00 pm on any working day before last date and hour fixed.
