Subject: Release of Admit cards for Stage-III Main (Descriptive) Examination of Shortlisted Candidates for the post of Personal Assistant in the High Court of Delhi- reg.

In continuation to Public Notice dated **20.08.2024** and the Vacancy Notice dated **06.03.2023**, the National Testing Agency is conducting the Stage-III i.e. Main (Descriptive) Examination of the Recruitment Examination for the post of Personal Assistant on 14th September, 2024 (Saturday).

Admit Cards to the Shortlisted Candidates for the above mentioned examination have been released today.

Candidates are advised to download their respective Admit Cards from website(s) <https://recruitment.nta.nic.in/DelhiHCRecruitment/> or <https://delhihighcourt.nic.in/> by using their Application Number and Date of Birth. Candidates are also advised to read "Important Instructions for Candidates appearing in Main (Descriptive) Examination for the Post of Personal Assistant" available on <https://recruitment.nta.nic.in/>. The details of centre, time and shift of the examination shall be as per the Admit Card.

This Admit Card is issued online provisionally to the Candidates, subject to the fulfilment of the eligibility conditions:

- Issuance of this Admit Card, however, shall not necessarily mean acceptance of the fulfilment of eligibility of the candidate, which shall be further be scrutinized at subsequent stages of the recruitment process. Mere possession of this Admit Card shall not entitle the candidate to make any claim to the post.
- Candidate must not mutilate the Admit Card or change any entry made therein. Any tampering in the particulars, photograph, signature, thumb impression in this Admit Card shall be considered as Unfair Means (UFM) practice and the same will be dealt with as per Law.
- Candidates are advised to preserve a copy of their Admit Card in good condition for future reference.
- Admit Card will not be sent by post/mail.
