Producer's description

The Autronica, Type BH-500, smoke detector consists of AutroSafe BDH-500 detector head and AutroSafe BWA-100 detector base. It is a plug-in compatible with the Autronica BWA-100 detector base with loop contact. One LED on the sensor pulses as the detector is polled by the associated control and indicating equipment. This LED illuminates red to indicate the alarm status of the device.

This detector has three adjustable sensitivity settings (Clean, Normal and Industry).

The Autronica BH-500 Smoke Detector is 100 mm diameter and 50 mm high.
