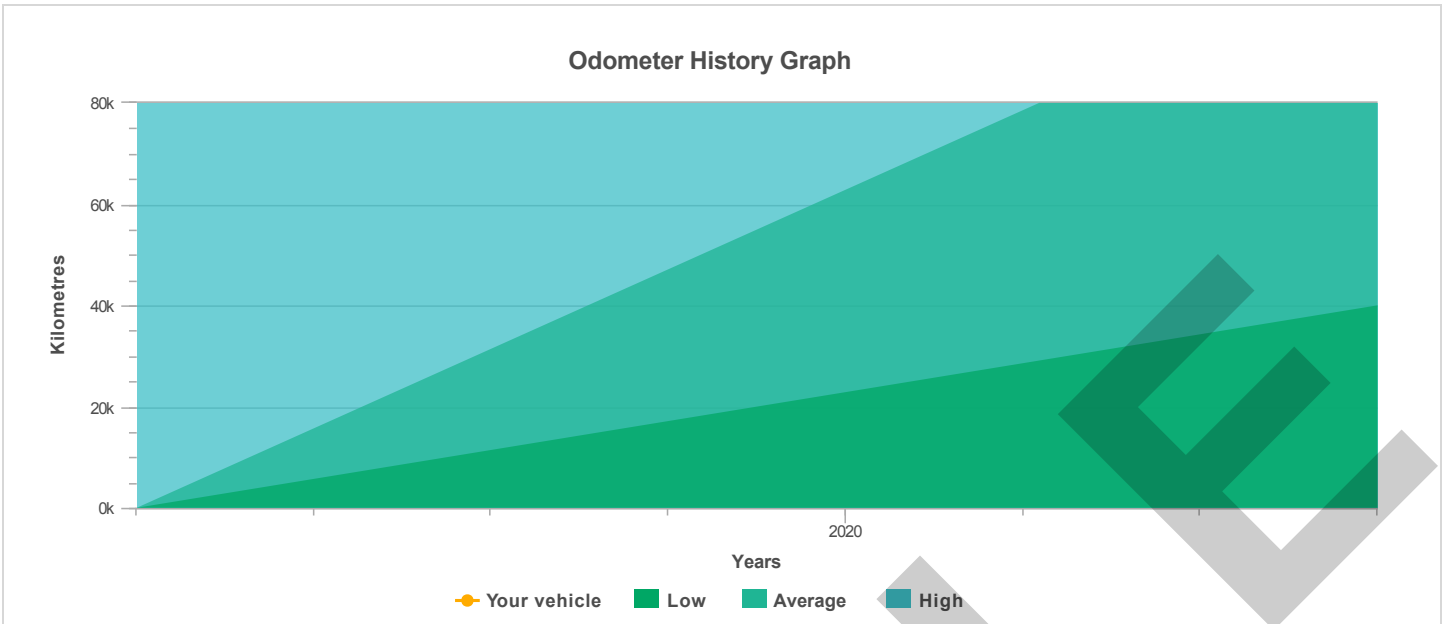

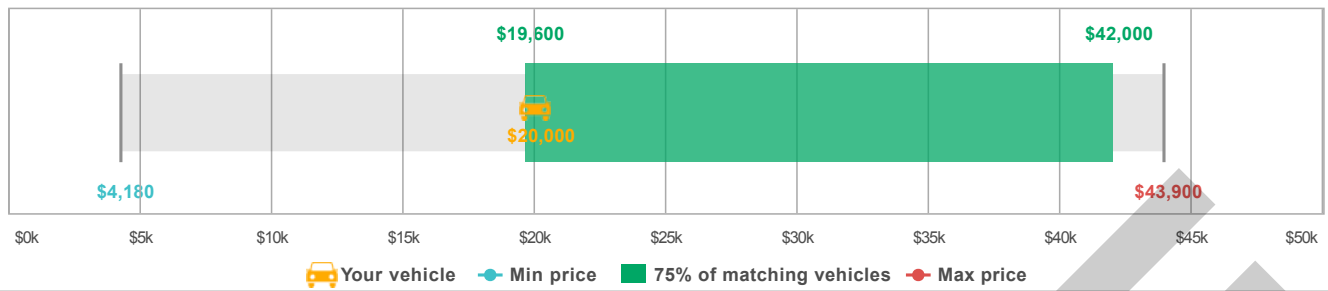

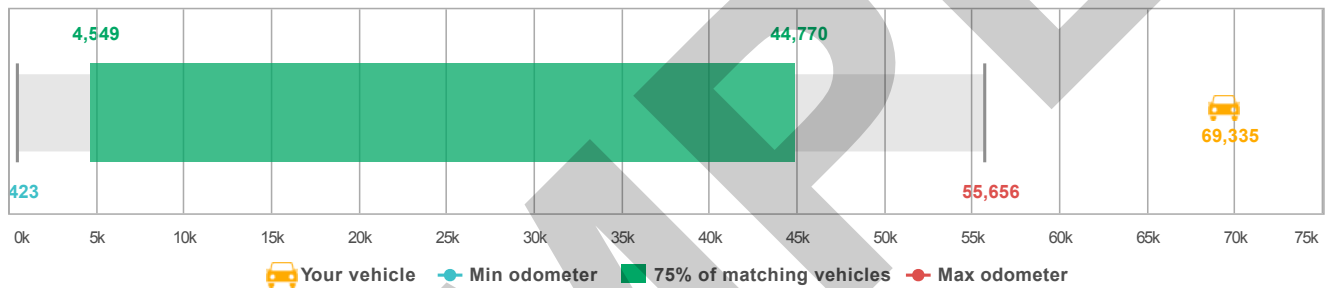
Price Comparison Graph
