VEHICLE PARKING APPLICATION

Release and Waiver for Liability and Indemnity Agreement

The undersigned acknowledges that the County of Monterey is extending a special privilege in allowing them to park their vehicle overnight or store during the dates provided on the application below. In consideration of the privilege to store vehicles at the designated area, the undersigned, for themselves and any personal representative, heirs, and next of kin, hereby acknowledges, agrees and represents the following:

RELEASE

I agree to release, waive, discharge, and covenant not to sue the County of Monterey, its directors, officers, employees, and agents; A & D Narigi Consulting LLC, its directors, officers, employees, and agents; and WeatherTech, its parent subsidiary and affiliated companies, and their officers, directors and employees, from all liability to me, my personal representative, heirs, and next of kin for any loss, theft, or damage, and any claim or demands therefore on account of injury to my property, whether caused by the negligence of the County of Monterey or otherwise during the dates provided below.

INDEMNIFICATION

I agree to indemnify and hold harmless the County of Monterey, its directors, officers, employees, and agents; A & D Narigi Consulting LLC, its directors, officers, employees, and agents; and WeatherTech, its parent subsidiary and affiliated companies, and their officers, directors and employees, from any loss, liability, theft, damage or cost that may incur due to my storing my vehicle, upon or about the County of Monterey's premises whether caused by the negligence of the County of Monterey or otherwise.

ACCEPTANCE OF RISK

I understand that the County of Monterey never intended, nor designed the above-mentioned lot to be used as a storage facility and I acknowledge that the County of Monterey does not guarantee the security of the property being stored. In addition, I realize that the lot is not locked, secured, or guarded. Therefore, I agree to assume full responsibility for and risk of property damage due to the negligence of the County of Monterey or otherwise while my vehicle is stored during the dates provided below.

CONTACT PERSON

I agree to provide a contact person and a telephone number in my absence so that in the event of an emergency, the contact person will be responsible for my vehicle. The undersigned further expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as California law allows and that if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect.

This agreement is signed in Monterey County, which shall be the exclusive venue for resolution or
litigation of any disputes between the parties hereto over this Agreement. The prevailing party in any
such dispute shall be entitled to recover reasonable legal fees and costs. I also represent and warrant that I
have adequate insurance on this vehicle which I will maintain at all times and have advised my insurer
that I am hereby releasing the County of Monterey, State of California, A & D Narigi Consulting LLC
and WeatherTech of any and all liability or claim arising out of the storage of my vehicle(s).


