**Hours of Enforcement**

Parking permits/garage fees are required in all campus lots Monday through Friday, 8 am to 4 pm.  
Reserved parking spaces are enforced seven days per week, twenty-four hours per day.

**Temporary Parking Hangtags**

Make sure that the hangtag has the month, date, and year scratched off. Hang it from the rearview mirror with the printed side facing the front of the vehicle.

**Construction Contractor Parking**

Check with the Parking Office staff for the location of contractor parking lots.

**Reserved Spaces**

Reserved spaces are posted with purple and black “Reserved Parking” signs. Unauthorized vehicles parked in reserved spaces are subject to ticketing and/or towing.

**Ticketing / Towing / Immobilization**

Illegally parked vehicles and vehicles with previous unpaid tickets are subject to ticketing, immobilization (booting), and/or towing. Immobilizers (boots) will not be removed until all fines are paid. All unclaimed immobilized vehicles are removed (commercially towed) from campus daily at 4 p.m.
