YOUR LEGISLATORS' VOTING RECORD ON SMALL BUSINESS ISSUES | 2022 EDITION

Votes by your state legislators on key small business issues are listed here. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislator's attitudes toward small business. Please thank those legislators who supported small business.

BOTH CHAMBERS

- 1. \$15 Minimum Wage (SB 15 with SA1):** Legislation to raise Delaware's minimum wage to \$15 per hour by January 1, 2025. **A "NO" vote supports the NFIB position.** Passed the Senate 14-7. Passed the House 26-15. Signed by the governor.
- 2. Training and Youth Wages (HB 88):** This legislation eliminates the training and youth wages employers were allowed to pay certain workers temporarily. **A "NO" vote supports the NFIB position.** Passed the Senate 13-8. Passed the House 26-15. Signed by the governor.
- 3. Single-Use Plastic Bag Ban (HB 212):** Legislation gradually phases out single-use plastic bags by retailers except under a limited number of circumstances. **A "NO" vote supports the NFIB position.** Passed by the Senate 11-10. Passed the House 28-12. Signed by the governor.
- 4. Wage Theft (SS1 for SB 35 with SA 1):** Legislation makes substantial changes to Delaware's independent contractor law and enhances penalties for violations. **A "NO" vote supports the NFIB position.** Passed the Senate 17-3. Passed the House 32-9. Awaiting action by the governor.
- 5. Workers' Compensation Revisions (SB 315):** Legislation revises state's workers' compensation law to ensure rising employer rates are mitigated by incorporating efforts to modernize claims and processing procedures. **A "YES" vote supports the NFIB position.** Passed the Senate 19-0. Passed the House 41-0. Awaiting action by the governor.
- 6. Paid Family and Medical Leave Insurance (SS2 to SB 1):** Legislation creates a paid family and medical leave insurance program for workers funded through a payroll tax whereby employees and employers contribute to the fund. **A "NO" vote supports the NFIB position.** Passed the Senate 14-7. Passed the House 29-11. Signed by the governor.
- 7. State-run Retirement Program (HB 205):** Legislation creates a retirement program administered by the state but facilitated by employers through payroll deductions. **A "NO" vote supports the NFIB position.** Passed the Senate 20-0. Passed the House 35-5. Awaiting action by the governor.

HOUSE ONLY

- 8. Data Privacy (HB 262):** Legislation would create numerous recordkeeping requirements that would involve small businesses. Further the bill includes enhanced penalties of up to \$10,000 per year under certain circumstances. **A "NO" vote supports the NFIB position.** Passed the House 27-13.

SENATE ONLY

- 9. Delaware Climate Change Solutions Act (SB 305):** Legislation allowed all state agencies to implement climate and environmental policy through regulation without proper legislative oversight. **A "NO" vote supports the NFIB position.** Passed the Senate 13-6.
