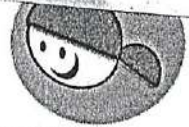

RESOLUTION NO. 027, S. 2022

RESOLUTION AUTHORIZING HON. CESAR M. YNARES TO CAUSE THE DISPOSAL THRU PUBLIC BIDDING OF THE MOVABLE PROPERTIES AND EQUIPMENT OWNED BY THE MUNICIPALITY ON BINANGONAN IN ACCORDANCE WITH THE DISPOSAL PROCEDURE PRESCRIBED BY LAW

WHEREAS, section 16 of R.A. 7160 specifically provides that, "Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, several movable properties and equipment owned by the Municipality of Binangonan has already become dilapidated due to the extent of damage brought by its normal wear and tear and old age;

WHEREAS, repair or rehabilitation of the subject movable properties and equipment are no longer practical for being costly and its maintenance will certainly entail a relatively big amount of money to the disadvantage of the municipality.

WHEREAS, the most practical and economical thing to do is to dispose of the said properties and equipment in accordance with the disposal procedures prescribed by law.

WHEREAS, this resolution is purposely being passed to authorized the Local Chief Executive to disposed of the said articles through public bidding.


NOW THEREFORE, on motion of Hon. Michael Reynan C. Dela Cuesta duly seconded **unanimously by all members of the Sangguniang Bayan, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to approve a Resolution authorizing Hon. Cesar M. Ynares to cause the disposal thru Public Bidding of the movable properties and equipment owned by the Municipality of Binangonan in accordance with the disposal procedure prescribed by law.

RESOLVED FURTHER, that copies of this **Resolution No. 027, S. 2022**, be furnished by the Secretary of the Sanggunian to all concerned for their information and guidance.






