Dear Reader,

In these fast-changing times, beer still stands the test of time, transcending borders and uniting diverse cultures. It brings people together across Europe, to talk, to share and to appreciate a good, refreshing beverage. There is no other drink that has the same power of attraction.

The last few years have seen new challenges coming thick and fast but the beer market is on the road to recovery since the Covid pandemic in 2020 forced bars, cafés and restaurants to close, with lockdowns keeping people from enjoying a beer with friends, family and new acquaintances.

The scars from this period are mapped in the 2023 Edition of our European Beer Trends Report. If 2020 brought an abrupt end to the gradual growth in production and consumption for European brewers, the recovery has been more steady and we can see in 2022 that the market was not yet back to its pre-Covid health.

The statistics show that beer sales in the European Union fell from 322 million hectolitres in 2019 to 297 million hl in 2020 and, while nearly two thirds of the losses had returned by 2022, beer consumption was still only at 313 million hl.

The figures also show how the hospitality sector bore the brunt of the damage and remains under pressure from increased costs and changing lifestyles. While each country has its traditions, the balance between the on-trade of immediate consumption and the off-trade of retail stores has shifted towards the latter. Between 2019 and 2022, the on/off trade mix moved from 68/32 to 59/41 in Spain, from 35/65 to 31/69 in the Czech Republic, and from 45/55 to 41/59 in the UK.

In terms of production, high manufacturing costs (in mid-2023 they were 20-25% higher than in 2019), coupled with a sharp rise in shipping costs have prevented the dynamic export growth of the previous decade that might have compensated for the gradual recovery in beer consumption.

The number of active breweries is however still up: it rose again in the EU from 9500 breweries in 2021 to 9,680 in 2022, still a far cry from the increases at the end of the

last decade when brewery numbers were rising by a thousand a year, but a sure sign that consumer fascination with beer remains. With this growth in brewery numbers is a parallel growth in the diversity and choice on offer for all.

Brewers are naturally resourceful and positive people. We are creative and adaptable. We are innovating to meet consumer demand for diversity and quality, ensuring that there is a beer for everyone and every occasion. For example, non-alcoholic beer now represents over 5% of the European beer market.

Today, the challenges are different. Where once we battled a pandemic, now we face a war in Ukraine, tightening government budgets, a general cost of living crisis and a surge in raw materials prices. For brewers, this also translates into bottlenecks for the imports of cereals and malt, as well as packaging – glass bottles and aluminium cans – and fluctuating energy costs.

To be clear, most of these factors are having an effect across the economy. But in these straitened times, brewers need a supportive fiscal and policy regime, one that also recognises the positive and sustainable contribution that beer and brewing make to European communities, its social wellbeing and the economy.

Nor can we ignore the climate crisis: as temperatures shift further to the extremes, it is affecting agriculture, with harvests coming earlier and – in some cases – fires and floods destroying them. We are looking to the future and it is a future that is sustainable. We have reduced our environmental footprint and our brewers have launched hundreds of pioneering sustainability initiatives over the years. We will continue to transition towards a clean, stable, circular economy. We can do that even as we navigate crises.

As we head into 2024, there will be elections in many places, not least for the European Parliament in June. This will shape Europe's political future: when the new European Commission is in place, it will set new policy priorities. We brewers will have to show the importance and uniqueness of beer, that we can move with the times and that we can adapt to the changing environment.

Beer is deeply entrenched in European history and there is a unique cultural heritage in beer. We need to constantly evolve while staying true to our essence to ensure a positive future. So let us raise a virtual toast to the brewers, the artisans, beer sellers and the enthusiasts who contribute to this ever-evolving story.

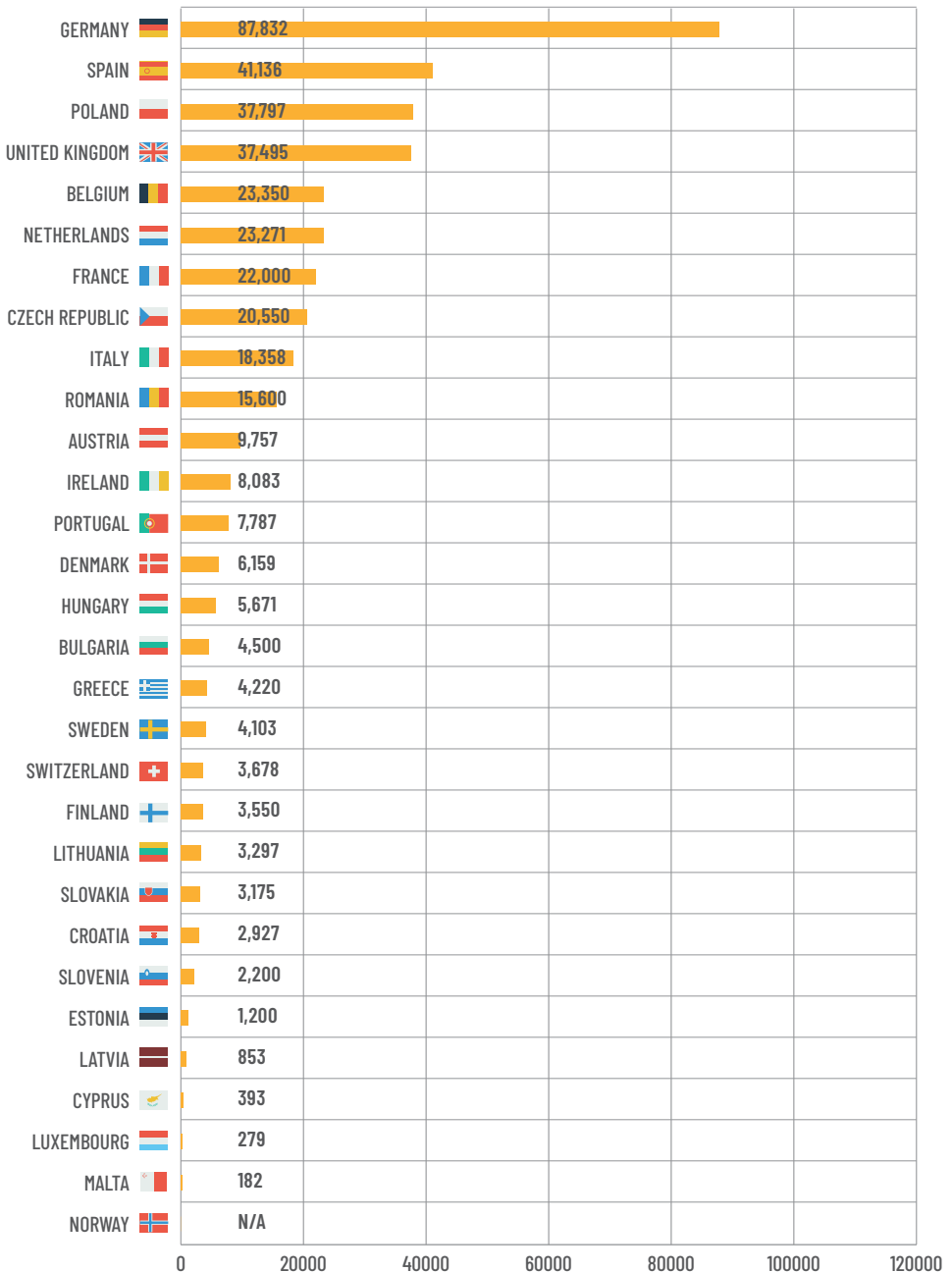
























BEER PRODUCTION 2022















BEER CONSUMPTION PER CAPITA 2022

BEER PRODUCTION:

Beer produced within a given country.

BEER CONSUMPTION:

Beer consumed within a given country.

BEER CONSUMPTION PER CAPITA:

Consumption per head in a given country.

BREWERY:

A plant or an establishment for beer production.

BREWING COMPANY:

A company which produces and / or sells beer, operating one or more breweries. These companies may also be involved in activities other than brewing beer, such as the production of soft drinks and bottled mineral water.

DIRECT EMPLOYMENT:

Employment directly by the brewing companies.

EXCISE DUTY REVENUE RELATED TO BEER:

Government revenues generated from excise duties on the sale of beer.

EXPORT - EXTRA-EU:

Extra-EU exports of goods are goods which leave the territory of the European Union for a third country after being placed under the customs procedure for exports (for definitive export) or outward processing (goods for working, further processing) or repair or following inward processing.

EXPORT - INTRA-EU:

Intra-EU exports of goods are goods which leave a Member State of the EU for another Member State for definitive export, outward processing or repair or following inward processing.

HECTOLITRE (HL):

A hectolitre is a metric unit of volume or capacity where one hectolitre equals 100 litres.

IMPORT - EXTRA-EU:

Extra-EU imports of goods are goods which enter the territory of the European Union from a third country and are placed under the customs procedure for free circulation within the EU (as a general rule goods intended for consumption), inward processing or processing under customs control (goods for working, processing or repair) immediately or after bonded warehousing.

IMPORT - INTRA-EU:

Intra-EU imports of goods are goods which enter a Member State of the EU from another Member State for definitive import (as a general rule goods intended for consumption), inward processing or processing under customs control (goods for working, processing or repair) immediately or after bonded warehousing.

MICROBREWERY:

A brewery with yearly production up to 1,000 hectolitres.

OFF-TRADE SECTOR:

Beer sales through wholesale and retail (shops, supermarkets and other outlets).

ON-TRADE SECTOR:

Beer sales through (licensed) pubs, clubs, bars, restaurants, etc., also called the hospitality sector.

The data for the 2023 edition were mainly collated via the national brewers' associations through surveys by The Brewers of Europe.

With the received data the corresponding tables and charts have been prepared and verified with the interlocutors from different countries. Therefore, unless indicated otherwise in this or previous editions, all data comes from national brewers associations.
