Contemporary Pediatrics Submission Guidelines

Important: Manuscripts that do not follow the submission guidelines will be returned for revision before the submission will be considered.

- Limit feature articles to 2,500 words, excluding references, tables, and other supplementary materials.
- There can be no more than 3 authors per paper. Manuscripts with more authors will be returned for revision.
- Please note: ALL graphics (charts, tables, etc.) must be edit-able; if they are not, we will have to send them back
- We use AMA11 as our publication style, which uses superscript citation numbers and a corresponding numbered reference list. Please create your citations and references in this style. IMPORTANT: Do NOT submit manuscripts with any type of linked references from an Endnote or Reference Manager program. If you use these programs in your writing, kindly unlink the references before submission. Check this recent article posted online at https://www.contemporarypediatrics.com/view/the-rx-of-adhd for examples of reference style. IMPORTANT NOTE WITH AMA 11TH EDITION: PLEASE PUT DOI OR WEBSITES/URLS AT END OF REFERENCE LINE.
- Limit references to 25 and do not use references that are older than 5 years, unless citing seminal studies. If using electronic references, you must supply an active URL that can be accessed; member-only sites that require registration/purchase to view content are discouraged. Finally, avoid using citations from textbooks.
- Figures and/or tables are encouraged. All figures, tables, and images should be original and not previously published in other copyrighted sources. In order to maintain quality and consistency of style, such items will most likely be recreated. You may submit PDFs of already-created figures if they are original and of good quality. Please provide any data for figures that may be recreated, if applicable. Please supply legends for all figures, titles for all tables, and sources for all.
- We encourage a writing style that is more "pediatrician to pediatrician" in its approach (ie, more "conversational") and not overly formal/densely scientific. We ask that you focus on the information of greatest relevance to the community-based physician so that he or she

can immediately apply it to day-to-day practice. Interpreting the clinical literature is important, and where applicable, patient and parent education are also helpful.

- The author information (bylines and short bio sketches), manuscript title, manuscript text, tables and reference material/data to create any tables or figures (if necessary), and the references all should be included in one MS Word document.
- All images must be ORIGINAL separate, high-resolution (minimum 300 dpi) tiffs or jpgs, and sent as separate attachments to your e-mail—do not embed them into the manuscript. Imaging such as x-ray, MRI, and/or CT scans are acceptable; these should be unretouched. Any patient information on these materials will be masked.
- Authors and coauthors each must complete conflict of interest forms, license agreements, and biography information. These forms will be e-mailed to you on acceptance of your manuscript for publication. Further instructions, if necessary, about these forms will be sent along with the forms.
