### USE RELATED TO 2020 UPDATED TITLE IX REGULATIONS

As the Clery Act requirements intersect with the requirements of other federal laws, some of Clery Center's trainings do address and educate on Title IX regulations. Clery Center will support institutions in meeting the updated requirements to make Title IX training materials publicly available by providing, upon request, our related content. Proof of payment for trainings and resources associated with a cost may be required.

Clery Center maintains sole discretion over what, if any, materials used during a training are applicable in order to meet Title IX requirements.

You will have the opportunity to request a copy of the Title IX-related materials used within the training to include in your institution's shared materials. The process for receiving materials will be dependent on the specific training and will be communicated when you register.
