- **As of 9/30/24 there are 32 outstanding minor deficiencies**
- **As of 9/30/24 there are 6 outstanding failed properties – to note 3 of these properties have had tenants removed and are in the process of being rehabbed before renting again.**

Dayton September 2024 Report

Thursday 9/5/24 Picked up a neutered male pit bull from 316 9th. Dog had a rabies tag from a vet. That lead me to the guy who kept the dog for the original owner for a year. He lives in Burlington and can't take the dog back. Dog was taken to the shelter. Owner Heather Gillespie did contact me and she claimed the dog.

Monday 9/9/24 Called to 809 7th ave for a declawed cat found. Cat had a microchip and lives down the street. Cat has stopped using the litterbox so she is now an outdoor cat. She is spayed.

Wednesday 9/11/24 called out for an older neutered male terrier mix with no teeth and no microchip.

Thursday 9/12/24 Received a call that 2 mother cats and some kittens were left abandoned with carriers behind 440 8th ave. I was able to find both mom cats and 8 kittens in the lot. Took to the shelter. Hoping there are cameras to catch the person so we can charge them with animal cruelty 2nd degree.

Called regarding a pit bull with a chain collar at 4th and Ervin. Could not locate.

Also called about a Rottweiler in the alley behind the 600 block of 5th. Did not locate.

Friday 9/13/24 called from 514 8th for a dog in his yard. It was a bullmastiff/pit bull type dog. It had a microchip. Found the owner around the corner, dogs name is Luka.

Monday 9/16/24 385 Manhattan blvd. found a dog adopted from the shelter "Jessie". I tried to get ahold of the dogs owner. Finder will keep and take to the shelter themselves if the owner does not call back by 3:30. Owner did call and got his dog back.

Tuesday 9/17/24 Jessie was out on the floodwall again. Texted the owner and he said she went back to the finder from yesterday. He got his dog back again.

Thursday 9/19/24 Picked up a dog on the floodwall. Dog had tags from the shelter. Back to owner at 201 Clay C2.

Monday 9/23/24 over the weekend I had a call from Berry ave about a missing neighborhood cat. There were workers at 612 Berry doing the floor and they think she could be locked inside the house. I called the city clerk and got the number for the property owner. We checked the house. There was no cat.

Tuesday 9/24/24 found out that 2 people were evicted from 802 6th and the property owner put 3 black cats outside. Looking into charges for cat owners.

Received a complaint about the declawed cat on 7th. Neighbor wants them charged with abandonment. The cat is very over weight and is obviously eating well. Although its not idea the cat is microchipped and spayed. Spoke to the owners they leave food and water out for her.

Monday 9/30/24 impounded a shepherd mix from the 400 block of Kenton. Owner claimed from the shelter.

Fire Chief's Report for September 2024

FIRE & EMS Report

Response calls: 61 Fire runs, and 113 EMS calls were made in September for a total of 174 calls for service.

CPR: There was one CPR class in September.

Training: Members have completed 1623 hours of training through the month of September. Topics this month included Water Supply/Pumps, SOP/SOG review, drivers training, and Haz-mat operations. EMS training was Airway/Respiratory emergencies, Pediatric Cardiac Arrest/Pals, ACLS, and St. Elizabeth Simulation Lab. Our training requirements restart every January and include at least 100 hours of Fire, and 40 hours of EMS training per person.

FIRE INSPECTIONS

Crews completed 4 inspections in September.

BURN PERMITS

Due to the drought conditions, there was a total burn ban for the end of September. Open burning is allowed starting October 1 with a burn permit from the fire department.

PUBLIC ACTIVITIES AND EVENTS.

Another Riverfest has come and gone without any issues. We have taken our boat out of the water for the season.

As you know I am retiring at the end of the month. I would like to thank each and every one of you for the last 6+ yrs of collaboration and professionalism. I walk away after 27 years of service with nothing but gratitude and good thoughts.
