# **EDUPAC SOFTWARE SUPPORT SERVICES (PTY) LTD PRIVACY POLICY**

#### 1 INTRODUCTION

Edupac Software Support Services (Pty) Ltd ("Edupac" or "we" or "us" or "our") respects the privacy of our users ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website <a href="https://www.edupac.co.za">www.tvetonline.co.za</a>, <a href="https://www.tswela.co.za">www.tswela.co.za</a> <a href="https://www.emis.africa">www.emis.africa</a> or any other of our websites that carries our trademark or logo) or information that may be created in our on-line application <a href="https://emis.edupac.co.za">emis.edupac.co.za</a> and our mobile applications "Edupac Parents Portal" or "Edupac Employee Portal", including any other media form (Facebook, Twitter, LinkedIn etc, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site").

Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the site.

We reserve the right to make changes to this Privacy Policy at any time and for any reason. Changes can be noticed by referring to thee "Last Updated" date of this Privacy Policy. Any changes or modifications will be effective immediately upon posting the updated Privacy Policy on the Site, and you waive the right to receive specific notice of each such change or modification.

You are encouraged to periodically review this Privacy Policy to stay informed of updates. You will be deemed to have been made aware of, will be subject to, and will be deemed to have accepted the changes in any revised Privacy Policy by your continued use of the Site after the date such revised Privacy Policy is posted.

## 2 COLLECTION OF YOUR INFORMATION

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

## 2.1 Personal Data

Personal, identifiable information, such as your name, physical and postal addresses, email address, and telephone number, that you voluntarily give to us when you register with the Site or when you choose to participate in various activities related to the Site, such as online chat and message boards. You are under no obligation to provide us with personal information of any kind, however your refusal to do so may prevent you from using certain features of the Site.

#### 2.2 Derivative Data

Information our servers automatically collect when you access the Site, such as your IP address, your browser type, your operating system and your access times. ### 2.3 Financial Data

Financial information, such as data related to your debit order payment method, or information that you supply with proof of payments that we may collect when you purchase, order or request information about our services from the Site or our mobile application. We store only very limited, if any, financial information that we collect. Otherwise, all financial information is stored by our payment processor - Stratcol, and you are encouraged to review their privacy policy and contact them directly for responses to your questions.

#### 2.4 Facebook Permissions

The Site and our mobile application may by default access your <u>Facebook</u> basic account information, including your name, email, gender, birthday, current city, and profile picture URL, as well as other information that you choose to make public. We may also request access to other permissions related to your account, such as friends, check-ins, and likes, and you may choose to grant or deny us access to each individual permission. #### 2.5 Data from Social Networks

User information from social networking sites, such as Facebook, Google+, Instagram, Pinterest, Twitter, including your name, your social network username, location, gender, birth date, email address, profile picture, and public data for contacts, if you connect your account to such social networks.

### 2.6 Mobile Device Data

Device information, such as your mobile device ID, model, and manufacturer, and information about the location of your device, if you access the Site from a mobile device.

## 2.7 Third-Party Data

Information from third parties, such as personal information or network friends, if you connect your account to the third party and grant the Site permission to access this information.

### 2.8 Data from Surveys

Personal and other information you may provide when responding to surveys.

## 2.9 Mobile Application Information

If you connect using our mobile application:

- Geo-Location Information. We may request access or permission to and track location-based information from your
  mobile device, either continuously or while you are using our mobile application, to provide location-based services.
   If you wish to change our access or permissions, you may do so in your device's settings.
- Mobile Device Access. We will not request access or permission to certain features from your mobile device,

including your mobile device's calendar, camera, contacts, microphone, reminders, sensors, SMS messages, social media accounts, storage, and other features. If you wish to change our access or permissions, you may do so in your device's settings.

• *Push Notifications.* We may request to send you push notifications regarding your account or the Application. If you wish to opt-out from receiving these types of communications, you may turn them off in your device's settings.

## 3 USE OF YOUR INFORMATION

Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the Site or our mobile application to:

- Assist law enforcement and respond to subpoena.
- Compile anonymous statistical data and analysis for use internally but will not share it with third parties.
- Create and manage your account.
- Deliver targeted advertising, coupons, newsletters, and other information regarding promotions and the Site and our mobile application to you.

## 4.2 Third-Party Service Providers

## 4.8 Offer Wall

Such an offer wall may appear in our mobile application and be displayed to you based on certain data, such as your geographic area or demographic information.
