Section 3: Supplemental (Non-Vacancy Specific) Recruitment Activities Undertaken by Stations KICD-AM, KICD-FM, KMRR-FM and KMRR HD-2.

KICD-AM, KICD-FM, KMRR-FM, AND KMRR HD-2 HAVE ACHIEVED BROAD OUTREACH THROUGH THE FOLLOWING ACTIONS:

- 1. KICD AM & FM, KMRR FM have broadcast announcements on a monthly basis alerting the public and those interested of our on air openings.
- 2. KICD AM & FM and KMRR FM broadcast various public affairs interviews during the year and aired news stories of various non-profit public events within the broadcast area.
- 3. KICD AM & FM and KMRR FM offer a paid internship program. Interns register for the internship and also receive college credit for the experience. The individuals keep a log of hours and compose a reflection paper on their experience. Our radio stations then evaluate the intern after internship completion and forward that to the broadcast instructor.

The radio stations have also offered job shadowing positions as part of a grade in career development courses at area community High Schools.

4. KICD AM & FM and KMRR FM will broadcast severe weather warnings within the broadcast area to alert the public. When public functions are cancelled or postponements, the stations will make those announcements over the air and made available on the station web sites.
