First Graduate was founded with the purpose of improving college access among aspiring first generation college graduates. Programming began in 2002 based on the premise that helping the first child of a family to graduate from college would result in exponential benefits for the family as a whole, empowering that family economically by spawning a college-going tradition. In the San Francisco Unified School District, 8 of 10 students have parents who are not college graduates. Without help, only 11% of first generation students obtain a college degree. We believe that the first college degree in a family is the key to breaking the cycle of poverty. Donor support provides coaching and academic tutoring for students that would replicate or substitute for the innate advantages that their peers with college-educated parents possess. First Graduate provides 300 hours of free coaching/student/year for 10 years - from the summer before seventh grade through the completion of college and into their first careers. (continued on 4b)

(continued from 4a) First Graduate is the only San Francisco college access program that starts in middle school. In FY14-15, staff and 500+ volunteers helped 320 students from seventh grade through college. Core program components are: Academic instruction and tutoring during a 5-week Summer School and a 35-week School Year Session; high school and college counseling, standardized test preparation, application assistance, financial aid workshops, access to summer enrichment programs, on-campus visits; parent engagement activities including multilingual workshops that address high school selection, college choices, eligibility requirements, application processes, and financial aid; mentors who provide guidance through each program transition, insight into potential college and career pathways. Career exploration activities, counseling, and guidance, are provided from 7th grade through college graduation. Middle school students boost their math and language arts skills to a competitive level. (continued on 4c)

(continued from 4b) 9th - 12th grade students transition to academically rigorous high schools and are coached to complete college prep coursework to achieve CSU and UC eligibility. Through regular contact via email, phone calls and on-campus visits, we coach our college students on financial management, career development, and using campus resources. In doing so, our students accomplish five specific goals: 1) Improve academic skills and knowledge 2) Set long-term goals and high expectations for success 3) Develop decision-making and study skills 4) Expand their horizons as to what is possible with a college degree 5) Engage their families in the process of becoming successful college graduates. As we continue to improve, First Graduate's research-based methods have achieved remarkable results. * The retention rate was 78% overall and 97% for the newest 3 cohorts. * In 2014: 87% enrolled in 4-year and 13% in 2-year colleges; 2013: 85% enrolled in 4-year and 15% in 2-year colleges; 2012: 94% enrolled in 4-year and 6% in 2-year colleges (continued on Schedule O)
