F007-21 Motion by Mr. Moye, second by Mrs. Knight to approve the Age Friendly Region Designation Resolution. The motion was approved.

F008-21 Motion by Mr. Prince, second by Mrs. Knight to approve the purchase of a John Deere TX Gator for the Recreation Department at a price of \$8,079.66 from Ag Pro. This cost will be offset by the sale of the Reel Mower for \$5,258.88 and the old gator for \$2,650.00 for a total of \$7,908.88. This results in a net price of \$170.78 to be funded from contingency. The motion was approved.

NEW/UNFINISHED BUSINESS

Mrs. Murkerson, Finance Director, presented the following,

Financial Review for January 2021

Revenue:

- 1. Based on budget, month-end Revenue was at 92% and the ideal remaining percent was 92% for the General Fund
- a. LOST receipts for January 2021 were \$166,000 compared to \$140,000 for January 2020
- b. SPLOST receipts for January 2021 were \$166,000 compared to \$140,000 for January 2020

c. TSPLOST receipts for January 2021 were \$151,000 which is approximately \$20,000 more than December 2020 and shows a continual increase

Expenditures:

2. Based on budget, month-end Expenditures were at 95% with the ideal remaining percentage was at 92% for the General Fund (under budget)

Other news:

- 3. We have been down 2 people in the Finance area due to surgery and/or illness for the last two weeks. We ask for patience while two of us do the duties of four for the next six or more weeks.
- 4. We have implemented some of the changes/updates in the Finance area that I suggested a few months ago; I went through all the January bank reconciliations with Buddy last week, explained how they all worked, and he signed off on all of them behind me. We will continue this monthly along with signing off on any journal entries that are made throughout the month.

Mr. Johnson informed the board that the Rotary Club will hold a fund-raising fishing tournament at Tired Creek Lake on May 1, 2021.

Mr. Prince brought up the severe problem we have with trash on our roads. Mr. Prince asked if we could get prisoners to help with cleaning up the sides of our roads. Mr. Johnson stated that he would speak with the Sheriff Department and see what we can do.

Mrs. Knight brought up road conditions in our county. She stated the following citizens have contacted her about conditions on their roads,

They are all complaining about their roads.

Mrs. Knight stated she is checking on a Junk Yard in Whigham to ensure they have a business license.

Mr. Prince asked if Mr. Ridley had heard anything else from Mr. Hicks and Mr. Ridley stated he had not heard anything from Mr. Hicks.
