#### **LATVIA**

Identity cards issued by the Ministry of Foreign Affairs

- Category A identity card, for diplomatic staff (with red marking)

These cards are issued to the diplomatic staff (e.g. ambassadors, first secretaries and attachés) of a diplomatic mission, and to members of their families; on the reverse of the card it is stated that the holder enjoys all the privileges and immunities provided for in the Vienna Convention on Diplomatic Relations: ‘Šīs apliecības uzrādītājs bauda visas privilēģijas un imunitātes, kas paredzētas 1961. gada 18. aprīļa Vīnes konvencijā „Par diplomātiskajām attiecībām”’.

- Category B identity card, for administrative and technical staff (with yellow marking)

These cards are issued to the administrative and technical staff of a diplomatic mission; on the reverse of the card it is stated that the holder enjoys partial privileges and immunities under Article 37(2) of the Vienna Convention on Diplomatic Relations of 18 April 1961: ‘Šīs apliecības uzrādītājs bauda daļējas privilēģijas un imunitātes, kas paredzētas administratīvajiem un tehniskajiem darbiniekiem saskaņā ar 1961. gada 18. aprīļa Vīnes konvencijas „Par diplomātiskajām attiecībām” 37. panta 2. punktu’.

- Category C identity card, for the staff of international organisations (white in colour)

These cards are issued to the staff of international organisations and to members of their families; on the reverse of the card it is stated that the holder enjoys the privileges and immunities provided for in the agreement between Latvia and the relevant international organisation: ‘Šīs apliecības uzrādītājs bauda daļējas privilēģijas un imunitātes, kas paredzētas līgumā starp Latvijas Republiku un attiecīgo starptautisko organizāciju’.

- Category D identity card, for career consular officers (with blue marking)

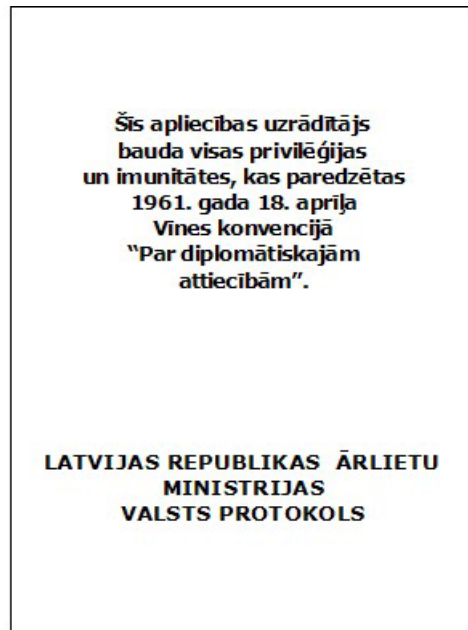
These cards are issued to the career consular officers of a consular mission; on the reverse of the card it is stated that the holder enjoys all the privileges and immunities provided for in the Vienna Convention on Consular Relations : ‘Šīs apliecības uzrādītājs bauda visas privilēģijas un imunitātes, kas paredzētas 1963. gada 24. aprīļa Vīnes konvencijā „Par konsulārajām attiecībām”’.

- Category F identity cards (green in colour) are of two kinds:
  1. Category F identity cards issued to the service staff of a diplomatic mission; on the reverse of the card it is stated that the holder enjoys the partial privileges and immunities envisaged for service staff in Article 37(3) of the Vienna Convention on Diplomatic Relations of 18 April 1961: ‘Šīs apliecības uzrādītājs bauda daļējas privilēģijas un imunitātes, kas paredzētas vēstniecību apkalpojošam personālam saskaņā ar 1961. gada 18. aprīļa Vīnes konvencijas „Par diplomātiskajām attiecībām” 37. panta 3. punktu’.
  2. Category F identity cards issued to the private servants of members of a diplomatic mission; on the reverse of the card it is stated that the holder enjoys the partial privileges and immunities envisaged for service staff in Article 37(4) of the Vienna Convention on Diplomatic Relations of 18 April 1961: ‘Šīs apliecības uzrādītājs bauda daļējas privilēģijas un imunitātes, kas paredzētas vēstniecību apkalpojošam personālam saskaņā ar 1961. gada 18. aprīļa Vīnes konvencijas „Par diplomātiskajām attiecībām” 37. panta 4. punktu’.

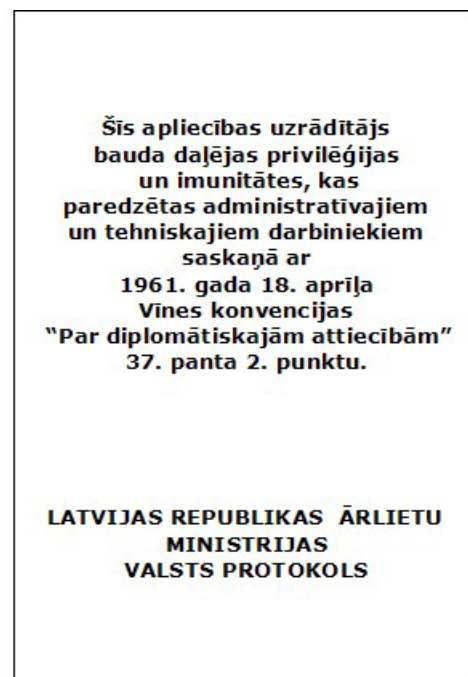

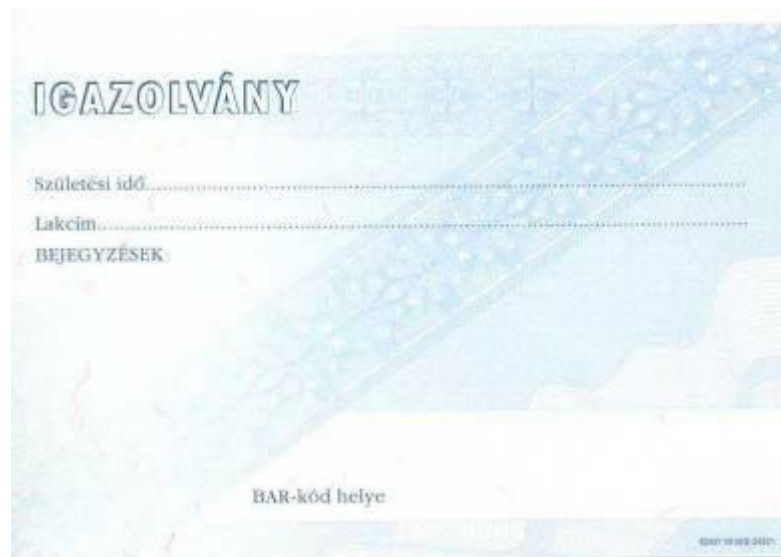


## HUNGARY

The Ministry of Foreign Affairs issues the following ID cards to members of the staff of foreign representations. The coloured stripe at the middle of the ID card indicates the different categories:

- (a) Blue stripe

These ID cards are issued to diplomats and their family members and to officials of international organisations holding diplomatic rank and to their family members



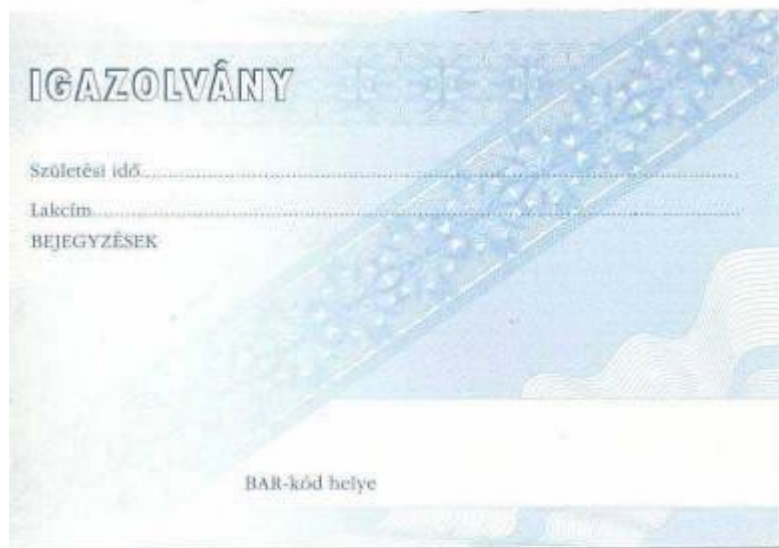
(b) Green stripe

These ID cards are issued to technical and administrative staff of the diplomatic missions and to their family members and to officials of international organisations holding a technical and administrative rank and to their family members



(c) Pink stripe

These ID cards are issued to members of consular representations and to their family members



(d) Yellow stripe

These ID cards are issued to members of the service staff of diplomatic or consular missions or representations of international organisations and to their family members



(e) Light green stripe

These ID cards are issued to members of representations of foreign countries and international organisations and to their family members, certifying limited diplomatic privileges and immunities

## MALTA

The Ministry for Foreign Affairs of the Republic of Malta issues identity cards to staff members at Embassies, High Commissions and International Organisations accredited to the Republic of Malta provided they do not have a residence permit in the Republic of Malta. There are various types of cards (Categories D, C, S and O) with the following data and remarks.

The data on the front side of ID cards is the following:

- Surname
- Designation
- Embassy / High Commission / Organisation
- Address of Embassy/ High Commission / International Organisation
- Signature of the applicant (for applicants who are at least 14 years of age)

O	Burgundy	Diplomatic identity cards issued to the Head of International Organisations approved by the Government of the Republic of Malta. Officers in possession of this type of card are to be working permanently in Malta. They are also issued to their spouses and unmarried children up to 21 years of age still making up their respective households.
O	Blue	Special identity cards issued to officials of International Organisations as approved by the Government of Malta. Officers in possession of this type of card are to be working permanently in Malta. The cards are also issued to their spouses and unmarried children up to 21 years of age still making up their respective households.
S	Orange	Special identity cards issued to members of International Organisations as approved by the Government of the Republic of Malta. Officers in possession of this type of card are to be working permanently in Malta. The cards are also issued to their spouses and their unmarried children up to 21 years of age, still making up their respective households. This card is for identification purposes only.
S	Purple	Special identity cards issued to private domestic staff of staff working at diplomatic missions and International Organisations as approved by the Government of the Republic of Malta.









The Ministry for Foreign Affairs of the Republic of Malta also issues identity cards to Honorary Consuls of the Republic of Malta in foreign countries and Honorary Consuls of foreign countries in the Republic of Malta. An Honorary Consul is granted a Category HC card with the following data and remarks.

The identity cards (Categories D, C, O and S purple coded) are equivalent to a residence permit. They cannot be used as travel documents unless accompanied by a passport. The identity cards (Categories HC and S orange coded) are not equivalent to a residence permit.

When designing the Diplomatic Cards, the Ministry for Foreign Affairs prioritizes the security aspects of the physical card so as to minimise the risk of tampering or forgery. The cards contain an MRZ (Machine Readable Zone) that picks up certain applicant details which are printed on the card. Another security feature is a holographic laminate which covers the front of the card. The Ministry also adds an embossed image (the same one we have on the holographic laminate) which is printed strategically on the picture and the applicant's details. This assures that if someone tries to change a picture or details to forge the card, the embossment would be ruined and the authorities will immediately realise that the card was tampered with.

## NETHERLANDS

### Statuses

Each privileged person is assigned a status indicating to which category of privileged persons he or she belongs. This status is shown on the Privileged Persons document by means of a code.

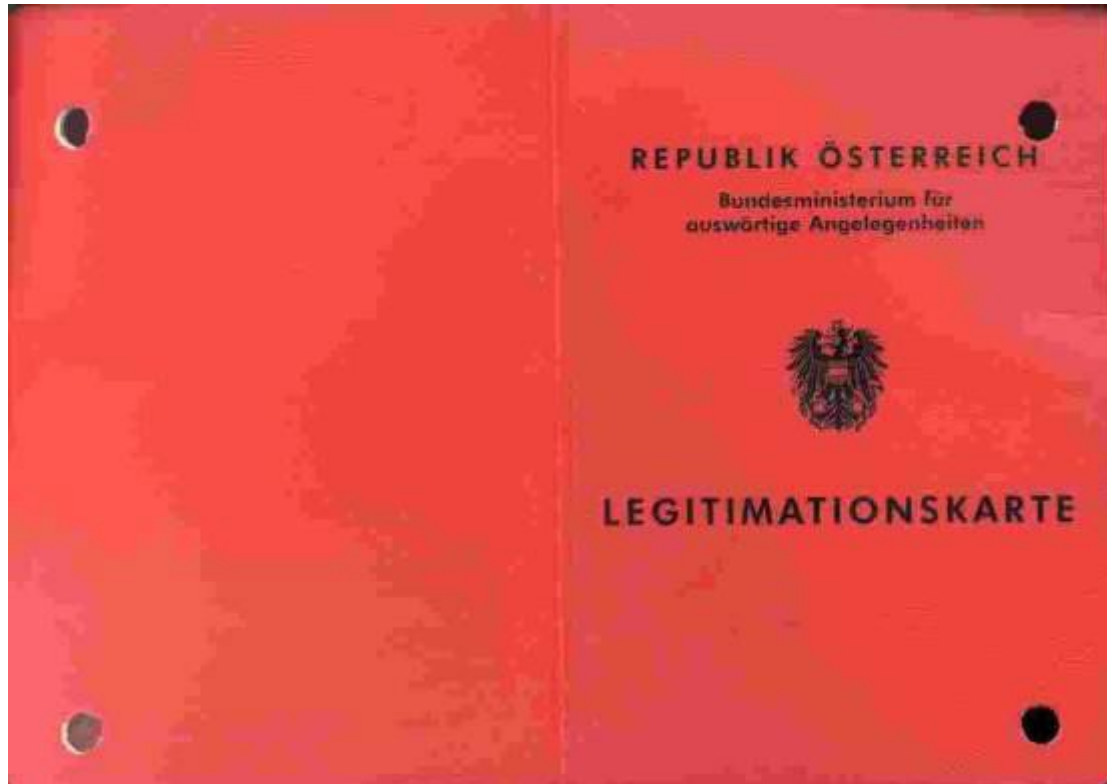

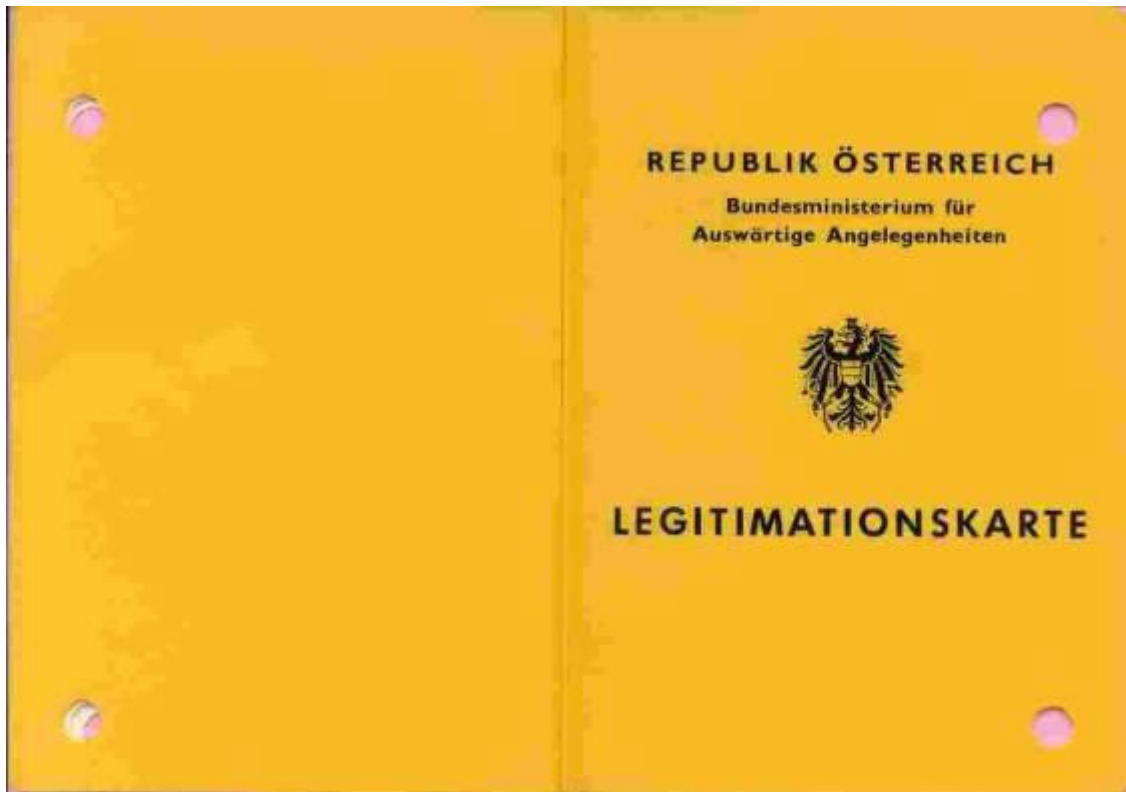

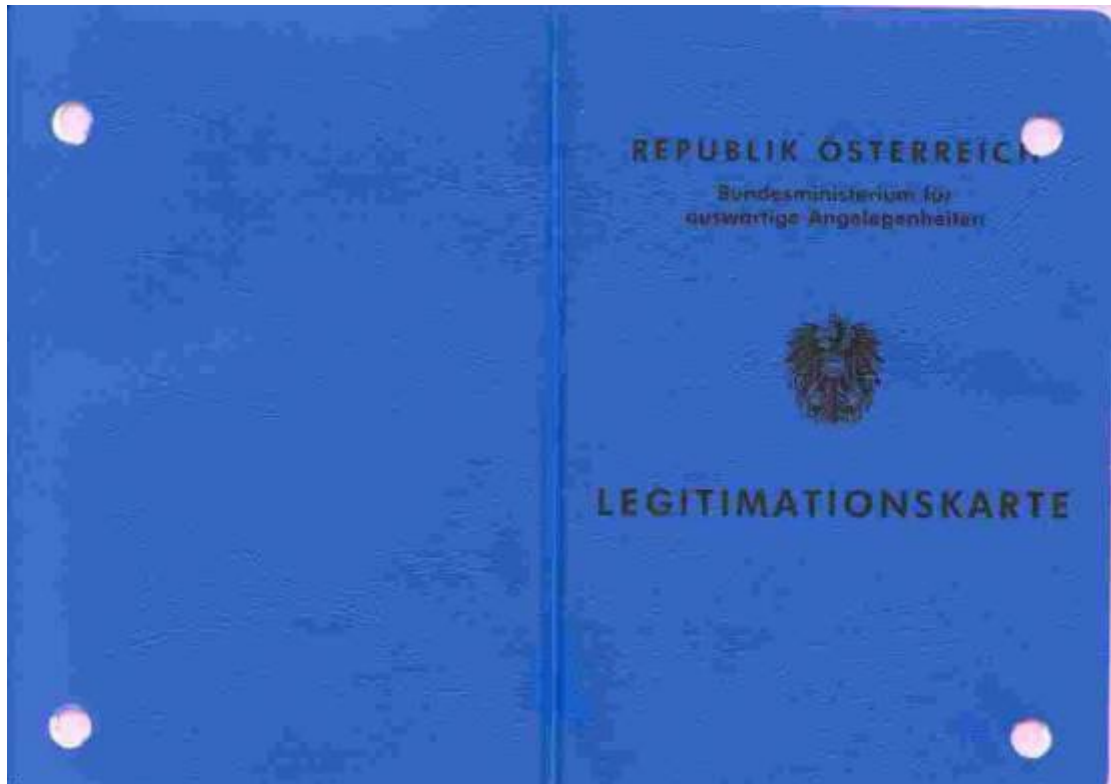
Red ID card for persons who have diplomatic status in Austria and their family members

## ROMANIA

Red CD series diplomatic cards are issued to diplomatic, consular personnel, staff of international organizations and their families, holders of diplomatic passports.

It gives right of residence and diplomatic immunity on the territory of Romania.



Yellow TC series diplomatic cards are issued to technical-administrative personnel and their families, holders of diplomatic and service passports.

It gives right of residence and certain immunities on the territory of Romania.



Blue PS series diplomatic cards are issued to staff of the diplomatic missions or in the particular service of high rank diplomats and to their families.

It gives right of residence on the territory of Romania.



All the above-mentioned cards are issued starting with March 2012. The old version of cards issued starting with 2007 by the Ministry of Foreign Affairs, as described below, remain valid and will cease to be valid at the end of 2014.

## FINLAND

The Ministry for Foreign Affairs issues identity cards to the members of missions, their family members and to private servants for the term of office or residence in Finland. An identity card is not considered to be an official document of identity in Finland. Its purpose is to certify the position and status of the person assigned to serve at a mission and is a residence permit in Finland. The different types of cards are as follows:

- A-card to diplomatic agents;
- B-card to members of the administrative and technical staff;
- C-card to members of the service staff of missions (such as drivers, housekeepers and cooks);
- D-card to private servants of members of missions, and locally engaged drivers of missions.

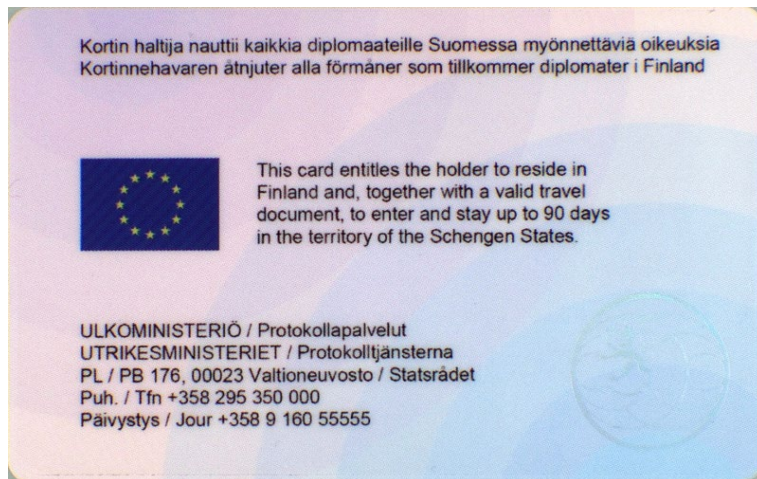

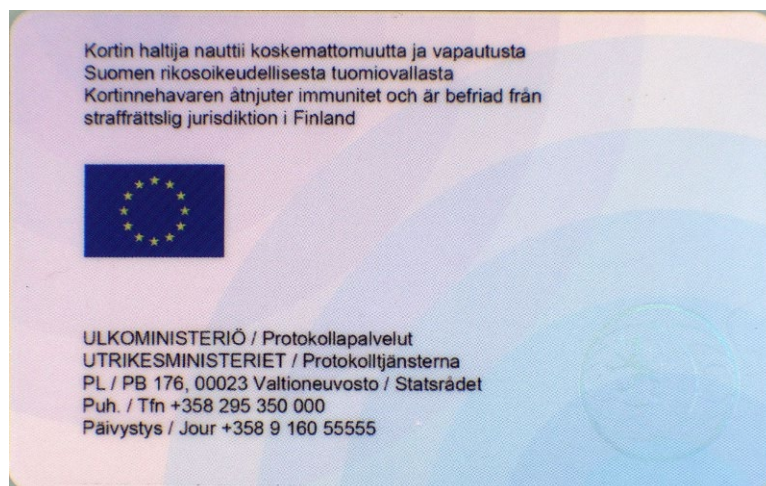

## ICELAND

As of 1 January 2009 the Ministry for Foreign Affairs issues new identity cards for members of the staff of diplomatic missions and career consular posts in Iceland.

### Blue identity card/ Persónuskilríki (see specimen)

This ID card is issued to administrative, technical and service staff of diplomatic missions and career consular posts in Iceland and members of their families forming part of their households.

The ID card is a white laminated plastic card (8.6 cm x 5.4 cm) with blue bands across the top of both sides. On the front, it bears a serial number in the blue band, a photograph of the holder, his/her name, signature and title and the name of the sending State. On the back, in the blue band it is stated that it is a Persónuskilríki (Identity card) issued by the Ministry for Foreign Affairs/Utanríkisráðuneytið. The Seal of the Republic is reproduced on the card. It is signed by the Chief of Protocol and indicates the dates of issuance and expiry. It states in Icelandic that the card must be returned to the Ministry for Foreign Affairs upon the holder's departure from Iceland.

This ID card is issued to Heads of Missions and Consular Posts, members of the diplomatic staff and consular officers and to members of their families forming part of their households.

The ID card is a white laminated plastic card (8.6 cm x 5.4 cm) with red bands across the top of both sides. On the front, it bears a serial number in the red band, a photograph of the holder, his/her name, signature and title and the name of the sending State. On the back, in the red band it is stated that it is a Diplómatískt persónuskilríki (Diplomatic identity card) issued by the Ministry for Foreign Affairs/Utánríkisráðuneytið. The Seal of the Republic is reproduced on the card. It is signed by the Chief of Protocol and indicates the dates of issuance and expiry. It states in Icelandic that the holder enjoys diplomatic privileges and immunities under international law and that it is therefore prohibited to restrict his/her freedom of movement.

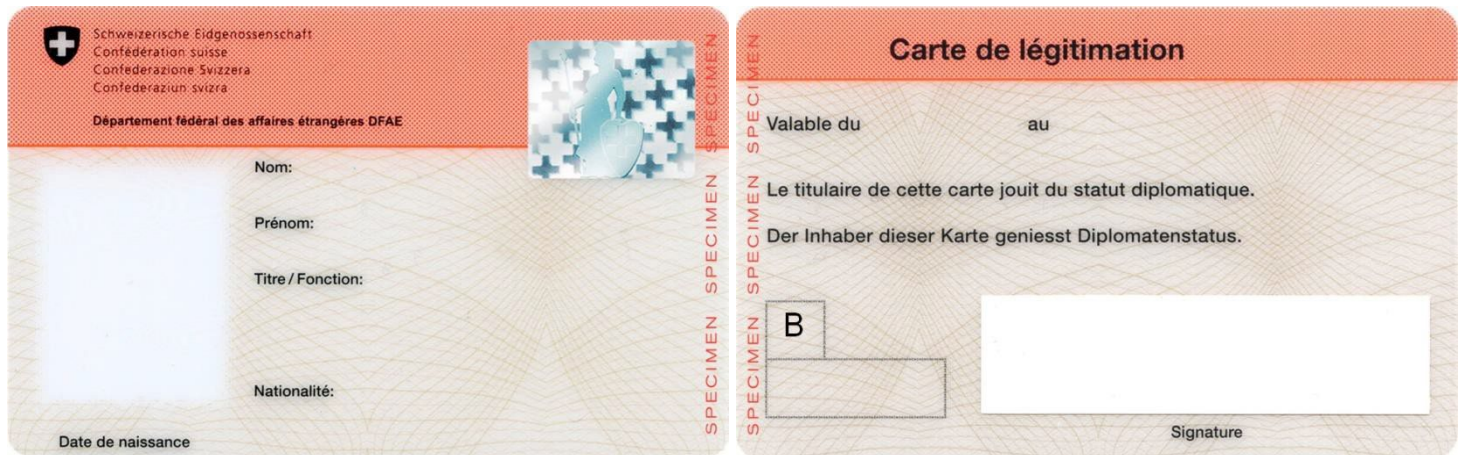

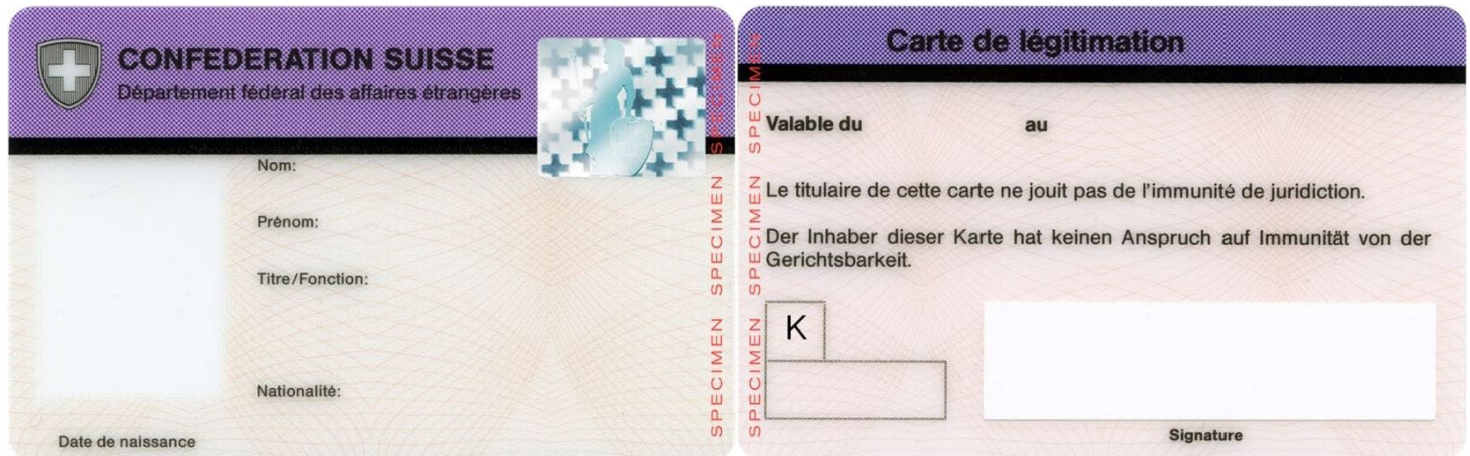

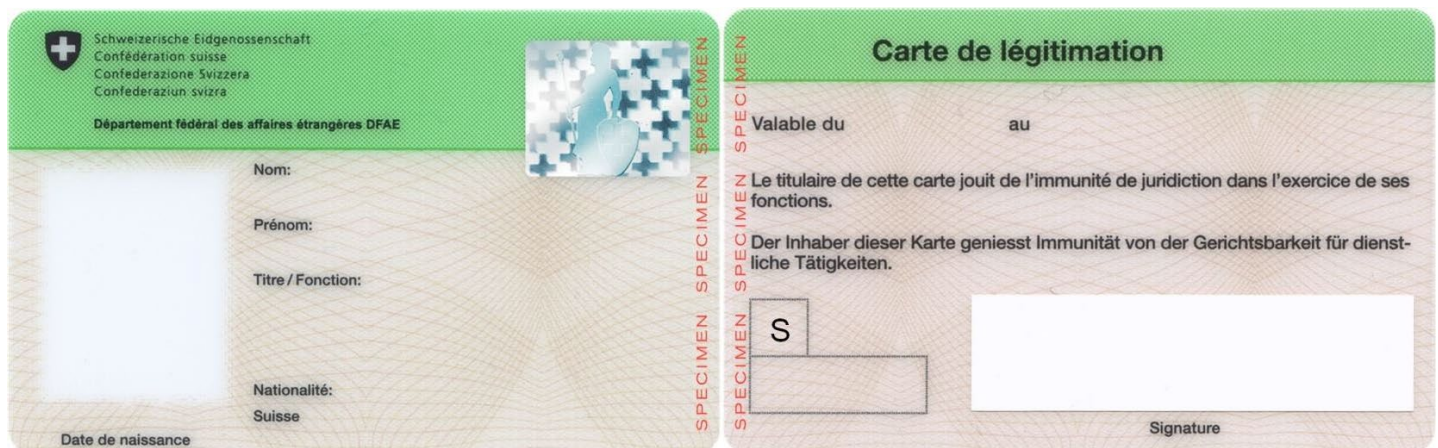

## DFAE IDENTITY CARD TYPE S

In principle, Swiss members of staff receive a type S identity card, irrespective of their role within the foreign representation or international organisation. Swiss staff members recruited locally by embassies and consulates do not receive a card. Temporary Swiss officials (short-term officials) of international organisations do not receive a card.

- **Embassies and consulates: career members of staff with Swiss nationality**
- **Permanent missions: Swiss members of staff**
- **International organisations: Swiss officials/employees**
