### **Board Transitioning to New Database**

The Alabama State Board of Pharmacy will transition to a new database in October of this year. The new system and the renewal process will look different. The system will be more user-friendly,

easier to navigate, and more intuitive. However, the change will require licensees to create a new account to renew licenses, permits, and registrations.

# Pharmacist Renewals

Pharmacist licenses require renewal by December 31, 2024. The online renewal portal will open in October 2024. Pharmacists are required to complete 30 hours of continuing education (CE) each renewal cycle, with six of those hours as live education. The ability to carry over extra hours from a previous renewal cycle is no longer allowable. Please ensure that all required hours are completed no later than December 31, 2024. Monthly Board meetings may be

attended for Alabama CE credit only. Each meeting is worth one live hour. Pharmacists may receive a maximum of three live hours each calendar year for attending a Board meeting.

Attendees of Board meetings, in person or virtually, may receive credit by following the procedures listed below:

 Full name must be displayed on Webex, and you must sign in individually.

# **Reciprocity Update**

During the June Board meeting, the five-member Board made the motion to draft a policy statement clarifying Alabama's reciprocity licensing requirements. The policy statement was presented during the July Board meeting for final approval and included the following:

- a. A pharmacist is eligible to reciprocate to Alabama if he/she has:
  - 1) an active license in any state, and
  - 2) licensure by exam confirmed in any state, regardless of whether that license is active
- b. Once Alabama licensure is obtained via reciprocity, maintaining your home state license is not required.

### USP <800> Compliance

On September 20, 2023, the fivemember Board adopted Policy 23-005, United States Pharmacopeia (USP) <800> Compliance Enforcement. The policy stated USP <800> was enforceable on November 1, 2023. The Board recognized that pharmacies needed time to fully implement the requirements of USP <800> and would allow investigators to use discretionary enforcement during inspections regarding compliance.

# Compounding of Semaglutide

Semaglutide powder is being advertised to physician offices, pharmacies, and the public for purchase from innumerable sources. Much of this semaglutide is **not** prescription quality. The outlets are selling semaglutide salt forms and research grade powder. These salt forms and research grade powders are not approved by Food and Drug Administration (FDA) nor are they evaluated for safety. As such, the only powder that should be used in compounding is the prescription quality powder. Pharmacists are required to purchase and use

only prescription quality active pharmaceutical ingredients when compounding a drug for human consumption. Outlets attempting to sell glucagon-like peptide-1 powder or products to practitioners in Alabama must have the appropriate permit from the Board. At this time, 503B outsourcers may not supply medications to pharmacies for delivery to patients. In June 2023, FDA released draft guidance to remove the prohibition on wholesaling under 503B. However, this is a draft only and specifically states the draft contains

nonbinding recommendations and is not for implementation. Physicians, pharmacists, and the public can validate that a supplier has an active permit with the Board by utilizing the License Verification feature on the Board website, www.albop.com.

#### **DEA Reminder**

Board staff has been aware of a misconception by some pharmacists. When a prescription is written with a "Do Not Fill Before" or a specific "Fill on" this date, you must strictly adhere to the physician's written comment. Some pharmacists were of the understanding that if the date

stated by the physician was on a weekend or when the pharmacy was closed, the pharmacist could fill the prescription early. Drug Enforcement Administration (DEA) has confirmed this is **not** the case. There is no allowance for filling early based on store hours, weekends, or holidays.

The Board has hosted many work groups over the past several months to evaluate the current language in 680-X-2-.14 – The Role of Technicians in Pharmacies. The five-member Board continues to discuss potential changes to this rule at monthly Board meetings. # Immediate Action Required: 680-X-2-.23 Drug Manufacturers; Wholesale Distributors; Private Label Distributors, Repackagers, Third-Party Logistics Providers, Outsourcing Facilities; Reverse Distributors; Retail Medical Oxygen Suppliers

The Board extended a final 45-day grace period for your facility to comply with this rule. Failure to submit the application for registration **before August 2, 2024,** will result in disciplinary action for your facility. Your facility will remain on administrative hold until such time as you are compliant. While on administrative hold, you may not ship or conduct business in or into Alabama.

9)(a)(1): All designated representatives shall register with the Alabama State Board of Pharmacy. The initial registration fee and renewal fee shall be one hundred dollars (\$100). All designated representatives shall pay the renewal fee annually with this fee being due on October 31 and delinquent after December 31 annually. All designated representative registrations shall expire on December 31 annually. If the renewal is not timely received by the board, the applicant shall pay a penalty of fifty dollars (\$50) for each month the renewal is late.
