Update Your Profile

In an effort to communicate more effectively with its licensees and permittees, the Arizona State Board of Pharmacy has noticed that contact information in its system is not always current and up to date. You are required to update your

personal contact information and pharmacy employer within 10 days after a change, pursuant to Arizona Revised Statutes (A.R.S.) §32-1926. Please use your online profile to update your contact information.

Be on Alert - Scam Reported

There have been reports of individuals impersonating Board staff members requesting personal information from license and permit holders. Please know that the Board already has your information, which you are able to update using the

Hot Topics in Arizona Pharmacy

This installment of the Compliance Corner will focus on some recent trending themes. These topics include commonly confused areas of Arizona pharmacy law or information the Board wants to announce. The intention of this article is to provide information and offer some clarification; it should

not be construed as an exhaustive list of the laws governing pharmacy practice in Arizona.

Required Reporting of Charges

A.R.S. 32-3208 (A)(B) states: A health professional who has been charged with a misdemeanor involving conduct that may affect patient safety or a felony after receiving or renewing a license or certificate must notify the health professional's regulatory board in writing within ten working days after the charge is filed.

(B) An applicant for licensure or certification as a health professional who has been charged with a misdemeanor involving conduct that may affect patient safety or a felony after submitting the application must notify the regulatory board in writing within ten working days after the charge is filed.

This means that applicants and licensees who have been arrested or charged with an applicable crime must report it to the Board within 10 days. The common confusion here is that if no charges are filed or the charges are dropped they are not reportable. Reportable arrests or charges include those that are dropped, pending, or any other status. This also includes charges from other jurisdictions; if you are arrested or charged in another state you must report that as well. The Board's Frequently Asked Questions section has more information about reportable

criminal charges and an example listing of the type of offenses that must be reported.

Required Reporting of Change in PIC

A.R.S. 32-1926. Notice of change of information required (B). Pursuant to board rule, a pharmacist designated as the pharmacist in charge for a permit issued under this chapter shall give immediate notice to the board office staff of the initiation and termination of such responsibility. The pharmacist shall either electronically update the pharmacist's online board profile or give written notice to the board office staff of the new information

A change of pharmacist-in-charge (PIC) can be a busy time for any pharmacy. However, there is a requirement to notify the Board of the change. The preferred way to do this is through the Board's website. The **pharmacist's personal profile and pharmacy's facility profile** should be updated to reflect changes in PIC. This update serves as the notification of change in PIC and captures the initiation and termination for the PIC. Other ways to notify the Board are through written (mail, email, or fax) communication. Also, note that a full controlled substance (CS) inventory must be taken within 10 days of changing the PIC.

Compliance Activity

The compliance team is busy throughout the year with inspections, complaint investigations, permit

Licensing Activity

The Board's licensing team is constantly working to improve the turnaround time for license applications. Currently, a complete application will be processed in one to two weeks. The major reason applications take longer to process is due to incomplete information. Applicants should check their application status often to be informed of the status.

Pharmacy CE for Board Meetings

Recently the Board has begun offering CE for attending live Board meetings in person. Up to six

CE credits are available for attending all sessions both days of a meeting. The meeting is divided into two sessions (morning and afternoon) each day with 1.5 hours of CE available for each session. Each session will have a sign-in sheet to be filled out at the start of the session, and the CE certificates will be provided at the end of that session. Participants must arrive at the beginning of the session and stay to the end of the session for the credit to be earned. These CE hours are only accredited in Arizona at this time and will be classified as "General CE"

Scam Alerts - Be on the Lookout

There has been a rise in scams in the Arizona pharmacy industry. Examples of current scams include: Criminals impersonating a Board officer – This scam includes phone calls or emails claiming to represent the Board or other agencies. The scammer will create an urgent

- situation, then ask for money to resolve it.
- 2. Fraudulent Prescriptions –
 Either electronic or otherwise,
 this is a growing trend in
 Arizona. The scammer will
 send a fake prescription,
 usually for CS, in the hopes
 of getting it filled. (See the

 article for more information.)
- 3. Wholesaler Ordering Scams

 Here the scammer will
 gain access to a pharmacy's
 wholesaler account and
 order large quantities and/
 or expensive drugs. When
 the delivery arrives at the
 pharmacy, the scammer calls
 the pharmacy posing as an
 agent for the wholesaler. The
 "agent" claims they made a
 mistake in delivering too much

of the drug and someone will come pick up the incorrectly delivered medication. A scammer presents to the pharmacy claiming to be the agent of the wholesaler and takes the medication.

2024 Legislation Summary

The Arizona Legislature's Regular Session adjourned on June 15, 2024. The next session will open on September 14, 2024. The legislation listed below was passed, including legislation on naloxone dispensations, scope of practice, and narcotics. In May, Governor Hobbs also signed Executive Order 2024-03: Protecting Reproductive Freedom Through Increased Access to Contraception. The Board is aware of and reviewing the Executive Order, and will post more information on its website this summer.

House Bill (HB) 2113	medical assistants; scope of practice	Communicate documented medical advice, interpretation of test results and orders; obtain, process, and communicate medication or procedure prior authorization ordered by a doctor of medicine, physician assistant (PA), or nurse practitioner.
HB 2045	dangerous drugs; definition; xylazine	Adds xylazine to Title 13 (Law Enforcement).
HB 2245	narcotic drugs; fentanyl; sentencing	List consequences for distribution, possession, and transportation of narcotics (first offense and second offense).
HB 2582	pharmacists; collaborative practice agreements	Adds PA to the definition of provider under the section for Collaborative Practice.
Senate Bill (SB) 1021	scope of practice; process; repeal	Removes the requirement for a sunrise to justify a scope enhancement. The group must show education and training as well as improve patient access that maintains or advances health, safety, and welfare for Arizonians.

SB 1165	pharmacy audit; procedures; prohibition	Restricts auditing company from reviewing invoices not related to them. Shall reverse a finding of discrepancy if the correct National Drug Code was used with exception of last two numbers. Also prohibits an auditing entity to retroactively reduce the amount of a claim payment unless they meet certain criteria.
SB 1211	pharmacy; prescribing; naloxone; reporting	Removes requirement to report opioid antagonist to Arizona Controlled Substances Prescription Monitoring Program.
SB 1234	pharmacy board; virtual manufacturers	Removes requirement for contract manufacturing organization (CMO) making devices for virtual manufacturer (VM) to be permitted by the Board. VM prescription drugs can only have CMO permitted by the Board. All drugs and devices follow current Good Manufacturing Practice.
