## Projection Free Online Learning over Smooth Sets

## Abstract

The projection operation is a crucial step in applying Online Gradient Descent (OGD) and its stochastic version SGD. Unfortunately, in some cases, projection is computationally demanding and inhibits us from applying OGD. In this work, we focus on the special case where the constraint set is smooth and we have an access to gradient and value oracles of the constraint function. Under these assumptions we design a new approximate projection operation that necessitates only logarithmically many calls to these oracles. We further show that combining OGD with this new approximate projection, results in a projectionfree variant that recovers the standard rates of the fully projected version. This applies to both convex and strongly-convex online settings.

## 1 Introduction

Over the last decade, the Online Gradient Descent (OGD) method introduced by Zinkevich (2003) and its stochastic version SGD have become the methods of choice both in practical machine learning tasks as well as in theory. Usually, OGD/SGD is constrained to choosing points among a set  $\mathcal{K}$ . This induces simple solutions (e.g., solutions with low norm or low rank), and enables to establish generalization bounds for SGD (Shalev-Shwartz et al., 2009; Cesa-Bianchi et al., 2004). Therefore, in every step, OGD/SGD apply a projection step onto the constraint set  $\mathcal{K}$ . In this paper, we adopt the setup of Mahdavi et al. (2012), and focus on constraints of the following form,

$$\mathcal{K} := \{ x \in \mathbb{R}^d : \ h(x) \le 0 \} \ , \tag{1}$$

where  $h: \mathbb{R}^d \to \mathbb{R}$  is a smooth convex function, and assume that we may query the gradients/values of  $h(\cdot)$ .

The projection operation requires to find a point in  $\mathcal{K}$  which is closest in  $\ell_2$  norm to a given point outside  $\mathcal{K}$ . This translates to a quadratic optimization problem over  $\mathcal{K}$ . Unfortunately, in some situations, this problem is computationally demanding and even impractical. One relevant example is the case when we have a quadratic constraint of the form  $h(x) = x^{\top}Ax - b$ , where  $x \in \mathbb{R}^d$ ,  $A \in \mathbb{R}^{d \times d}$ , and  $b \in \mathbb{R}$  (A is a PSD matrix). A projection in this case requires to factorize the matrix A which necessitates  $O(d^3)$  operations. This cost is unacceptable in large scale scenarios.

There are roughly two approaches to avoid using projections. The first approach is originally related to Frank and Wolfe (1956). Such FW methods assume an access to a linear optimization oracle over  $\mathcal{K}$ . There is a large body of work on how to employ such oracles in order to ensure convergence in the stochastic and online optimization settings (Hazan and Kale, 2012; Garber and Hazan, 2013; Lan and Zhou, 2016). On the downside, a linear oracle is not always easy to compute. Concretely, in the case of quadratic constraints, linear optimization might be as time consuming as full projection. Moreover, the online FW version (Hazan and Kale, 2012) obtains suboptimal regret guarantees compared to projected OGD<sup>1</sup>.

The second approach, which was originally suggested in Mahdavi et al. (2012) is to solve a primal dual problem that is related to the original optimization problem, while applying only a single/few projections. This work assumes that  $\mathcal{K}$  is of the form of Eq. (1)<sup>2</sup>, and requires a single query to the gradients of  $h(\cdot)$  in each round. On the downside, it does not apply to the online learning setting, but rather to the stochastic and offline optimization settings. Moreover, this approach still

requires to compute a single/few projections, which might be prohibitive in large scale problems with, e.g., quadratic constraints.

Contribution: We present a different approach towards projection free online convex optimization problems. We assume a constraint  $\mathcal{K}$  in the form of Eq. (1), and devise a method that recovers the standard regret rates of  $\mathcal{O}(\sqrt{T})$  and  $\mathcal{O}(\log T)$  in the settings of online convex (Zinkevich, 2003) and strongly-convex (Hazan et al., 2007) optimization. Our approach does not require any projections, but rather requires logarithmically many queries to the gradients and values of  $h(\cdot)$  in each round.

Concretely, in the case of stochastic/online optimization with quadratic constraints, i.e.,  $h(x) = x^{\top}Ax - b$ ; our method has a computational cost of  $O(d^2 \log(T)T)$  over all T rounds (related to the cost of computing values and gradients of  $h(\cdot)$ ). Conversely, all other approaches, including full projections, FW (Hazan and Kale, 2012) and (Mahdavi et al., 2012) require  $O(d^3 + d^2T)$  operations, since they need to factorize A

At the heart of our method is a new approximate projection procedure which we call FAstProj. This procedure is an efficient substitute to the full projection, and is guided by a simple geometric intuition. Note that the regret bounds that we recover depend on a curvature parameter, which encapsulates the geometry of  $\mathcal{K}$ . We further comment that our results immediately translate into stochastic optimization guarantees by standard online to batch conversion, (Cesa-Bianchi et al., 2004).

Related work: Kalai and Vempala (2005) were the first to provide a projection free online learning method. Similarly to FW, their algorithm employs a linear optimization oracle which they combine with an appropriate noise perturbation. Nevertheless, their results are restricted to linear loss functions. The general convex case was tackled by Hazan and Kale (2012), which offered an online FW variant, though with suboptimal regret guarantees. Later, for the case of polytope constraints, Garber and Hazan (2013) offered a FW variant that achieves the optimal regret rates.

Lan and Zhou (2016) and Lan et al. (2017) developed a FW method that obtains the optimal rates in the convex and strongly-convex stochastic optimization settings. Their ideas were further developed in Hazan and Luo (2016) who devised a variance reduced FW versions. In the broader context of machine learning and optimization, we have recently witnessed an extensive investigation of FW methods. This was done, e.g., in Jaggi (2013); Lacoste-Julien et al. (2013); Garber and Hazan (2015); Lacoste-Julien and Jaggi (2015);

Garber and Meshi (2016); Garber (2016); Allen-Zhu et al. (2017), among other works.

Mahdavi et al. (2012) discuss the stochastic convex setting and show how to obtain the standard convergence rates using only single/few projections. Conversely to FW methods, Mahdavi et al. (2012) do not assume the availability of a linear optimization oracle. Instead they assume that  $\mathcal{K}$  is given in the form of Eq. (1), and query the gradients of  $h(\cdot)$  in each round. Their technique relies on primal-dual machinery. This idea was later developed by Cotter et al. (2016); Chen et al. (2016); Yang et al. (2017) to tackle the cases of large number of constraints as well as to the offline setting. However, all of these works: (i) require at least one projection, and (ii) are inappropriate to handle the online setting.

Finally, we remark that interior point methods are appropriate to solving constrained convex problems without projecting, (Nesterov and Nemirovskii, 1994). Nevertheless, these methods are too costly in high dimensions. Interestingly, Abernethy et al. (2012) combine interior point mechanism in solving online learning problems.

## 2 Setting and Preliminaries

**Notation:**  $\|\cdot\|$  denotes the  $\ell_2$  norm, and  $[T]:=\{1,\ldots,T\}$ . Given two vectors  $x,y\in\mathbb{R}^d$  then [x,y] denotes the line segment between them. For a set  $\mathcal{K}\subset\mathbb{R}^d$  its diameter is defined as  $D=\sup_{x,y\in\mathcal{K}}\|x-y\|$ . We also denote by  $\partial\mathcal{K}$  and  $\operatorname{int}(\mathcal{K})$  the boundary and interior of  $\mathcal{K}$ .

**Online Learning:** We consider a repeated game of T rounds between a player and an adversary, at each round  $t \in [T]$ ,

- 1. player chooses a point  $x_t \in \mathcal{K}$ .
- 2. adversary chooses a loss function  $f_t : \mathcal{K} \to \mathbb{R}$ .
- 3. player suffers a loss  $f_t(x_t)$  and receives  $f_t(\cdot)$  as a feedback.

In the OCO (Online Convex Optimization) framework we assume that the decision set  $\mathcal{K}$  is convex and that all loss functions are convex. We will also discuss the case where losses are strongly-convex.

We measure the performance of the player using the regret which is the difference between the cumulative loss of the player and the cumulative loss of the best point in hindsight,

Regret<sub>T</sub> := 
$$\sum_{t=1}^{T} f_t(x_t) - \min_{w^* \in \mathcal{K}} \sum_{t=1}^{T} f_t(w^*)$$
.

The player aims at minimizing her regret, and we are interested in players that ensure o(T) regret for any loss sequence that the adversary may choose. In this paper we focus on first order online methods, i.e., methods which only require to query the gradients of the loss functions as a feedback.

**Projected OGD:** The projected OGD algorithm is a well known method in online learning. The update rule of OGD is of the following form,

$$x_{t+1} = \Pi_{\mathcal{K}}(x_t - \eta_t \nabla f_t(x_t))$$

where,

$$\forall z \in \mathbb{R}^d; \ \Pi_{\mathcal{K}}(z) := \underset{y \in \mathcal{K}}{\operatorname{arg \, min}} \|y - z\|.$$

Thus, in each round OGD updates its predictions in the direction opposite to the gradient  $\nabla f_t(x_t)$ , and then projects onto  $\mathcal{K}$ . Later, we will present online methods of the same form which utilize a cheap projection procedure instead of  $\Pi_{\mathcal{K}}(\cdot)$ .

**Smooth sets:** As previously mentioned we focus on convex compact sets of the following form,

$$\mathcal{K} := \{ x \in \mathbb{R}^d : \ h(x) \le 0 \} \ . \tag{2}$$

where  $h: \mathbb{R}^d \to \mathbb{R}$  is a smooth convex function. In case  $\mathcal{K}$  is of the above form and  $h(\cdot)$  is  $\beta_h$ -smooth we will relate to  $\mathcal{K}$  as a  $\beta_h$ -smooth set. Note that whenever we relate to  $\mathcal{K}$  in this paper we assume it has a from as in Eq. (2) (we will not always mention  $h(\cdot)$ , and relate to  $\mathcal{K}$  and  $h(\cdot)$  interchangeably). We assume to have an access for both value and gradient oracles of  $h(\cdot)$ , i.e., we may query the value and gradient of h at any point  $x \in \mathbb{R}^d$ .

Next we define H-strongly-convex and  $\beta$ -smooth functions. A function  $f: \mathcal{K} \mapsto \mathbb{R}$  is H-strongly convex over  $\mathcal{K}$  if  $\forall x, y \in \mathcal{K}$ ,

$$f(y) \ge f(x) + \nabla f(x)^{\top} (y - x) + \frac{H}{2} ||x - y||^2$$
.

A function  $f: \mathcal{K} \mapsto \mathbb{R}$  is  $\beta$  smooth over  $\mathcal{K}$  if  $\forall x, y \in \mathcal{K}$ ,

$$f(y) \le f(x) + \nabla f(x)^{\top} (y - x) + \frac{\beta}{2} ||x - y||^2$$
.

## Preliminaries:

**Definition 2.1.** Given a closed convex set K and  $x \in \partial K$ , n is a normal vector to K in x if,

$$n \cdot (y - x) < 0; \quad \forall y \in \mathcal{K}$$
.

If, in addition, ||n|| = 1 we say that n is a unit normal vector.

The following lemma characterizes the normal vectors of convex sets in the form of Eq. 2,

**Lemma 2.1.** Let K be a convex set (Eq. (2)) and  $x \in \partial K$ , then  $\nabla h(x)$  is a normal vector to K in x.

Given a  $\beta_h$ -smooth convex and compact set  $\mathcal{K} = \{x \in \mathbb{R}^d : h(x) \leq 0\}$ , we shall now define a geometric quantity that measures how "pointy" is  $\mathcal{K}$ ,

**Definition 2.2** (Curvature). Given a  $\beta_h$ -smooth convex and compact set  $\mathcal{K}$  and  $x \in \partial \mathcal{K}$  we define the Local Curvature (LC) of  $\mathcal{K}$  in x as follows,

$$\mu_x := \beta_h / \|\nabla h(x)\| .$$

We also define the Global Curvature (GC) of K as follows,  $\mu := \max_{x \in \partial K} \mu_x$ .

Intuitively, if the gradients on the boundary are very small, then the shape of  $\partial \mathcal{K}$  will be more "pointy" and the curvature  $\mu$  will be larger. Note that the above definition is not necessarily equivalent to the definition of curvature from differential geometry. Interestingly, both definitions coincide in the case where  $\mathcal{K}$  is the  $\ell_2$  ball (i.e.,  $h(x) = ||x||^2 - R^2$ ). In this case,  $\mu = 0.5/R$ , where R is the radius.

In this paper, we assume that  $\mu$  is upper bounded. This assumption is equivalent to the assumptions made by Mahdavi et al. (2012); Chen et al. (2016); Yang et al. (2017). Concretely, in these works it is assumed that  $\min_{x \in \partial \mathcal{K}} \|\nabla h(x)\| \geq B$  which immediately translates to an upper bound on  $\mu$ , i.e.,  $\mu \leq \beta_h/B$ .

## 3 Fast Approximate Projection

Here we introduce our FAstProj (Fast Approximate Projection) procedure. This algorithm requires logarithmically many calls to a value and gradient oracles for  $h(\cdot)$  in order to provide an approximate projection onto  $\mathcal{K}$ .




Figure 1: Approximate Projection.

Algorithm description: Our FAstProj procedure is given in Alg. 1. Let us first describe it using Figure 1. Given  $x \in \mathcal{K}, v \in \mathbb{R}^d$  this procedure finds an approximate projected point,  $\tilde{\Pi}_{\mathcal{K}}(x+v) \in \mathcal{K}$ .

In the case where x+v belongs to  $\mathcal{K}$  our method returns x+v. The interesting case is when  $x+v\notin\mathcal{K}$ . In this case, our method first finds  $\tilde{x}$ , which is a point where the segment (x,x+v] intersects with  $\partial\mathcal{K}$  (see Fig. 1), and we also define  $\tilde{v}:=x+v-\tilde{x}$ . At this point, our method computes the unit normal vector to  $\mathcal{K}$  in  $\tilde{x}$ , n (represented by the orange dashed line)

## **Algorithm 1** Fast Approximate Projection (FAstProj)

Input:  $x \in \mathcal{K}, v \in \mathbb{R}^d$ Output: approximate projection of x+v onto  $\mathcal{K}$ If  $x+v \in \mathcal{K}$ , then output  $\tilde{\Pi}_{\mathcal{K}}(x+v) = x+v$ Else
Find  $\tilde{x} \in (x,x+v] \cap \partial \mathcal{K}$ , and let  $\tilde{v} \leftarrow x+v-\tilde{x}$ (find  $O(\|v\|^2)$ -approximately using bisection)
Calculate  $n = \nabla h(\tilde{x})/\|\nabla h(\tilde{x})\|$ Let  $\hat{v} \leftarrow \tilde{v} - (n \cdot \tilde{v})n$ Compute  $\alpha = \min\{\alpha \geq 0 : \tilde{x} + \hat{v} - \alpha n \in \mathcal{K}\}$ (find  $O(\|v\|^2)$ -approximately using bisection)

and computes  $\hat{v}$  (the dashed blue arrow) which is the projection of  $\tilde{v}$  onto the linear subspace orthogonal to n. Next our method finds the first point where the ray  $\{\tilde{x}+\hat{v}-\alpha n:\alpha\geq 0\}$  intersects with  $\mathcal{K}$  and outputs this point as the approximated projection  $\tilde{\Pi}_{\mathcal{K}}(x+v)$  (the red point in the figure).

Let us provide some intuition behind our method. Recall the full projection operation  $\Pi(x+v)$  will find a point in  $\mathcal{K}$  which is closer to x+v rather than any other point in  $\mathcal{K}$ . Our approximate procedure tries to do so efficiently while suffering an additional approximate term. Concretely, note that since n is the normal vector to  $\mathcal{K}$  in  $\tilde{x}$ , intuitively the point  $\tilde{x}+\hat{v}$  is closer to x+v rather than any other point in  $\mathcal{K}$ , i.e.,

$$||(x+v) - (\tilde{x} + \hat{v})|| < ||(x+v) - y||; \quad \forall y \in \mathcal{K}$$
.

which is exactly what the full projection is trying to obtain. Note however, that the point  $\tilde{x} + \hat{v}$  is not necessarily in K. Fortunately by starting at  $\tilde{x} + \hat{v}$ , we can search in the direction opposite to n and find a point  $\tilde{\Pi}_{\mathcal{K}}(x+v) \in \mathcal{K}$  that is close enough to  $\tilde{x} + \hat{v}$ . By close enough, we mean that for smooth sets the following applies,

$$\|\tilde{\Pi}_{\mathcal{K}}(x+v) - (\tilde{x}+\hat{v})\| < \mu \|v\|^2$$
.

Using the triangle inequality, we conclude that,

$$\|(x+v) - \tilde{\Pi}_{\mathcal{K}}(x+v)\| \le \|(x+v) - y\| + \mu \|v\|^2; \quad \forall y \in \mathcal{K}.$$

So compared to the full projection we suffer an additional additive term of  $\mu ||v||^2$ .

Now, consider a gradient update rule with approximate projection,  $x_{t+1} := \tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t \nabla f(x_t))$ . In this case the additive term is  $\mu \|v\|^2 := \mu \eta_t^2 \|\nabla f(x_t)\|^2$ , and as we show later on, this term still enables to extract the standard regret guarantees in the convex and strongly-convex online settings (while suffering larger constants which depend on the geometry of  $\mathcal{K}$ ).

The next theorem provides us with the formal guarantees of FAstProj (Alg. 1).

**Theorem 3.1.** Let K be a  $\beta_h$ -smooth and convex set with a Global Curvature of  $\mu$ , and diameter D. Then upon invoking FAstProj (Alg. 1) with  $x \in K$  and  $v \in \mathbb{R}^d$  such that  $||v|| \leq 0.5/\mu$  it outputs a point  $\tilde{\Pi}_K(x+v) \in K$ , such that the following holds,

$$\forall y \in \mathcal{K}, \ \|\tilde{\Pi}_{\mathcal{K}}(x+v) - y\| \le \|(x+v) - y\| + \mu \|v\|^2$$
(3)

Algorithm 1 requires  $O(\log(1/\|v\|)) + \log(1+\|v\|)$  calls to a value and gradient oracle for  $h(\cdot)$ .

**Efficient implementation:** Clearly, we can not compute the exact values  $\tilde{x}$  and  $\alpha$ . Instead, we compute these values up to sufficient accuracy. Next we describe how to achieve an accuracy of  $\varepsilon$  with only  $\log(1/\varepsilon)$  calls to gradient and value oracles for  $h(\cdot)$ .

First, let us focus on finding  $\tilde{x}$ , which is equivalent to finding an arbitrary root of the equation h(x) = 0 in the segment (x, x+v]. Since  $h(x) \leq 0$  and h(x+v) > 0, we can use bisection in order to find a point which is  $\varepsilon$  close the exact value of  $\tilde{x}$  using  $O(\log(1/\varepsilon))$  calls to the value of  $h(\cdot)$  (note that even if h(x) = 0 we can still use bisection, we elaborate on this in the full proof of the theorem).

In order to find  $\alpha$ , assume for now that we are given a point  $z \in \mathcal{K} \cap \{\tilde{x} + \hat{v} - \alpha n : \alpha \geq 0\}$ . In this case, clearly  $h(z) \leq 0$  and  $h(\tilde{x} + \hat{v}) > 0$ , and both points  $z, \tilde{x} + \hat{v}$ , are on the ray  $\{\tilde{x} + \hat{v} - \alpha n : \alpha \geq 0\}$ . Therefore, we can again use bisection in order to find a point  $\varepsilon$  close to the optimal  $\alpha$  using  $O(\log(1/\varepsilon))$  calls to the value of  $h(\cdot)$ . The question now is: how to come up with a point  $z \in \mathcal{K} \cap \{\tilde{x} + \hat{v} - \alpha n : \alpha \geq 0\}$ ? In the full proof of the theorem, we show how the problem of finding such z translates to approximately solving a one dimensional convex optimization problem. The latter can be done by convex bisection (Juditsky, 2015), which requires  $O(\log(1 + ||v||))$  calls to a gradient oracle of  $h(\cdot)$ .

Taking an accuracy parameter of  $\varepsilon \leq \mathcal{O}(\|v\|^2)$  is sufficient in order to maintain the guarantees of Theorem 3.1 (although with slightly worse constants).

#### 3.1 Proof of Theorem 3.1

Here we provide a proof sketch of Theorem 3.1. First, let us introduce our main technical lemma.

**Lemma 3.1.** Let K be a  $\beta_h$ -smooth and convex set with a Global Curvature of  $\mu$ , and diameter D. Also let  $x \in \partial K$  and  $n_x := \nabla h(x)/\|\nabla h(x)\|$ , and let  $v \in \mathbb{R}^d$  such that  $v \cdot n_x = 0$ , and  $\|v\| \le 0.5/\mu$ . Then there exists  $0 \le \alpha \le \mu_x \|v\|^2 \le \mu \|v\|^2$  such that  $x + v - \alpha n_x \in K$ . Moreover, for any  $\Delta_\alpha \in [0, \frac{4}{5\mu}]$ , the point  $x + v - (\alpha + \Delta_\alpha)n_x \in K$ .

Proof Sketch of Theorem 3.1. The Theorem is immediate in case that  $x + v \in \mathcal{K}$  since then  $\tilde{\Pi}_{\mathcal{K}}(x + v) = x + v \in \mathcal{K}$ . Next we focus on the case where  $x + v \notin \mathcal{K}$ .

In this case  $\tilde{x} \in \partial \mathcal{K}$  with a normal vector n and  $\hat{v}$  is orthogonal to n (by definition of  $\hat{v}$ ). In addition,  $\|\hat{v}\| \leq \|v\| \leq 0.5/\mu$ , and we can therefore apply Lemma 3.1 (taking  $x \leftrightarrow \tilde{x}$  and  $v \leftrightarrow \hat{v}$ ), implying,

$$\|\tilde{\Pi}_{\mathcal{K}}(x+v) - (\tilde{x}+\hat{v})\| = \alpha \le \mu \|\hat{v}\|^2 \le \mu \|v\|^2 \ . \tag{4}$$

where we have used  $\tilde{\Pi}_{\mathcal{K}}(x+v) := \tilde{x} + \hat{v} - \alpha n_x$  together with  $||n_x|| = 1$ . We also used the definition of  $\alpha$  in Alg. 1, which together with Lemma 3.1 implies that  $\alpha \leq \mu ||\hat{v}||^2$ .

Next notice that  $x+v=\tilde{x}+\tilde{v}$ , and that the dependence of FAstProj (Alg. 1) in  $\tilde{v}$  is only through  $\hat{v}$  (which is the projection of  $\tilde{v}$  onto the linear space orthogonal to n). Thus, the following holds,

$$\tilde{\Pi}_{\mathcal{K}}(x+v) = \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\tilde{v}) = \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v}) . \tag{5}$$

Also, using the definition of  $\tilde{x}, n$ , as well as the the smoothness of K it can be shown that (see Fig. 1),

$$\forall y \in \mathcal{K}, \ \|(\tilde{x} + \hat{v}) - y\| \le \|(\tilde{x} + \tilde{v}) - y\| = \|(x + v) - y\|.$$
(6)

Combining Equations (4), (5), (6), implies that  $\forall y \in \mathcal{K}$ ,

$$\begin{split} \|\tilde{\Pi}_{\mathcal{K}}(x+v) - y\| \\ &= \|\tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v}) - y\| \\ &\leq \|(\tilde{x}+\hat{v}) - y\| + \|(\tilde{x}+\hat{v}) - \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v})\| \\ &\leq \|(x+v) - y\| + \mu \|v\|^2 \ . \end{split}$$

version of the ellipsoid method. The idea is that in the 1 dimensional convex case the sign of the gradient at a point x "tells" us whether the global optimum is larger or smaller than x. Thus, using gradient information we can use bisection in order to approximately find the optimum.

#### 3.1.1 Proof Sketch of Lemma 3.1

Next we provide a proof sketch of Lemma 3.1. To simplify the exposition we will only sketch a part of the proof (see the appendix for the full details).

*Proof Sketch of Lemma 3.1.* Lemma 3.1 is a direct consequence of the following three lemmas.

**Lemma 3.2.** Under the same assumptions of Lemma 3.1. If  $||v|| \le 0.5/\mu$ , and if there exists  $\alpha \ge 0$  such that  $x + v - \alpha n_x \in \partial \mathcal{K}$  then the following holds,

$$\alpha \le \mu_x ||v||^2 \le \mu ||v||^2 \ . \tag{7}$$

where  $\mu_x := \beta_h / \|\nabla h(x)\|$  is the Local Curvature at x (see Def. 2.2).

**Lemma 3.3.** Under the same assumptions of Lemma 3.1. If  $||v|| \le 0.5/\mu$ , then there exists  $\alpha \ge 0$  such that  $x + v - \alpha n_x \in \partial \mathcal{K}$ .

**Lemma 3.4.** Under the same assumptions of Lemma 3.1. If  $||v|| \le 0.5/\mu$ , then there exists  $\alpha \ge 0$  such that  $x + v - (\alpha + \Delta_{\alpha})n_x \in \mathcal{K}$  for any  $\Delta_{\alpha} \in [0, \frac{4}{5\mu}]$ .

In the appendix, we prove Lemma 3.2 and then use it in order to prove Lemma 3.3; both are then used to prove Lemma 3.4.

Next we provide a proof sketch for Lemma 3.2. Concretely, we will show that if there exists  $\alpha \geq 0$  such that  $x + v - \alpha n_x \in \partial \mathcal{K}$  then the following holds,

$$\alpha \le \mu_x ||v||^2 \le \mu ||v||^2$$
 . (8)

Indeed let us denote  $z := x + v - \alpha n_x$  and assume  $z \in \partial \mathcal{K}$ . Using the  $\beta_h$  smoothness of  $h(\cdot)$  yields,

$$0 = h(z) - h(x) \le \nabla h(x) \cdot (z - x) + \frac{\beta_h}{2} ||x - z||^2$$
$$= -\alpha ||\nabla h(x)|| + \frac{\beta_h}{2} (||v||^2 + \alpha^2)$$
(9)

where we use h(x) = h(z) = 0 (since  $x, z \in \partial \mathcal{K}$ ), as well as,  $n_x := \nabla h(x) / \|\nabla h(x)\|$ , and  $v \cdot n_x = v \cdot \nabla h(x) = 0$ .

Now Eq. (9) is a quadratic inequality in  $\alpha$ , and is equivalent to the following,

$$\alpha \le \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 - \sqrt{1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2}} \right)$$
 (10)

Using  $||v|| \le 0.5/\mu$  and recalling the definitions of  $\mu_x$ ,  $\mu$  allows to derive Eq. (8) from Eq. (10).

## 4 Regret Guarantees

Here we establish the guarantees of the online gradient descent (OGD) method when we apply FAstProj rather than the full projection. As we show in Theorems 4.1, and 4.2, this OGD version preserves the well known regret rates of  $\mathcal{O}(\sqrt{T})$  and  $\mathcal{O}(\log T)$  in the convex and strongly-convex settings. Our bounds are worse by a multiplicative factor compared to projected OGD.

#### 4.1 Convergence Guarantees

In this section, we assume the online convex optimization setting (see Section 2), where we receive a a sequence of convex functions loss  $\{f_t : \mathcal{K} \mapsto \mathbb{R}\}_{t \in [T]}$ . We also assume bounded gradients, i.e.,  $\forall t \in [T], x \in \mathcal{K}$ ;  $\|\nabla f_t(x)\| \leq G$ .

Consider the following OGD version combined with FAstProj (Alg. 1) rather than exact projection,

$$\forall t \in [T]; \quad x_{t+1} = \tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t \nabla g_t) . \tag{11}$$

where  $g_t := \nabla f(x_t)$ .

Recall the definition of regret,

$$\operatorname{Regret}_T := \sum_{t=1}^T f_t(x_t) - \min_{x \in \mathcal{K}} \sum_{t=1}^T f_t(x) .$$

The following two theorems establish the regret guarantees of this algorithm in the convex and strongly-convex cases.

**Theorem 4.1.** Assume that K is a  $\beta_h$  smooth convex set with bounded diameter D. Upon invoking the OGD algorithm with FAstProj (Eq. (11)) and taking an arbitrary  $x_1 \in K$ , and  $\eta_t = \frac{D}{G(1+2\mu D)\sqrt{t}}$ , the following holds,

$$Regret_T \le \mathcal{O}\left((1+\mu D)GD\sqrt{T}\right)$$
.

The next theorem asserts the guarantees in case that all loss function  $\{f_t\}_{t\in[T]}$  are H-strongly-convex.

**Theorem 4.2.** Assume that K is a  $\beta_h$  smooth convex set with bounded diameter D. Upon invoking the OGD algorithm with FAstProj (Eq. (11)) and taking an arbitrary  $x_1 \in K$ , and  $\eta_t = (2\mu G + Ht)^{-1}$ , the following holds,

$$Regret_T \le \mathcal{O}\left(\frac{G^2(1+\mu D)}{H}\log T\right) \ .$$

Notice that in both cases our bounds are worse by a multiplicative factor of  $\mathcal{O}(\mu D)$  compared to projected OGD.

**Invariance of**  $\mu D$ : Before we go on to the proofs we show that the  $\mu D$  factor is invariant with respect to a very natural quantity. Concretely, consider convex constraints of the form  $\mathcal{K}_C = \{x \in \mathbb{R}^d : c(x) \leq C\}$  where  $c(\cdot)$  is a homogeneous of degree 2 smooth convex function, and C > 0.

**Proposition 4.1.** As long as  $K_C$  is non-empty then the factor  $\mu D$  of  $K_C$  is invariant w.r.t. C.

By homogeneous of degree 2 we mean that  $\forall \rho \in \mathbb{R}$ ;  $c(\rho x) = \rho^2 c(x)$ . Note that for such functions, it can be shown that  $\nabla c(\rho x) = \rho \nabla c(x)$ . In order to see why the proposition holds, consider  $\mathcal{K}_C$  and  $\mathcal{K}_{\rho C}$  for some  $\rho > 0$ . Due to homogeneity of degree 2, the boundary of  $\mathcal{K}_{\rho C}$  is a  $\sqrt{\rho}$  scaled version of the boundary of  $\mathcal{K}_C$ . Thus, diameter  $(\mathcal{K}_{\rho C}) = \sqrt{\rho} \cdot \text{diameter}(\mathcal{K}_{\rho C})$ , and also,  $\min_{x \in \partial \mathcal{K}_{\rho C}} \|\nabla c(x)\| = \sqrt{\rho} \cdot \min_{x \in \partial \mathcal{K}_C} \|\nabla c(x)\|$ . Since the smoothness of the body  $\mathcal{K}_C$  (equivalently smoothness of c(x) - C) does not change C, this implies that the  $\mu D$  factor for  $\mathcal{K}_C$  and  $\mathcal{K}_{\rho C}$  is the same.

The above assumptions on  $c(\cdot)$  hold for quadratic constraints, i.e.,  $c(x) = x^{\top} A x$ , as well as for squared  $\ell_p$  norms, i.e.,  $c(x) = ||x||_p^2$  with  $p \in (1, \infty)$ .

## 4.2 Applications: Quadratic Constraints

Consider a quadratic constraint:  $h(x) = ||Ax - y||^2 - b$ , where  $x \in \mathbb{R}^d$ ,  $y \in \mathbb{R}^m$ ,  $b \in \mathbb{R}$ , and  $A \in \mathbb{R}^{m \times d}$ . Such constraints are prevalent in optimization and machine learning. Concrete examples include training Kernelized SVMs (where  $h(x) = x^{\top}Kx - b$ , and K is the kernel matrix), and compressive sensing (Candès and Wakin, 2008).

Next, we show that for quadratic constraints, the curvature  $\mu$  is upper bounded and we can therefore apply our approach. Clearly, the smoothness of  $h(\cdot)$  is equal to the largest eigenvalue of  $A^{\top}A$ , i.e.,  $\beta_h = \lambda_{\max}(A^{\top}A)$ . Also, as Yang et al. (2017) shows  $\min_{x:h(x)=0} \|\nabla h(x)\| \geq \sqrt{b\lambda_{\min}(AA^{\top})}$ . This immediately implies that  $\mu = \lambda_{\max}(A^{\top}A)/\sqrt{b\lambda_{\min}(AA^{\top})}$ , and  $\mu D \leq \lambda_{\max}(A^{\top}A)/\sqrt{\lambda_{\min}(AA^{\top})}$ .

#### 4.3 Proof of Theorem 4.1

Proof of Theorem 4.1. First note that due to the choice of learning rate then for any  $t \in [T]$ ,

$$\|\eta_t g_t\| \le \frac{D}{2\mu D} \cdot \frac{\|g_t\|}{G\sqrt{t}} \le 0.5/\mu .$$

The above enables to apply Theorem 3.1 which implies that  $\forall x \in \mathcal{K}$ ,

$$\|\tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t g_t) - x\| \le \|(x_t - \eta_t g_t) - x\| + \mu \eta_t^2 \|g_t\|^2$$

Taking the square of the above we get,

$$\|\tilde{\Pi}_{\mathcal{K}}(x_{t} - \eta_{t}g_{t}) - x\|^{2}$$

$$\leq \|(x_{t} - \eta_{t}g_{t}) - x\|^{2} + \mu^{2}\eta_{t}^{4}\|g_{t}\|^{4}$$

$$+ 2\|(x_{t} - \eta_{t}g_{t}) - x\| \cdot \mu\eta_{t}^{2}\|g_{t}\|^{2}$$

$$\leq \|(x_{t} - \eta_{t}g_{t}) - x\|^{2} + \mu^{2}\eta_{t}^{4}G^{4} + 2(D + \eta_{t}G)\mu\eta_{t}^{2}G^{2}$$

$$\leq \|(x_{t} - \eta_{t}g_{t}) - x\|^{2} + \mu^{2}\eta_{t}^{4}G^{4} + (2\mu D + 1)\eta_{t}^{2}G^{2}$$

$$\leq \|(x_{t} - \eta_{t}g_{t}) - x\|^{2} + \mu^{2}\eta_{t}^{4}G^{4} + (2\mu D + 1)\eta_{t}^{2}G^{2}$$

$$(12)$$

where we used  $||g_t|| \leq G$ ,  $||x_t - x|| \leq D$  and  $\eta_t G \leq 0.5/\mu$ .

We continue similarly to the classical OGD proof. For any  $t \in [T]$  we may use the above to show the following for any  $x \in \mathcal{K}$ ,

$$||x_{t+1} - x||^{2}$$

$$= ||\tilde{\Pi}_{\mathcal{K}}(x_{t} - \eta_{t}g_{t}) - x||^{2}$$

$$\leq ||(x_{t} - \eta_{t}g_{t}) - x||^{2} + \mu^{2}\eta_{t}^{4}G^{4} + (2\mu D + 1)\eta_{t}^{2}G^{2}$$

$$\leq ||x_{t} - x||^{2} - 2\eta_{t}g_{t} \cdot (x_{t} - x) + \eta_{t}^{2}||g_{t}||^{2}$$

$$+ \mu^{2}\eta_{t}^{4}G^{4} + (2\mu D + 1)\eta_{t}^{2}G^{2}$$

Re-arranging the above and using  $||g_t|| \leq G$  we get,

$$g_t \cdot (x_t - x) \leq \frac{1}{2\eta_t} (\|x_t - x\|^2 - \|x_{t+1} - x\|^2) + \frac{1}{2} \mu^2 \eta_t^3 G^4 + \eta_t (\mu D + 1) G^2$$

By convexity  $f_t(x_t) - f_t(x) \leq \nabla f(x_t) \cdot (x_t - x)$ . Using this and summing the above inequality over all rounds we conclude that  $\forall x \in \mathcal{K}$ ,

$$\sum_{t=1}^{T} f_t(x_t) - \sum_{t=1}^{T} f_t(x)$$

$$\leq \sum_{t=1}^{T} \frac{\|x_t - x\|^2}{2} \left(\frac{1}{\eta_t} - \frac{1}{\eta_{t-1}}\right) + G^2(1 + \mu D) \sum_{t=1}^{T} \eta_t$$

$$+ \frac{G^4 \mu^2}{2} \sum_{t=1}^{T} \eta_t^3$$

$$\leq \frac{D^2}{2\eta_T} + G^2(1 + \mu D) \eta_1 \sum_{t=1}^{T} \frac{1}{\sqrt{t}} + \frac{G^4 \mu^2 \eta_1^3}{2} \sum_{t=1}^{T} \frac{1}{t^{3/2}}$$

$$\leq ((1 + \mu D)/2 + 2) GD\sqrt{T} + C.$$

here in the first line we denote  $\eta_0=\infty$ , the second line uses  $\operatorname{diam}(\mathcal{K})=\mathrm{D}$  and  $\eta_t\leq \eta_{t-1}$ . The last line uses  $\sum_{t=1}^T 1/\sqrt{t}\leq 2\sqrt{T},$  and  $\sum_{t=1}^T 1/t^{3/2}\leq 3.$  Also  $C:=\frac{3}{2}G\mu^2D^3/(1+\mu D)^3.$ 

#### 4.4 Proof of Theorem 4.2

*Proof.* First note that due to the choice of learning rate then for any  $t \in [T]$ ,

$$\|\eta_t g_t\| = \frac{\|g_t\|}{2\mu G} \le 0.5/\mu$$
.

The above enables to apply Theorem 3.1 which implies that  $\forall x \in \mathcal{K}$ ,

$$\|\tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t g_t) - x\| \le \|(x_t - \eta_t g_t) - x\| + \mu \eta_t^2 \|g_t\|^2$$

Similarly to the proof of Theorem 4.1, we take the square of the above which gives,

$$\|\tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t g_t) - x\|^2 \le \|(x_t - \eta_t g_t) - x\|^2 + \mu^2 \eta_t^4 G^4 + (2\mu D + 1)\eta_t^2 G^2 .$$
(14)

Using the above it follows that for any  $x \in \mathcal{K}$ ,

$$||x_{t+1} - x||^2 = ||\tilde{\Pi}_{\mathcal{K}}(x_t - \eta_t g_t) - x||^2$$

$$\leq (||x_t - x||^2 - 2\eta_t g_t \cdot (x_t - x) + \eta_t^2 G^2)$$

$$+ \mu^2 \eta_t^4 G^4 + (2\mu D + 1)\eta_t^2 G^2.$$

Re-arranging we get:

$$g_t \cdot (x_t - x) \le \frac{1}{2\eta_t} \left( \|x_t - x\|^2 - \|x_{t+1} - x\|^2 \right)$$
$$+ \eta_t G^2 (1 + \mu D) + \frac{\eta_t^3}{2} \mu^2 G^4$$

Combining the above with the H-strong-convexity of  $f_t$ 's and summing over all rounds we conclude that,

$$\sum_{t=1}^{T} f_t(x_t) - \sum_{t=1}^{T} f_t(x)$$

$$\leq \sum_{t=1}^{T} \frac{\|x_t - x\|^2}{2} \left( \frac{1}{\eta_t} - \frac{1}{\eta_{t-1}} - H \right)$$

$$+ G^2(1 + \mu D) \sum_{t=1}^{T} \eta_t + \mu^2 G^4 \sum_{t=1}^{T} \frac{\eta_t^3}{2}$$

$$\leq \mu D^2 G + \frac{G^2(1 + \mu D)}{H} (1 + \log T) + \frac{2\mu^2 G^4}{H^3}.$$

where we denote  $\eta_0 = \infty$ . The last line uses  $\frac{1}{\eta_t} - \frac{1}{\eta_{t-1}} = H$ ;  $\forall t \geq 2$ , and  $||x_t - x|| \leq D$ , as well as,

$$\sum_{t=1}^{T} \eta_t \le \sum_{t=1}^{T} 1/Ht \le (1 + \log T)/H ,$$

and also.

$$\sum_{t=1}^{T} \eta_t^3 \le \sum_{t=1}^{T} 1/(Ht)^3 \le 2/H^3.$$

#### 4.5 Complexity of FAstProj for OGD

As we discuss in the introduction, FAstProj requires  $O(\log(T))$  calls to a gradient+value oracles for  $h(\cdot)$  in each round of OGD. Here we explain the reason for that.

Theorem 3.1 tells us that FastProj requires  $O(\log(1/\|v\|^2) + \log(1+\|v\|^2))$  calls to a gradient+value oracle at each round. Note that in Theorems 4.1 and 4.2 we take  $v = \eta \nabla f_t(x_t)$ . Since the gradient magnitude is bounded by G, the complexity term  $\log(1 + \|v\|^2)$  is bounded by a constant, i.e.,  $\log(1 + (\eta G)^2)$ . Note however that when  $\|v\|$  is very small then the other term might explode. Fortunately, we can ignore rounds where  $\|\nabla f_t(x_t)\| \leq 1/T$  and still maintain regret guarantees up to an additive constant factor<sup>5</sup>. Meaning we only have to make gradient update and call FastProj procedure when  $\|v\| = \|\eta \nabla f_t(x_t)\| \geq \Omega(\frac{1}{\sqrt{TT}})$ . In this case the first term in complexity,  $\log(1/\|v\|^2)$ , is upper bounded by  $O(\log(T))$ .

## 5 Conclusion

We presented a new approach towards projection-free online learning, which recovers the same rates as the fully projected version. While we have mainly focused on projections for first order online methods, second order online methods, e.g., Online Newton Step (Hazan et al., 2007), require more complex projections, which take a data dependent condition matrix into account. It will be interesting to extend our approach to this case.

## A Proof of Lemma 2.1

*Proof.* By definition for any  $y \in \mathcal{K}$  we have  $h(y) \leq 0$  and for any  $x \in \partial \mathcal{K}$  we have h(x) = 0. Using this in conjunction with the gradient inequality (which holds since  $h(\cdot)$  is convex) we get,

$$0 \ge h(y) - h(x) \ge \nabla h(x) \cdot (y - x), \quad \forall y \in \mathcal{K}, x \in \partial \mathcal{K}$$

Thus, by definition 2.1,  $\nabla h(x)$  is a normal vector to  $\mathcal{K}$  in x.

## B Proof of Lemma 3.1

*Proof of Lemma 3.1.* Recall that according to the proof sketch in Section 3.1.1 Lemma 3.1 is a direct consequence of Lemmas 3.2, 3.3; and 3.4.  $\Box$ 

Next we prove Lemma 3.2 and then use it in order to prove Lemma 3.3; both are then used to prove Lemma 3.4.

#### B.1 Proof of Lemma 3.2

Before we start with the proof we provide the full description of the lemma,

**Lemma** (Lemma 3.2). Let K be a  $\beta_h$ -smooth and convex set with a Global Curvature of  $\mu$ , and diameter D. Also let  $x \in \partial K$  and  $n_x := \nabla h(x)/\|\nabla h(x)\|$ , and let  $v \in \mathbb{R}^d$  such that  $v \cdot n_x = 0$ , and  $\|v\| \le 0.5/\mu$ . Then if there exists  $\alpha \ge 0$  such that  $x + v - \alpha n_x \in \partial K$  then the following holds,

$$\alpha \le \mu_x \|v\|^2 \le \mu \|v\|^2 \ . \tag{15}$$

*Proof.* Let us denote  $z := x + v - \alpha n_x$  and assume  $z \in \partial \mathcal{K}$ . Using the  $\beta_h$  smoothness of  $h(\cdot)$  yields,

$$0 = h(z) - h(x) \le \nabla h(x) \cdot (z - x) + \frac{\beta_h}{2} ||x - z||^2$$

$$= \nabla h(x) \cdot (v - \alpha n_x) + \frac{\beta_h}{2} ||v - \alpha n_x||^2$$

$$= -\alpha ||\nabla h(x)|| + \frac{\beta_h}{2} (||v||^2 + \alpha^2)$$
(16)

where the first line uses h(x) = h(z) = 0 (since  $x, z \in \partial \mathcal{K}$ ), and the last line uses  $n_x := \nabla h(x) / \|\nabla h(x)\|$ , and  $v \cdot n_x = v \cdot \nabla h(x) = 0$ .

Now Eq. (16) is a quadratic inequality in  $\alpha$ , and it can be verified to be equivalent to the following inequalities,

$$\alpha \le \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 - \sqrt{1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2}} \right); \qquad \text{Or} \qquad \alpha \ge \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 + \sqrt{1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2}} \right)$$

Note however that when v = 0 then clearly  $\alpha = 0$  (since then  $z = = x + 0 - 0 \cdot n_x = x \in \partial \mathcal{K}$ ), and the only inequality that agrees with this condition is the first one; thus the following holds,

$$\alpha \le \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 - \sqrt{1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2}} \right)$$
 (17)

Recalling that we assume  $||v|| \leq 0.5/\mu$ , and using the definitions of  $\mu, \mu_x$  we have,

$$||v|| \le 0.5/\mu \le 0.5/\mu_x := 0.5||\nabla h(x)||/\beta_h$$
.

The above implies that  $\frac{\beta_h^2 ||v||^2}{\|\nabla h(x)\|^2} \le 1$ , which together with Eq. (17) gives,

$$\alpha \leq \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 - \sqrt{1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2}} \right) \leq \frac{\|\nabla h(x)\|}{\beta_h} \left( 1 - \left( 1 - \frac{\beta_h^2 \|v\|^2}{\|\nabla h(x)\|^2} \right) \right)$$

$$= \frac{\beta_h}{\|\nabla h(x)\|} \|v\|^2 := \mu_x \|v\|^2 . \tag{18}$$

where the second inequality uses  $\sqrt{1-y} \ge 1-y$  which hold for any  $y \in [0,1]$ . Thus, Eq. (18) establishes Lemma 3.2.

#### B.2 Proof of Lemma 3.3

Before we start with the proof we provide the full description of the lemma,

**Lemma** (Lemma 3.3). Let K be a  $\beta_h$ -smooth and convex set with a Global Curvature of  $\mu$ , and diameter D. Also let  $x \in \partial K$  and  $n_x := \nabla h(x)/\|\nabla h(x)\|$ , and let  $v \in \mathbb{R}^d$  such that  $v \cdot n_x = 0$ , and  $\|v\| \le 0.5/\mu$ . Then there exists  $\alpha \ge 0$  such that  $x + v - \alpha n_x \in \partial K$ .

*Proof.* In order to simplify exposition let us use the following notation,  $u := v/\|v\|$ . Thus u is a unit vector in the same direction of v, and there exists  $\theta \ge 0$  such that  $v = \theta u$ . Thus, proving Lemma 3.3 is equivalent to showing that the following holds:

(\*) Let  $x \in \partial \mathcal{K}$  and  $u \in \mathbb{R}^d$  such that ||u|| = 1 and  $u \cdot n_x = 0$ , then for any  $\theta \leq 0.5/\mu$  there exists  $\alpha > 0$  such that  $x + \theta u - \alpha n_x \in \partial \mathcal{K}$ .

We now split the proof of  $(\star)$  into 3 parts.

**Part 1:** By abusing notation we shall define a function  $\alpha : \mathbb{R}_+ \to \mathbb{R}$  as follows,

$$\forall \theta \ge 0; \qquad \alpha(\theta) = \min\{\alpha \ge 0 : x + \theta u - \alpha n_x \in \mathcal{K}\}\$$

From the above definition, if for a fixed  $\theta \ge 0$  there does not exist any  $\alpha \ge 0$  such that  $x + \theta u - \alpha n_x \in \mathcal{K}$ , then  $\alpha(\theta) = \infty$ . Also lets us define  $\theta_*$  as follows,

$$\theta_* := \max\{\theta \ge 0 : \alpha(\theta) < \infty\}$$
.

Using this notation it can be seen that in order to prove  $(\star)$  it is sufficient to show that the next three conditions hold,

**Existence:** The set  $\{\theta \geq 0 : \alpha(\theta) < \infty\}$  is non-empty, and  $\max\{\theta \geq 0 : \alpha(\theta) < \infty\}$  is well defined and bounded. This in turn implies that  $\theta_*$  always exists and is finite.

**Monotonicity:** If  $0 \le \phi \le \theta_*$  then there exists  $\alpha(\phi) \ge 0$  such that  $x + \phi v - \alpha(\phi) n_x \in \partial \mathcal{K}$ .

Lower bound:  $\theta_* \geq 0.5/\mu$ .

Note that the above Existence, Monotonicity and Lower bound conditions immediately imply  $(\star)$  which in turn establishes Lemma 3.3. In the rest of the proof (**Part 2** and **Part 3**) we focus on proving these conditions.

Part 2, Showing Existence and Monotonicity: We will require the next lemma which charecterizes some properties of  $\alpha(\cdot)$ ,

**Lemma B.1.** The function  $\alpha(\cdot)$  is monotonically non-decreasing. Also,  $\alpha(0) = 0$ ; and for any  $\theta \ge 0$  such that  $\alpha(\theta) < \infty$  then  $\alpha(\theta) \le D$  and also  $\theta \le D$ .

Due to the above lemma,  $\{0\} \subseteq \{\theta \ge 0 : \alpha(\theta) < \infty\}$ , and therefore  $\{\theta \ge 0 : \alpha(\theta) < \infty\}$  is non-empty. Also the monotonicity of  $\alpha(\cdot)$  and boundedness of  $\alpha(\theta)$  and  $\theta$  whenever  $\alpha(\theta) < \infty$  imply that  $\max\{\theta \ge 0 : \alpha(\theta) < \infty\}$  is well defined and is finite. This establishes the **Existence** condition. The **Monotonicity** condition follows directly be the monotonicity of  $\alpha(\cdot)$  combined with the definition of  $\theta_*$ .

Part 3, Showing  $\theta_* \geq 0.5/\mu$ :

Let us denote,  $\alpha_* := \alpha(\theta_*)$ , and also,

$$z_{\theta_*} := x + \theta_* u - \alpha_* n_x$$
.

By definition of  $\theta_*$  and  $\alpha(\cdot)$  it follows that  $z_{\theta_*}$  belongs to  $\partial \mathcal{K}$ . Next we require the following lemma,

**Lemma B.2.** The normal vector to K in  $z_{\theta_x}$  is orthogonal to the normal vector to K in x, i.e.,

$$\nabla h(z_{\theta_{-}}) \cdot \nabla h(x) = 0$$
.

Lemma B.2 implies,

$$\|\nabla h(z_{\theta_*}) - \nabla h(x)\|^2 = \|\nabla h(z_{\theta_*})\|^2 + \|\nabla h(x)\|^2 \ge \|\nabla h(x)\|^2$$
.

Using the above together with the smoothness of h and definition of  $z_{\theta_*}$  we obtain,

$$\|\nabla h(x)\|^{2} \leq \|\nabla h(z_{\theta_{*}}) - \nabla h(x)\|^{2}$$

$$\leq \beta_{h}^{2} \|z_{\theta_{*}} - x\|^{2}$$

$$\leq \beta_{h}^{2} \|\theta_{*}u - \alpha_{*}n_{x}\|^{2}$$

$$= \beta_{h}^{2} (\theta_{*}^{2} + \alpha_{*}^{2})$$
(19)

where we used  $u \cdot n_x = 0$ , and  $||n_x|| = 1$ , ||u|| = 1.

Next we use Eq. (19) in order to prove that  $\theta_* \ge 0.5/\mu$ . This will be done using proof by contradiction. Indeed let us assume by contradiction that  $\theta_* < 0.5/\mu$ , in this case Lemma 3.2 (see Eq. (15)) implies,

$$\alpha_* \le \mu_x \|\theta_* u\|^2 = \mu_x \theta_*^2 .$$

Plugging the above back into Eq. (19) we get a quadratic inequality in  $\theta_*^2$ ,

$$\mu_x^2 \theta_*^4 + \theta_*^2 - \frac{1}{\mu_x^2} \ge 0 \tag{20}$$

where we have used  $\mu_x := \beta_h/\|\nabla h(x)\|$ . It can be validated that Eq. is equivalent to the following inequality for  $\theta_*^{2-6}$ ,

$$\theta_*^2 \ge \frac{\sqrt{5} - 1}{2\mu_x^2}$$

Using  $\mu_x \leq \mu$  the above means,

$$\theta_* > 0.6 \frac{1}{\mu_r} > 0.5 \frac{1}{\mu}$$
.

But the above is in contradiction to the assumption that  $\theta_* < 0.5/\mu$ . Thus, this contradiction assumption is wrong, and the following must hold,

$$\theta_* \geq 0.5/\mu$$
.

The above concludes the proof of the third part. This in turn concludes the proof of the lemma.

#### B.3 Proof of Lemma 3.4

Before we start with the prove we provide the full description of the lemma,

**Lemma** (Lemma 3.4). Let K be a  $\beta_h$ -smooth and convex set with a Global Curvature of  $\mu$ , and diameter D. Also let  $x \in \partial K$  and  $n_x := \nabla h(x)/\|\nabla h(x)\|$ , and let  $v \in \mathbb{R}^d$  such that  $v \cdot n_x = 0$ , and  $\|v\| \le 0.5/\mu$ . Then there exists  $\alpha \ge 0$  such that  $x + v - (\alpha + \Delta_{\alpha})n_x \in K$  for any  $\Delta_{\alpha} \in [0, \frac{4}{5\mu}]$ .

*Proof.* Let us define,

$$\alpha_{\min} := \min\{\alpha \ge 0 : x + v - \alpha n_x \in \mathcal{K}\}; \quad \& \quad \alpha_{\max} := \max\{\alpha \ge 0 : x + v - \alpha n_x \in \mathcal{K}\}.$$

And also,

$$z_{\min} := x + v - \alpha_{\min} n_x;$$
 &  $z_{\max} := x + v - \alpha_{\max} n_x;$ .

By Lemmas 3.2 and 3.3 then  $\alpha_{\min}$  exists and also,  $\alpha_{\min} \leq \mu_x ||v||^2$ . Also, since  $\mathcal{K}$  is convex and has bounded diameter then  $\alpha_{\max}$  exists and for any  $\alpha \in [\alpha_{\min}, \alpha_{\max}]$  the point  $z = x + v - \alpha n_x$  belongs to  $\mathcal{K}$ . Therefore in order to establish this lemma it is sufficient to show that  $\alpha_{\max} - \alpha_{\min} \geq M$ ; which we do next.

<sup>&</sup>lt;sup>6</sup>Note that the inequality related to the other (negative) root of the quadratic equation implies that  $\theta_*^2 < 0$  and is therefore ignored.

Let us first bound the distance between  $\nabla h(x)$  and  $\nabla h(z_{\min})$ . Using the smoothness of  $h(\cdot)$  gives,

$$\|\nabla h(x) - \nabla h(z_{\min})\| \le \beta_h \|x - z_{\min}\| \le \beta_h \sqrt{\|v\|^2 + \alpha_{\min}^2}$$

$$\le \beta_h \sqrt{\|v\|^2 + \mu_x^2 \|v\|^4} \le \beta_h \sqrt{\frac{1}{4\mu_x^2} + \mu_x^2 \frac{1}{16\mu_x^2}}$$

$$\le \frac{3\beta_h}{5\mu_x}$$

$$= \frac{3}{5} \|\nabla h(x)\|.$$

where we have used the definition of  $z_{\min}$  together with  $n_x \cdot \hat{v} = 0$  and  $||n_x|| = 1$ . We also used  $||v|| \le 0.5/\mu \le 0.5/\mu_x$ . The last line uses  $\mu_x := \beta_h/||\nabla h(x)||$ .

Using the above we get,

$$\nabla h(z_{\min}) \cdot n_{x} = \nabla h(x) \cdot n_{x} + (\nabla h(z_{\min}) - \nabla h(x)) \cdot n_{x}$$

$$\geq \|\nabla h(x)\| - \|\nabla h(z_{\min}) - \nabla h(x))\|$$

$$\geq \|\nabla h(x)\| - \frac{3}{5} \|\nabla h(x)\|$$

$$= \frac{2}{5} \|\nabla h(x)\|. \tag{21}$$

We are now ready to bound  $\alpha_{\text{max}} - \alpha_{\text{min}}$ ; clearly,  $h(z_{\text{min}}) = h(z_{\text{max}}) = 0$ , using this together with the smoothness of h gives,

$$0 = h(z_{\text{max}}) - h(z_{\text{min}}) \le \nabla h(z_{\text{min}}) \cdot (\alpha_{\text{min}} - \alpha_{\text{max}}) n_x + \frac{\beta_h}{2} (\alpha_{\text{max}} - \alpha_{\text{min}})^2$$

Using the above together with  $\alpha_{\text{max}} - \alpha_{\text{min}} \geq 0$  and with Eq. (21) implies,

$$\alpha_{\text{max}} - \alpha_{\text{min}} \ge \frac{4}{5} \frac{\|\nabla h(x)\|}{\beta_h} := \frac{4}{5\mu_x} \ge \frac{4}{5\mu} .$$

#### B.4 Proof of Lemma B.1

*Proof of Lemma B.1.* Part 1, Showing monotonicity: Let  $0 \le \phi \le \theta$ , we need to show that  $\alpha(\phi) \le \alpha(\theta)$ .

This part is clear in case  $\alpha(\theta) = \infty$ . Now lets focus on the case where  $\alpha(\theta) < \infty$  which implies the following to hold,

$$z_{\theta} := x + \theta u - \alpha(\theta) n_x \in \mathcal{K}$$

Since  $\mathcal{K}$  is convex and  $x, z_{\theta} \in \mathcal{K}$  then the following point also belongs to  $\mathcal{K}$ ,

$$(1 - \frac{\phi}{\theta})x + \frac{\phi}{\theta}z_{\theta} = (1 - \frac{\phi}{\theta})x + \frac{\phi}{\theta}(x + \theta u - \alpha(\theta)n_{x})$$
$$= x + \phi u - \frac{\phi}{\theta}\alpha(\theta)n_{x} \in \mathcal{K}$$
(22)

where we used  $\phi/\theta \in [0,1]$ . Using the definition of  $\alpha$  together with Eq. (22) implies,

$$\alpha(\phi) := \min\{\alpha > 0 : x + \phi u - \alpha n_x \in \mathcal{K}\} \le \frac{\phi}{\theta}\alpha(\theta) \le \alpha(\theta)$$
.

This concludes this part of the proof.

**Part 2, Showing**  $\alpha(0) = 0$ : This part is immediate, since if  $\theta = 0$  and we take  $\alpha = 0$  then the point  $z := x + \theta u - \alpha(\theta) n_x = x \in \mathcal{K}$  (which holds since  $x \in \mathcal{K}$ ). And thus,

$$0 = \min\{\alpha \ge 0 : x + 0 \cdot u - \alpha n_x \in \mathcal{K}\} .$$

**Part 3, Showing**  $\alpha(\theta) < \infty \Rightarrow \alpha(\theta) < D$ : If  $\alpha(\theta)$  is finite, then the point,  $z := x + \theta u - \alpha(\theta) n_x$  belongs to  $\mathcal{K}$ . Using this together with the fact that  $\mathcal{K}$  has a bounded diameter and  $x \in \mathcal{K}$  implies,

$$D^2 \ge ||z - x||^2 = ||\theta u - \alpha(\theta) n_x||^2 = \theta^2 + \alpha^2(\theta)$$

where we used  $u \cdot n_x = 0$ ,  $n_x = 1$ , and ||u|| = 1. The above immediately implies  $\alpha(\theta) \leq D$  as well as  $\theta \leq D$ . This concludes the third part of the proof.

#### B.5 Proof of Lemma B.2

*Proof of Lemma B.2.* First note that for any  $\alpha < 0$  and  $\theta \in \mathbb{R}$  the following holds,

$$n_x \cdot ((x + \theta u - \alpha n_x) - x) = |\alpha| > 0$$
.

where we used  $n_x \cdot u = 0$ . Combining the above with  $n_x$  being the unit normal vector to  $\mathcal{K}$  in x (see Lemma 2.1) implies that for any  $\alpha < 0$  and  $\theta \in \mathbb{R}$  the following point is outside  $\mathcal{K}$ ,

$$x + \theta u - \alpha n_x \notin \mathcal{K} \tag{23}$$

Also note that by the definition of  $\theta_*$  and  $z_{\theta_*}$  it holds that for any  $\theta' > 0$  and  $\alpha > 0$  the following point does not belong to  $\mathcal{K}$ ,

$$x + (\theta_* + \theta')u - \alpha n_x \notin \mathcal{K} \tag{24}$$

Combining Equations (23) and (24) implies that for any  $\theta' > 0$ , and  $\alpha \neq 0$  the following point does not belong to  $\mathcal{K}$ ,

$$x + (\theta_* + \theta')u - \alpha n_x \notin \mathcal{K} \tag{25}$$

Thus since  $\mathcal{K} := \{x \in \mathbb{R}^d : h(x) \leq 0\}$ , the above implies that the following holds for any  $\theta' > 0$ , and  $\alpha \neq 0$ 

$$h(x + (\theta_* + \theta')u - \alpha n_x) > 0 \tag{26}$$

Combining Eq (26) with the smoothness of  $h(\cdot)$  means that  $\forall \theta' > 0, \alpha \neq 0$ ,

$$0 < h(x + (\theta_* + \theta')u - \alpha n_x)$$

$$\leq h(z_{\theta_*}) + \nabla h(z_{\theta_*}) \cdot ((x + (\theta_* + \theta')u - \alpha n_x) - z_{\theta_*}) + \frac{\beta_h}{2} \|(x + (\theta_* + \theta')u - \alpha n_x) - z_{\theta_*}\|^2$$

$$= 0 + \theta' \nabla h(z_{\theta_*}) \cdot u - (\alpha - \alpha(\theta_*)) \nabla h(z_{\theta_*}) \cdot n_x + \frac{\beta_h}{2} \left( (\theta')^2 + (\alpha - \alpha(\theta_*))^2 \right)$$

where the third line uses  $h(z_{\theta_*}) = 0$  (since  $z_{\theta_*} \in \partial \mathcal{K}$ ), and  $z_{\theta_*} = x + \theta_* u - \alpha(\theta_*) n_x$ , and also  $u \cdot n_x = 0$  as well as  $||n_x|| = ||u|| = 1$ .

Taking the limit of the above inequality when  $\theta' \to 0$  we obtain,

$$\forall \alpha \neq 0, \quad 0 \leq -(\alpha - \alpha(\theta_*)) \nabla h(z_{\theta_*}) \cdot n_x + \frac{\beta_h}{2} (\alpha - \alpha(\theta_*))^2$$

But the above can hold for any  $\alpha \neq 0$  only if,

$$\nabla h(z_{\theta_*}) \cdot n_x = 0 \ .$$

Otherwise we could choose an appropriate  $\alpha$  such that the above inequality does not hold (concretely any  $\alpha - \alpha(\theta_*)$  such that  $\operatorname{sign}(\alpha - \alpha(\theta_*)) = \operatorname{sign}(\nabla h(z_{\theta_*}) \cdot n_x)$  and  $|\alpha - \alpha(\theta_*)| < 2 |\nabla h(z_{\theta_*}) \cdot n_x| / \beta_h$  is appropriate with this respect). Since  $n_x := \nabla h(x) / \|\nabla h(x)\|$  this concludes the proof.

## C Proof of Theorem 3.1

Proof of Theorem 3.1. The Theorem is immediate in case that  $x + v \in \mathcal{K}$  since then  $\tilde{\Pi}_{\mathcal{K}}(x + v) = x + v \in \mathcal{K}$ . The rest of the prove focuses on the case where  $x + v \notin \mathcal{K}$ . Note that in this case  $\tilde{x}$  belongs to  $\partial \mathcal{K}$ .

For the sake of simplicity we will prove the theorem assuming that that we are able to compute the exact values of  $\tilde{x}$  and  $\alpha$ . Later we discuss the extension of the proof for the case where these variables are computed approximately, which can be done efficiently using line search (requires  $O(\log(1/||v||))$  calls to a gradient and value oracles of h).

**Part 1:** Here we show that  $\tilde{\Pi}_{\mathcal{K}}(x+v)$  exists and belongs to  $\mathcal{K}$ .

Since  $x + v = \tilde{x} + \tilde{v}$ , and since the dependence of FAstProj (Alg. 1) in  $\tilde{v}$  is only through  $\hat{v}$  (which is the projection of  $\tilde{v}$  onto the linear space orthogonal to n) then the following holds,

$$\tilde{\Pi}_{\mathcal{K}}(x+v) = \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\tilde{v}) = \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v}) . \tag{27}$$

Also note that,

$$\|\hat{v}\| \le \|\tilde{v}\| \le \|v\| \le 0.5/\mu \ . \tag{28}$$

where the first inequality holds since  $\hat{v}$  is a projection of  $\tilde{v}$  to a linear subspace, the second inequality holds since  $\tilde{x} = (1 - \rho)x + \rho(x + v)$  for some  $\rho \in (0, 1]$  and thus,

$$\tilde{v} = x + v - \tilde{x} = x + v - ((1 - \rho)x + \rho(x + v)) = (1 - \rho)v.$$
(29)

Now recalling that  $\tilde{x} \in \partial \mathcal{K}$  and noting that  $\hat{v} \cdot n = 0$ , and that  $\|\hat{v}\| \leq 0.5/\mu$  (due to Eq. (28)) we may apply Lemma 3.1 (using  $x \leftarrow \tilde{x}, v \leftarrow \hat{v}$ ) which implies there exists  $\alpha_0 \geq 0$  such that,

$$\tilde{x} + \hat{v} - \alpha_0 n \in \partial \mathcal{K}, \quad \text{and} \quad \alpha_0 \le \mu \|\hat{v}\|^2$$
 (30)

Combining the above equation with how  $\tilde{\Pi}_{\mathcal{K}}$  is defined,

$$\tilde{\Pi}_{\mathcal{K}}(x+v) = \tilde{x} + \hat{v} - \alpha n, \quad \text{where } \alpha = \min\{\alpha \ge 0: \ \tilde{x} + \hat{v} - \alpha n \in \mathcal{K}\} \ ;$$

implies that  $\tilde{\Pi}_{\mathcal{K}}(x+v)$  always exists and belong to  $\mathcal{K}$ . Moreover, Eq. (30) implies,

$$\left\| \tilde{\Pi}_{\mathcal{K}}(x+v) - (\tilde{x}+\hat{v}) \right\| = \alpha \le \mu \|\hat{v}\|^2 . \tag{31}$$

Part 2: Here we show the following,

$$\forall y \in \mathcal{K}, \ \|\tilde{\Pi}_{\mathcal{K}}(x+v) - y\| \le \|(x+v) - y\| + \mu \|v\|^2$$
 (32)

We will require the following two lemmas,

**Lemma C.1.** Let K be a  $\beta_h$ -smooth and compact convex set. Assume that  $x \in K$ , and that  $x + v \notin K$  for some  $v \in \mathbb{R}^d$ . Let  $\tilde{x} \in (x, x + v] \cap \partial K$ , and n be the unit normal vector to K in  $\tilde{x}$ , and also let  $\tilde{v} := x + v - \tilde{x}$ ; then the following holds,

$$\tilde{v} \cdot n \geq 0$$
.

**Lemma C.2.** Let  $n, v, z \in \mathbb{R}^d$  such ||n|| = 1, and suppose that  $n^\top v \ge 0$  and  $n^\top z \le 0$ , and define  $\hat{v} = v - (n \cdot v)n$ , then

$$||z - \hat{v}||^2 < ||z - v||^2$$
.

Now since n is the normal to K in  $\tilde{x}$ , the following holds for any  $y \in K$ ,

$$n \cdot (y - x) < 0 \tag{33}$$

Combining Eq. (33) with  $\tilde{v} \cdot n \geq 0$  (see Lemma C.1) and with the definition of  $\hat{v} := \tilde{v} - (n \cdot \tilde{v})n$  enables to apply Lemma C.2 (with  $z \leftarrow y - x$ ,  $v \leftarrow \tilde{v}$ ) and obtain,

$$\forall y \in \mathcal{K}, \ \|(\tilde{x} + \hat{v}) - y\| \le \|(\tilde{x} + \tilde{v}) - y\| = \|(x + v) - y\|$$
(34)

where in the equality we use  $x + v = \tilde{x} + \tilde{v}$ 

Combining Equations (27), (34); and using the triangle inequality gives for all  $y \in \mathcal{K}$ ,

$$\begin{split} \|\tilde{\Pi}_{\mathcal{K}}(x+v) - y\| &= \|\tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v}) - y\| \\ &\leq \|(\tilde{x}+\hat{v}) - y\| + \|(\tilde{x}+\hat{v}) - \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v})\| \\ &\leq \|(x+v) - y\| + \|(\tilde{x}+\hat{v}) - \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v})\| \\ &\leq \|(x+v) - y\| + \mu \|\hat{v}\|^2 \\ &\leq \|(x+v) - y\| + \mu \|v\|^2 \end{split}$$

where the fourth line uses Eq. (31) as well as  $\tilde{\Pi}_{\mathcal{K}}(x+v) = \tilde{\Pi}_{\mathcal{K}}(\tilde{x}+\hat{v})$ , and the last line uses  $\|\hat{v}\| \leq \|v\|$ . The above concludes the second part which in turn concludes the proof.

Extension for the case of approximate estimates: In the proof so far we assume to being able to calculate the exact values of  $\tilde{x}$  and  $\alpha$ . Here we discuss the extension to the case where we compute them approximately. Concretely assume that instead of finding  $\tilde{x}$  such that  $h(\tilde{x}) = 0$  we find an approximation  $\tilde{x}_{\varepsilon}$  such that,

$$-\mathcal{O}(\|v\|^2) \le h(\tilde{x}_{\varepsilon}) \le 0 \tag{35}$$

Note that  $h(\tilde{x}_{\varepsilon}) \leq 0$  and therefore  $\tilde{x}_{\varepsilon} \in \mathcal{K}$ . Also note that in this case  $\nabla h(x_{\varepsilon})$  is an approximate separator for  $\mathcal{K}$ , i.e., for any  $y \in \mathcal{K}$ ,

$$\mathcal{O}(\|v\|^2) \ge h(y) - h(x_{\varepsilon}) \ge \nabla h(x_{\varepsilon}) \cdot (y - x_{\varepsilon}), \qquad \forall y \in \mathcal{K}$$
(36)

Now, given  $\tilde{x}_{\varepsilon}$  and  $\nabla h(x_{\varepsilon})$ , we can find an approximate  $\alpha_{\varepsilon}$  and a respective approximate projection<sup>7</sup>,

$$\tilde{\Pi}_{\mathcal{K}}^{(\varepsilon)}(x+v) := \tilde{x}_{\varepsilon} + \hat{v} - \alpha_{\varepsilon}n \tag{37}$$

Such that,

$$-\mathcal{O}(\|v\|^2) \le h(\tilde{\Pi}_{\mathcal{K}}^{(\varepsilon)}(x+v)) \le 0.$$
(38)

Thus  $\tilde{\Pi}_{\mathcal{K}}^{(\varepsilon)}(x+v)$  is inside  $\mathcal{K}$ , and the normalized gradient at this point is approximately separating  $\mathcal{K}$ .

Following similar lines to the proof that assumes the exact values of  $\tilde{x}$ ,  $\alpha$ , it can be shown that using approximate points as described in Equations (35), (36), (37), translates to the following bound,

$$\|\tilde{\Pi}_{\mathcal{K}}^{\varepsilon}(x+v) - y\| \le \|(x+v) - y\| + 2\mu\|v\|^2, \quad \forall y \in \mathcal{K}, \ \|v\| \le 0.25/\mu.$$

i.e, we suffer and additional  $\mu ||v||^2$  term compared to the case where we can exactly compute  $\tilde{x}, \alpha$ . Also the restriction on the magnitude of ||v|| is tighter by a factor of 2.

**Obtaining approximate estimates:** Here we discuss on how to efficiently find  $\tilde{x}_{\varepsilon}$  and  $\alpha_{\varepsilon}$  as described in the above paragraph.

Finding  $\tilde{x}_{\varepsilon}$ : First consider finding  $\tilde{x}_{\varepsilon}$ , note that by definition  $\tilde{x}$  is a root of h(x) (i.e.  $h(\tilde{x}) = 0$ ) in the segment (x, x + v]. Clearly h(x + v) > 0 and  $h(x) \le 0$  since  $x + v \notin \mathcal{K}$ ,  $x \in \mathcal{K}$ . Now in the case where h(x) < 0 it is clear we can use bisection in order to find  $\tilde{x}_{\varepsilon}$  using  $\mathcal{O}(\log(1/||v||))$  calls to value oracle for  $h(\cdot)$ .

The other case is when h(x) = 0. In this case we can do the following: look at the value of  $h(x + \varepsilon v)$  for a small enough  $\varepsilon \in [0,1]$  such that  $\varepsilon \leq O(\|v\|^2)$ . Now, (i) if  $h(x + \varepsilon v) < 0$  then we can apply bisection to the segment  $[x + \varepsilon v, x + v]$  in order to find  $\tilde{x}_{\varepsilon}$ ; (ii) if  $h(x + \varepsilon v) = 0$  then we take  $\tilde{x}_{\varepsilon} := x + \varepsilon v$ , and (iii) if  $h(x + \varepsilon v) > 0$  we take  $\tilde{x}_{\varepsilon} := x + \varepsilon v$ . For a small enough value of  $\varepsilon$  this procedure finds  $\tilde{x}_{\varepsilon}$  which satisfies Eq. (35).

Finding  $\alpha_{\varepsilon}$ : Note that given a feasible point  $z \in \mathcal{K}$  such that  $z = \tilde{x}_{\varepsilon} + \hat{v} - \alpha' n_x \in \mathcal{K}$  for some  $\alpha' > 0$  we can apply bisection over  $[\tilde{x}_{\varepsilon} + \hat{v}, z]$  in order to find  $\alpha_{\varepsilon}$  that satisfies Eq. (38).

<sup>&</sup>lt;sup>7</sup> where similarly to Alg. 1,  $n := \nabla h(x_{\varepsilon})/\|\nabla h(x_{\varepsilon})\|$ ,  $\tilde{v} = x + v - \tilde{x}_{\varepsilon}$ , and also,  $\hat{v} = \tilde{v} - (\tilde{v} \cdot n)n$ .

The challenge is to find such a feasible point  $z \in \mathcal{K}$  which we discuss next:

First recall that there always exists  $0 \le \alpha_0 \le 2\mu \|v\|^2$  such that  $\tilde{x}_{\varepsilon} + \hat{v} - (\alpha_0 + \Delta_{\alpha})n_x \in \mathcal{K}$  for any  $\Delta_{\alpha} \in [0, \frac{4}{5\mu}]$  (see Theorem 3.1).

Thus inside the line segment,

$$S := \{ \tilde{x}_{\varepsilon} + \hat{v} - \alpha n_x : \alpha \in \left[ 0, 2\mu ||v||^2 + \frac{4}{5\mu} \right] \}.$$

there must exists a subsegment  $P \subseteq S$  of length  $|P| \ge \frac{4}{5\mu}$  which belongs to  $\mathcal{K}$  and therefore  $h(y) \le 0$ ;  $\forall y \in P$ . Now consider the following one dimensional convex problems,

min 
$$m(\alpha) := h(\tilde{x}_{\varepsilon} + \hat{v} - \alpha n_x)$$
  
s.t.  $\alpha \in \left[0, 2\mu \|v\|^2 + \frac{4}{5\mu}\right]$ 

Its solution  $\alpha_*$  necessarily defines a point  $\tilde{x}_{\varepsilon} + \hat{v} - \alpha_* n_x \in \mathcal{K}$  (since  $m(\alpha^*) \leq 0$ ). Now a solution which is  $\varepsilon$ -close to  $\alpha_*$  can be obtained using  $O(\log(|S|/\varepsilon))$  calls to the gradient of  $h(\cdot)$  using one-dimensional convex bisection Juditsky (2015). However since  $|P| \geq \frac{4}{5\mu}$  it is enough to take  $\varepsilon = \frac{2}{5\mu}$  which will give us a point  $\alpha'$  such that,

$$|\alpha' - \alpha_*| \le \frac{2}{5\mu} .$$

Now since  $|P| \ge \frac{4}{5\mu}$  then at least one point  $\alpha$  among the following 3 points  $\{\alpha', \alpha' - \frac{2}{5\mu}, \alpha' + \frac{2}{5\mu}\}$  satisfies the condition,

$$\tilde{x}_{\varepsilon} + \hat{v} - \alpha n_x \in \mathcal{K}$$
.

#### C.1 Proof of Lemma C.1

Let us first recall the lemma,

**Lemma.** Let K be a  $\beta_h$ -smooth and compact convex set. Assume that  $x \in K$ , and that  $x + v \notin K$  for some  $v \in \mathbb{R}^d$ . Let  $\tilde{x} \in (x, x + v] \cap \partial K$ , and n be the unit normal vector to K in  $\tilde{x}$ , and also let  $\tilde{v} := x + v - \tilde{x}$ ; then the following holds,

$$\tilde{v} \cdot n > 0$$
.

We are now ready to provide its proof.

*Proof of Lemma C.1.* We require the following lemma,

**Lemma C.3.** Let  $\mathcal{K} = \{x \in \mathbb{R}^d : h(x) \leq 0\}$ , and assume that  $x \in \mathcal{K}$  and  $x + v \notin \mathcal{K}$  for some  $v \in \mathbb{R}^d$ . Also let  $\tilde{x} \in (x, x + v] \cap \partial \mathcal{K}$  then for any  $\rho' > 0$  the following holds,

$$h(\tilde{x} + \rho' v) \ge 0 \ . \tag{39}$$

Now combining Eq. (39) together with the smoothness of  $h(\cdot)$  we conclude that  $\forall \rho' \in (0, 1 - \rho]$ ,

$$0 \leq h(\tilde{x} + \rho' v)$$

$$\leq h(\tilde{x}) + \rho' \nabla h(\tilde{x}) \cdot v + \frac{\beta_h}{2} (\rho')^2 ||v||^2$$

$$= \rho' \nabla h(\tilde{x}) \cdot v + \frac{\beta_h}{2} (\rho')^2 ||v||^2$$

$$(40)$$

where we used  $h(\tilde{x}) = 0$  which is due to  $\tilde{x} \in \partial \mathcal{K}$ . Note that Eq. (40) can hold for any  $\rho' > 0$  only if

$$\nabla h(\tilde{x}) \cdot v \ge 0 \ . \tag{41}$$

Otherwise, we can always choose a small enough  $\rho'$  that violates Eq. (40). Note that v and  $\tilde{v}$  are the same direction up to scaling (see Eq. (29)) and so are  $\nabla h(\tilde{x})$  and n, thus Eq. (41) implies,

$$n \cdot \tilde{v} \geq 0$$
.

which concludes the proof.

#### C.2 Proof of Lemma C.2

Proof.

$$||y - \hat{x}||^2 = ||y||^2 - 2y \cdot \hat{x} + ||\hat{x}||^2$$

$$= ||y||^2 - 2y \cdot x + 2(n \cdot x)(n \cdot y) + ||\hat{x}||^2$$

$$\leq ||y||^2 - 2y^\top x + ||x||^2$$

$$= ||y - x||^2$$

where we used  $(n \cdot x)(n \cdot y) \le 0$ , and  $\|\hat{x}\|^2 \le \|x\|^2$ .

## C.3 Proof of Lemma C.3

*Proof.* Recall that  $\mathcal{K} = \{y \in \mathbb{R}^d : h(y) \leq 0\}$ , and thus that  $h(x) \leq 0$ , and  $h(\tilde{x}) = 0$  (since  $x \in \partial \mathcal{K}$ ). Now since  $\tilde{x} \in (x, x + v]$  then for any  $\rho' > 0$  we can write,

$$\tilde{x} = (1 - \lambda)x + \lambda(\tilde{x} + \rho'v)$$

for some  $\lambda \in (0,1)$ . Combining the above with the convexity of h we conclude,

$$0 = h(\tilde{x}) \le (1 - \lambda)h(x) + \lambda h(\tilde{x} + \rho' v)$$

Which implies,

$$h(\tilde{x} + \rho' v) \ge -\frac{(1-\lambda)}{\lambda} h(x) \ge 0$$
.

where we have used  $\lambda \in (0,1)$  and  $h(x) \leq 0$ .
