**Google Consent Mode** and **TCF V2.2** are included and activated by default, regardless of your chosen configuration mode. You can disable them in the dedicated section. [Google Additional Consent](#) is automatically enabled when you select an eligible [Ad Technology Partner](#) like Facebook.
