IT is hereby notified that the Minister of Transport and Infrastructural Development has, in terms of section 6 of the Toll Roads Act [Chapter 13:13], made the following regulations:—

- 1. These regulations may be cited as the Toll Roads (National Road Network) (Amendment) Regulations, 2020 (No. 11).
- 2. The Fourth Schedule to the Toll Roads (Regional Trunk Road Network) Regulations, 2009, published in Statutory Instrument 39 of 2009, is repealed and substituted by the following—

- 3. Section 4c (3)(a) of the Toll Roads (National Road Network) (Amendment) Regulations, 2015, is amended by the deletion of paragraph (a) and substituted by the following paragraph—
 - "(a) residents living in areas within a 10km radius from a tollgate situated in their jurisdiction shall be required to pay toll fees as detailed below—
