**CHAPTER 171**  
**SENATE BILL 1071**

AN ACT

AMENDING SECTION 38-1111, ARIZONA REVISED STATUTES; RELATING TO PUBLIC SAFETY OFFICERS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 38-1111, Arizona Revised Statutes, is amended to  
3 read:

4 38-1111. Critical incident stress management team members;  
5 peer support team members; privilege; exceptions;  
6 definitions

7 A. Except as provided in subsection B OF THIS SECTION, a critical  
8 incident stress management team member OR PEER SUPPORT TEAM MEMBER who, in  
9 the course of the member's response to a critical incident at the request  
10 of the member or member's agency, acquires information secretly and in  
11 confidence from a designated person shall not be compelled to disclose  
12 that information in a legal proceeding, trial or investigation before any  
13 agency of this state or a political subdivision of this state.

14 B. Subsection A OF THIS SECTION does not apply if:

15 1. The communication or advice indicates clear and present danger  
16 to the designated person who received crisis response services or to other  
17 persons.

18 2. The designated person who received crisis response services  
19 gives express consent to the testimony.

20 3. The communication or advice is made during the course of a  
21 criminal investigation.

22 4. The designated person who received crisis response services  
23 voluntarily testifies, in which case the critical incident stress  
24 management team member OR PEER SUPPORT TEAM MEMBER may be compelled to  
25 testify on the same subject.

26 5. A breach of ~~department~~ AGENCY policy exists and that breach  
27 amounts to a violation of laws that are normally enforced by law  
28 enforcement.

29 C. For the purposes of this section:

30 1. "AGENCY" MEANS THE BRANCH OF GOVERNMENT, POLITICAL SUBDIVISION  
31 OF THIS STATE OR JOINT POWERS AUTHORITY IN WHICH A DESIGNATED PERSON IS  
32 EMPLOYED.

33 2. "CIVILIAN EMPLOYEE" MEANS A NONSWORN MEMBER OF AN AGENCY OR PEER  
34 SUPPORT TEAM.

35 ~~1.~~ 3. "Crisis response services" means consultation, risk  
36 assessment, referral and ~~onsite~~ ON-SITE crisis intervention services  
37 provided by a critical incident stress management team, PEER SUPPORT TEAM  
38 OR PEER SUPPORT TEAM MEMBER to a designated person.

39 ~~2.~~ 4. "Critical incident stress management team member" means an  
40 individual who has completed training through a recognized organization  
41 that delivers critical incident stress management training and who is part  
42 of a law enforcement, probation, firefighter or emergency medical provider  
43 crisis response team.

1 ~~3. "Department" means the branch of government in which a~~  
2 ~~designated person is employed.~~

3 ~~4.~~ 5. "Designated person" means an emergency medical provider,  
4 firefighter or law enforcement officer OR A CIVILIAN EMPLOYEE OF AN  
5 AGENCY.

6 ~~5.~~ 6. "Emergency medical provider" means municipal, FIRE DISTRICT  
7 or state emergency medical services personnel OR EMERGENCY MEDICAL  
8 SERVICES PERSONNEL UNDER A JOINT POWERS AUTHORITY.

9 ~~6.~~ 7. "Firefighter" means a municipal, FIRE DISTRICT or state  
10 firefighter OR A FIREFIGHTER UNDER A JOINT POWERS AUTHORITY.

11 ~~7.~~ 8. "Law enforcement officer" means:  
12 (a) An individual who is certified by the Arizona peace officer  
13 standards and training board, other than a person employed by a  
14 multi-county water conservation district.

15 (b) A detention officer or correction officer, other than a  
16 probationary employee, who is employed by this state or a political  
17 subdivision of this state.

18 9. "LICENSED MENTAL HEALTH PROFESSIONAL" MEANS A LICENSED  
19 INDIVIDUAL WHO SPECIALIZES IN TRAUMA AND CRISIS, WHO USES EVIDENCE-BASED  
20 TREATMENT OPTIONS AND WHO IS ONE OF THE FOLLOWING:

21 (a) A PSYCHIATRIST WHO IS LICENSED PURSUANT TO TITLE 32, CHAPTER 13  
22 OR 17 OR WHO HOLDS AN EQUIVALENT LICENSE IN ANOTHER STATE.

23 (b) A PSYCHOLOGIST WHO IS LICENSED PURSUANT TO TITLE 32,  
24 CHAPTER 19.1 OR WHO HOLDS AN EQUIVALENT LICENSE IN ANOTHER STATE.

25 (c) A MENTAL HEALTH PROFESSIONAL WHO IS LICENSED PURSUANT TO TITLE  
26 32, CHAPTER 33 OR WHO HOLDS AN EQUIVALENT LICENSE IN ANOTHER STATE AND WHO  
27 HOLDS EITHER A MASTER'S OR DOCTORAL DEGREE RELATED TO THE MENTAL HEALTH  
28 PROFESSION.

29 (d) A MENTAL HEALTH NURSE PRACTITIONER OR A PSYCHIATRIC CLINICAL  
30 NURSE SPECIALIST WHO IS LICENSED PURSUANT TO TITLE 32, CHAPTER 15 OR WHO  
31 HOLDS AN EQUIVALENT LICENSE IN ANOTHER STATE.

32 10. "MEMBER" MEANS A CRITICAL INCIDENT STRESS MANAGEMENT TEAM  
33 MEMBER OR A PEER SUPPORT TEAM MEMBER.

34 11. "PEER SUPPORT TEAM" MEANS A GROUP OF INDIVIDUALS THAT IS  
35 DESIGNATED BY AN AGENCY OR AN AGENCY'S AUTHORIZED AFFILIATE AND THAT IS  
36 TRAINED IN ALL OF THE FOLLOWING AREAS:

- 37 (a) COMPASSION FATIGUE.  
38 (b) CRISIS SUPPORT.  
39 (c) GRIEF AND LOSS RESILIENCY.  
40 (d) MOTIVATIONAL INTERVIEWING.  
41 (e) SUICIDE PREVENTION.

42 12. "PEER SUPPORT TEAM MEMBER" MEANS AN INDIVIDUAL WHO HAS  
43 COMPLETED TRAINING THAT IS PROVIDED BY A LICENSED MENTAL HEALTH  
44 PROFESSIONAL THROUGH A RECOGNIZED ORGANIZATION THAT OFFERS PEER SUPPORT

1 TRAINING OR CRITICAL INCIDENT STRESS MANAGEMENT TRAINING AND WHO IS PART  
2 OF ANY OF THE FOLLOWING:

- 3 (a) A LAW ENFORCEMENT CRISIS RESPONSE TEAM.
- 4 (b) A PROBATION OFFICER CRISIS RESPONSE TEAM.
- 5 (c) A FIREFIGHTER CRISIS RESPONSE TEAM.
- 6 (d) AN EMERGENCY MEDICAL PROVIDER CRISIS RESPONSE TEAM.
