CHAPTER 198
SENATE BILL 1335

AN ACT

AMENDING SECTIONS 9-403 AND 28-8414, ARIZONA REVISED STATUTES; RELATING TO
MUNICIPAL REAL PROPERTY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 9-403, Arizona Revised Statutes, is amended to
3 read:

4 9-403. Sale of real property; public hearing; resolution;
5 posting of terms of sale; special election; sale at
6 auction

7 A. REAL PROPERTY OF A CITY OR TOWN, THE VALUE OF WHICH IS MORE THAN
8 \$1,500,000 BUT LESS THAN \$15,000,000, MAY NOT BE SOLD UNLESS THE GOVERNING
9 BODY OF THE CITY OR TOWN DOES BOTH OF THE FOLLOWING:

10 1. HOLDS AT LEAST ONE PUBLIC HEARING TO TAKE PUBLIC COMMENT ON THE
11 PROPOSED SALE AFTER PUBLISHING THE INVITATION FOR BIDS AS PRESCRIBED IN
12 SECTION 9-402 AT LEAST THIRTY DAYS BEFORE THE SCHEDULED APPROVAL OF THE
13 PURCHASE AGREEMENT. NOTICE OF THE HEARING SHALL BE PROVIDED AT LEAST TEN
14 DAYS BEFORE THE HEARING AND SHALL INCLUDE BOTH OF THE FOLLOWING:

15 (a) A DESCRIPTION OF THE PROPERTY PROPOSED FOR SALE AND THE REASONS
16 FOR THE PROPOSED SALE.

17 (b) INFORMATION ON HOW TO SUBMIT TO THE GOVERNING BODY WRITTEN AND
18 VERBAL COMMENTS ON THE PROPOSED SALE.

19 2. BY A VOTE OF THE MEMBERS OF THE GOVERNING BODY, ADOPTS A
20 RESOLUTION APPROVING THE SALE OF THE PROPERTY.

21 B. IF A CITY OR TOWN SELLS REAL PROPERTY PURSUANT TO SUBSECTION A
22 OF THIS SECTION, THE TERMS OF THE SALE SHALL BE POSTED ON THE CITY'S OR
23 TOWN'S WEBSITE ON COMPLETION OF THE SALE.

24 ~~A.~~ C. Real property of a city or town, the value of which ~~exceeds~~
25 ~~one million five hundred thousand dollars~~ IS \$15,000,000 OR MORE, shall
26 not be sold unless first authorized by a special election called for the
27 purpose of submitting to the voters of the city or town the question of
28 selling or not selling the real property proposed for sale. The election
29 shall be held within the corporate limits of the city or town on a date
30 prescribed by section 16-204, and notice shall be given as provided in
31 section 9-402.

32 ~~B.~~ D. The ballots shall contain a description of the property
33 proposed for sale and the reason ~~why~~ the governing body desires the
34 property sold. The description and reasons shall be printed in
35 eight-point type and shall contain not more than one hundred words.

36 ~~C.~~ E. If a majority of the ballots cast is in favor of selling,
37 ~~then~~ the governing body may sell the property at public auction, after
38 giving the notice required in section 9-402, to the highest bidder for
39 cash, reserving the right to reject any and all bids.

40 F. REAL PROPERTY SOLD PURSUANT TO THIS SECTION SHALL BE SOLD AT NOT
41 LESS THAN THE APPRAISED VALUE OF THE PROPERTY.

1 Sec. 2. Section 28-8414, Arizona Revised Statutes, is amended to
2 read:

3 28-8414. City and town airport disposal

4 By resolution, the governing body of a city or town:

5 1. May sell, lease and dispose of an airport acquired under this
6 article.

7 2. If an airport acquired under this article is sold, leased or
8 disposed of to the county in which the airport is located, to ~~the~~ THIS
9 state or to the United States or any of its agencies, may sell, lease or
10 dispose of the airport for a nominal consideration without advertising and
11 without ~~holding a special election as~~ FOLLOWING THE PROCEDURES prescribed
12 by sections 9-402 and 9-403.
