**CHAPTER 217**  
**HOUSE BILL 2905**

AN ACT

AMENDING LAWS 2023, CHAPTER 141, SECTIONS 1 AND 3; RELATING TO HUMAN SERVICES.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Laws 2023, chapter 141, section 1 is amended to read:  
3 Section 1. Extended foster care comprehensive service model  
4 fund; extended foster care success coaching  
5 program; quality review committee; reporting  
6 requirements; rules; delayed repeal; transfer of  
7 monies; definitions

8 A. The extended foster care comprehensive service model fund is  
9 established consisting of legislative appropriations. The department  
10 shall administer the fund. Monies in the fund are continuously  
11 appropriated and are exempt from the provisions of section 35-190, Arizona  
12 Revised Statutes, relating to lapsing of appropriations. ~~In fiscal year~~  
13 ~~2023-2024~~. The department shall use monies in the fund for the purposes  
14 prescribed in this section.

15 B. Within ten days after ~~the effective date of this act, for fiscal~~  
16 ~~year 2023-2024~~ **OCTOBER 30, 2023**, the department shall prepare a scope of  
17 work for an extended foster care comprehensive service model that includes  
18 supportive services and required case management provided by contracted  
19 community providers for young adults who participate in the extended  
20 foster care program. The extended foster care comprehensive service model  
21 scope of work shall include:

- 22 1. Weekly engagement with each young adult.
- 23 2. Life skills training.
- 24 3. Mental and physical health and well-being.
- 25 4. Relational permanency.
- 26 5. Education and enrollment assistance.
- 27 6. Assistance with accessing safe housing attainment and stability  
28 for young adults.
- 29 7. Career and employment planning and readiness.
- 30 8. Assistance with accessing transportation services for young  
31 adults.

32 C. The extended foster care comprehensive service model shall  
33 include extended foster care success coaches for young adults in the  
34 extended foster care program. Each extended foster care success coach  
35 shall have a caseload of not more than twenty young adults. The extended  
36 foster care success coaching program shall be based on a practice that is  
37 youth driven and shall do the following:

- 38 1. Promote permanent connections.
- 39 2. Support the development of an educational foundation and skill  
40 set that enables young adults to gain and maintain employment to support  
41 their financial needs.
- 42 3. Ensure that young adults reside in safe, stable and secure  
43 housing.
- 44 4. Link young adults to appropriate services that address physical  
45 and behavioral health needs.
- 46 5. Build skills for developing personal agency.

1           6. Ensure that young adults have the cognitive skills essential to  
2 survival.

3           D. The department shall supervise and monitor the success of the  
4 extended foster care success coaching program.

5           E. Each extended foster care success coach shall:

6           1. Successfully complete a department-administered foster care  
7 success coach training program.

8           2. Possess a bachelor's or associate's degree or have equivalent  
9 credits equal to an associate's degree. The degree or credits shall be in  
10 the fields of social work, psychology, counseling, marriage and family  
11 therapy, behavioral health or education. In lieu of a degree or credits,  
12 an extended foster care success coach may possess skills that the coach  
13 acquired through alternative routes such as relevant job training,  
14 community college attendance, military service or an apprenticeship.

15           3. Be at least twenty-six years of age.

16           4. Have experience working with youth or young adults who are  
17 fourteen through twenty-six years of age and who are involved in systems  
18 of care, which may include:

19           (a) Foster care.

20           (b) Juvenile justice.

21           (c) Runaway and homeless youth programs.

22           5. Exhibit the belief that all young adults have the capacity to be  
23 successful in life.

24           F. The extended foster care success coaching program shall:

25           1. Operate from an evidence-based framework.

26           2. Ensure that the young adults served are aware of their rights to  
27 normalcy.

28           3. Assist young adults to advocate with caregivers to experience  
29 activities and opportunities that meet individual interests.

30           4. Support caregivers in identifying root causes of behaviors that  
31 present barriers to transition and provide opportunities that assist young  
32 adults in healing and addressing underlying trauma.

33           5. Develop feedback that allows young adults to communicate their  
34 needs and satisfaction with provided services and that allows a young  
35 adult to request a different extended foster care success coach.

36           6. Deliver interventions that are tailored to each young adult's  
37 strengths and experiences.

38           7. Contract with a public university to evaluate the effectiveness  
39 of the vendor's delivery of the extended foster care success coaching  
40 program.

41           G. The department shall solicit agencies to administer the extended  
42 foster care comprehensive service model within thirty days after ~~the~~  
43 ~~effective date of this act~~ **OCTOBER 30, 2023** and select an agency or  
44 agencies within ninety days after ~~the effective date of this act~~ **OCTOBER**  
45 **30, 2023**. The department shall implement the extended foster care

1 comprehensive service model within one hundred fifty days after ~~the~~  
2 ~~effective date of this act~~ OCTOBER 30, 2023.

3 H. The department shall adopt rules to implement this act.

4 I. The department shall establish an extended foster care quality  
5 review committee within the department. Members of the committee consist  
6 of department staff members. The committee shall confirm that a young  
7 adult who participates in extended foster care meets all of the following:

8 1. Eligibility criteria.

9 2. Has connections to a permanent family and supportive adults who  
10 are actively involved in the young adult's life.

11 3. Has a person-centered case and transition plan that supports the  
12 young adult's identified goals and future planning.

13 4. Is acquiring individualized skills to develop the tools that are  
14 needed to thrive outside of the foster care program.

15 J. Within one hundred fifty days after ~~the effective date of this~~  
16 ~~act~~ OCTOBER 30, 2023, the department shall submit to the joint legislative  
17 budget committee, the senate health and human services committee and the  
18 house of representatives health and human services committee a report on  
19 the extended foster care comprehensive service model developed pursuant to  
20 subsection B of this section. The report shall include data and  
21 statistics on:

22 1. The support and services to be offered by the extended foster  
23 care comprehensive service model.

24 2. The extended foster care program's eligibility requirements.

25 3. The young adult's program responsibilities.

26 4. Case and transition planning opportunities.

27 5. Health insurance coverage for young adults in the extended  
28 foster care program.

29 6. Educational opportunities for young adults in the extended  
30 foster care program.

31 7. Opportunities for mentors through the extended foster care  
32 program.

33 8. Transportation services for young adults in the extended foster  
34 care program, including obtaining a driver license.

35 9. Housing, including semi-supervised living arrangements if such  
36 arrangements best meet the young adult's needs.

37 K. The department shall provide to the joint legislative budget  
38 committee a quarterly report that includes all of the following:

39 1. The number of young adults served in the extended foster care  
40 comprehensive service model.

41 2. The young adult's participation in regular reviews with extended  
42 foster care staff.

43 3. Other performance measures as updated by the extended foster  
44 care quality review committee established pursuant to subsection I of this  
45 section and as determined by the chairperson of the joint legislative  
46 budget committee.

1 L. FROM AND AFTER JUNE 30, 2025, THIS SECTION IS REPEALED AND ANY  
2 UNEXPENDED AND UNENCUMBERED MONIES REMAINING IN THE EXTENDED FOSTER CARE  
3 COMPREHENSIVE SERVICE MODEL FUND ARE TRANSFERRED TO THE STATE GENERAL  
4 FUND.

5 ~~L.~~ M. For the purposes of this section:

6 1. "Department" means the department of child safety.

7 2. "Young adult" means a person who is at least seventeen and  
8 one-half years of age and under twenty-one years of age and who  
9 participates or will participate in the extended foster care program  
10 established pursuant to section 8-521.02, Arizona Revised Statutes.

11 Sec. 2. Laws 2023, chapter 141, section 3 is amended to read:

12 Sec. 3. Homeless shelter and services fund; annual report;  
13 delayed repeal; transfer of monies

14 A. The homeless shelter and services fund is established consisting  
15 of legislative appropriations, other monies directed to be deposited in  
16 the fund and investment earnings on monies in the fund. The Arizona  
17 department of housing shall administer the fund. Monies in the fund are  
18 continuously appropriated.

19 B. ~~In fiscal years 2023-2024, 2024-2025, 2025-2026 and 2026-2027,~~  
20 The Arizona department of housing shall use monies in the fund for the  
21 purposes prescribed in this section. Monies in the fund shall be used to  
22 award grants pursuant to title 41, chapter 23, Arizona Revised Statutes,  
23 to counties, cities, towns, Indian tribes and nonprofit organizations for  
24 programs that provide shelter and services to unsheltered persons who are  
25 experiencing homelessness.

26 C. Monies in the fund are exempt from the provisions of section  
27 35-190, Arizona Revised Statutes, relating to lapsing of appropriations.

28 D. On or before December 31, ~~of each fiscal year~~ 2024, the Arizona  
29 department of housing shall submit a report to the governor, the president  
30 of the senate and the speaker of the house of representatives describing  
31 all grants awarded in that year.

32 E. ~~This section is repealed~~ From and after ~~September 30, 2027~~ JUNE  
33 30, 2025, THIS SECTION IS REPEALED AND ANY UNEXPENDED AND UNENCUMBERED  
34 MONIES REMAINING IN THE HOMELESS SHELTER AND SERVICES FUND ESTABLISHED BY  
35 THIS SECTION ARE TRANSFERRED TO THE STATE GENERAL FUND.

36 Sec. 3. Department of economic security; drug testing; TANF  
37 cash benefits recipients

38 During fiscal year 2024-2025, the department of economic security  
39 shall screen and test each adult recipient who is otherwise eligible for  
40 temporary assistance for needy families cash benefits and who the  
41 department has reasonable cause to believe engages in the illegal use of  
42 controlled substances. Any recipient who tests positive for the use of a  
43 controlled substance that was not prescribed for the recipient by a  
44 licensed health care provider is ineligible to receive benefits for a  
45 period of one year.
