1.1 Release Notes for LGY Suite - LGY 22.7.0

Focus of Release: The areas of focus for the 22.7.0 release include automating the Surviving Spouse Certificate of Eligibility determination and end-to-end workflow, adding "Non-Exempt" as a new Funding Fee Exemption status, automating VSC letters and ensuring the correct claim type is incorporated, and enabling sorting and pagination on Document History for MU associates. Additionally, this release prepopulated "Space Force" as a new Branch of Service and enables users to select it as a new option. This release also concludes VA.gov defect remediation and addresses security issues. This release provides value to the Veteran by increasing the efficiency of lenders through the enhancements allowing for a better experience for the Veteran.

1.1 Enhancements

Key	Component	Summary
LGY-1312419	COE	This enhancement added automation functionality for a surviving spouse eligibility determination.
LGY-1312579	COE	This enhancement established an integration with BGS to bring data currently viewable in SHARE into LGY. The qualifying DIC data will be used to automate Surviving Spouse COE requests.
LGY-1324882	COE	This enhancement created new VSC referral letters to replace existing letters for COS referrals and DFD referrals. In addition, the letter will display whether the Veteran or lender submitted the application.
LGY-1319990	COE	This enhancement added "Space Force" as a manually selectable option for Branch of Service for active duty and reservists.
LGY-1314529	COE	This enhancement added a new Funding Fee Exempt Status "Non-Exempt - In Development" to let lenders know of situations where a Veteran has an exemption status under appeals review.

LGY-1324836	C & V	This enhancement added the functionality for Appraisal stakeholders to view the updated format and data for “VBA Form 26-1805: Request for Determination of Reasonable Value (Real Estate)”.
LGY-1327644	FFLR	This enhancement created the functionality for ULAD files uploaded by users to the WebLGY “FFLR Correspondence” page or provided by lenders via the Loan Review API (to be introduced in a future release) to be validated to confirm files are in the format expected by the VA for processing. Users will be provided an error message if the ULAD file that has been provided is not in the correct format.

LGY-1323812	LGY Hub	This fix ensured all counties will be available for users to select when using the “Guaranty Percentage Calculator”.
