Executive Director's Report: Ben Popp

- Trail projects are underway. We will have an excavator for two months this summer to work on the Classic Trail, some of the snow-making loops, Korte stadium, OO building/grounds and plenty of erosion repair
- We're developing an idea of a "Sport Development" tour to visit various clubs in our region to see how we can help them.

- Staff Update: Collen was doing registration/admin, John Oman was doing Reg/Data/Marketing. Ashley Shuman will be joining us to take over the marketing part with Nancy, as well as some of the adminisetrative duties of Colleen. Colette Belisle will be joining us to take over ALL the registration parts, as well as some of the database stuff. We will be keeping John on in a part-time role to teach out new staff CRM, help with marketing lists and provide our CRM support (discontinuing our contract with Power Objects).

- Birkie Kids/Strength Park at 00 will soon be done along with the Virkus fitness room there. We already have teams asking to come use it.

- ABSF made a payment to Birkie Enterprises to cover more of Louise's salary; she ended up doing more work for ABSF then we paid for, so BE initially overpaid its portion of her salary. That is now all square.

- We had a community meeting in Hayward to get feedback on our mission and vision.
