Attached is information regarding a benefit program called Summer EBT, which will help families in buying food for their children during the summer when they are not in school. If your child receives SNAP, OWF, or Medicaid and are within the free or reduced-price meal income level, you will automatically receive this benefit.

Families can apply for free and reduced-price school meals benefits anytime throughout the school year and if eligible will also approve the children for Summer EBT.

Parents are encouraged to update their address in FinalForms so the benefit will go to the correct address.

Below explains the Summer EBT Program a little more and answers a lot of questions families might have regarding this.

Summer Electronic Benefits Transfer (Summer EBT) Program for Children Fact Sheet

Summer Electronic Benefit Transfer Program for Children (Summer EBT), also known as SUN Bucks, is new in summer 2024. Summer EBT provides grocery benefits to low-income families with school-aged children when schools are closed for the summer. Summer EBT benefits will either be loaded to a household's Ohio Direction Card or a benefit card will be sent in the mail in a plain white envelope addressed to each eligible child.

Families will receive a one-time benefit of \$120 for each eligible child and can use the money to buy food during the summer at grocery stores, farmers markets, and other authorized retailers.

WHO WILL RECEIVE SUMMER EBT AUTOMATICALLY:

All children between the ages of 6 to 18 participating in one or more of the following assistance programs (on or after July 1, 2023) will receive Summer EBT automatically with no need to apply:

- Supplemental Nutrition Assistance Program (SNAP)
- Ohio Works First (OWF)
- Medicaid (if income meets USDA Income Eligibility Guidelines for current program year)

Children of any age enrolled in a school participating in the National School Lunch Program that are approved for free or reduced-price meals for school year 2023-2024 will also receive Summer EBT automatically with no need to apply.

IF STUDENTS ATTEND A COMMUNITY ELIGIBILITY PROVISION OR PROVISION 2 SCHOOL AND RECEIVE NO COST MEALS, ARE ALL STUDENTS IN ATTENDANCE GOING TO RECEIVE THE BENEFIT:

No, each student at a Community Eligibility Provision (CEP) or Provision 2 school are not automatically eligible for Summer EBT.

Households with children that participate in SNAP, OWF, Medicaid and are within the free or reduced-price meal income level, or are homeless, migrant, runaway, or participate in Head Start will automatically get Summer EBT.

Households that are within 185% of the federal poverty level but do not participate in one of these programs can submit a Summer EBT application via the Summer EBT web page at sebt.ohio.gov. 2 | Summer EBT Fact Sheet | 2024

HOW WILL HOUSEHOLDS RECEIVE THE SUMMER-EBT BENEFIT:

Children who qualify for the Summer EBT program will receive benefits in one of two ways:

1. Households that currently receive SNAP benefits will see benefits for each eligible child issued on their Ohio Direction Card.
2. Households that do not currently receive SNAP benefits will receive a new Summer EBT card in the mail for each approved child. The card will be in a plain white envelope and addressed to the child. Households should keep Summer EBT cards to potentially receive future summer benefits.

WHEN WILL BENEFITS BE AVAILABLE:

Households with children already participating in SNAP, OWF, Medicaid with household income within the free or reduced-price school meal guidelines, or certified for free or reduced-price school meals during the school year will receive their benefit by July 31. Check back regularly for updates. Note: benefits will be issued over many days so children in the same household may receive their benefit on a different day from one another.

Households that become eligible for SNAP, OWF, or Medicaid during the summer, or apply for Summer EBT using the Summer EBT application will receive benefits within two months after being approved.

WILL THE SUMMER EBT BENEFITS BE ON A NEW CARD OR LOADED TO THE P-EBT CARD?

Households with active SNAP accounts should have benefits loaded to their Ohio Direction Card. All other households will receive a new Summer EBT card in the mail for each eligible child. The card will arrive in a plain white envelope and be addressed to the child. Any past summer P-EBT cards can be thrown away.

HOW LONG WILL SUMMER EBT FUNDS BE AVAILABLE FOR USE:

Summer EBT funds will expire after 122 days after the benefit is issued. If the benefit is loaded on the Ohio Direction Card, the Summer EBT benefit will be used first the next time you visit a store. 3 | Summer EBT Fact Sheet | 2024

WILL PRESCHOOL, KINDERGARTEN AND GRADUATING STUDENTS BE INCLUDED IN THE SUMMER BENEFIT:

Graduating seniors of any age who are approved for free or reduced-price meals will receive Summer EBT. Preschool and Kindergarten students under the age of 6 will only be included if they are approved for free or reduced-price meals, their school is on the National School Lunch Program or School Breakfast Program, and they are being offered school breakfast and/or school lunch. Preschool or Kindergarten students at a childcare center will not receive Summer EBT.

ARE VIRTUAL/ONLINE STUDENTS INCLUDED IN SUMMER EBT:

When a school has fully virtual/online students with no access to the National School Lunch Program, those students will not be submitted by the school for Summer EBT. However, the student will automatically receive Summer EBT if the student is on SNAP, OWF, or Medicaid (and the household is within the income eligibility of the free or reduced-price meal program).

HOW WILL BENEFITS BE ISSUED FOR CHILDREN THAT LIVE IN MORE THAN ONE HOUSEHOLD:

Student data submissions will only allow for one address per child. The Ohio Department of Job and Family Services, Ohio Department of Medicaid, and Schools will provide the address for the primary guardian.

CAN HOUSEHOLDS PARTICIPATE IN THE SUMMER MEALS PROGRAM AND ALSO RECEIVE SUMMER EBT:

Summer EBT and the Summer Food Service Program are meant to work together to address food insecurity during the summer months when children are not receiving school meals. Households can participate in both programs. Call 1-866-3-HUNGRY (486479) for a nearby location
