was presented and read by title only. City Clerk-Treasurer Rode detailed the appropriation request for Council noting that it is primarily a negative appropriation to reduce expenses in the Electric Fund and Electric Capital Reserve Fund as requested by the Board of Public Affairs at their last meeting.
