AUGUST 9, 2021

Council President Mary Leatherman presided over the Special Council meeting held on August 9, 2021, with the following members present: Judy Yahraus, Jim Kozumplik, and F. John Betts. Council member Ric Hupe was absent. Also present were: Mayor Carrie Schlade, City Attorney Rhonda Fisher, City Engineer Brian Wieland, and Deputy Clerk-Treasurer Patricia Buda.

Council President Leatherman called the Special Meeting to order at 12:00 p.m.

was presented and read by title only. City Attorney Fisher gave a brief history of the opioid crisis that lasted from 1999 to 2008 where a large number of people died from drug overdoses. She recommended reading the book Dream Land by Sam Quinones that tells of this issue. She explained the participation agreement is to allow an effective means of distributing any potential settlement funds obtained under the memorandum of understanding between the State of Ohio and local governments. She was asked if other municipalities were participating and showed the list of multiple entities. The participation form needed to be signed, dated and returned by August 13, 2021 if approved. Mayor Schlade indicated that was the reason for the special meeting as the notice for action came out after the last Council meeting on August 2, 2021. Further discussion was held on how the funds could be spent: the Narcan drug used for opioid overdoses, education and training for first responders.
