Council President Richard Hupe opened the meeting with the following members present: F. John Betts, Judith Yahraus, Mary Leatherman, and Jim Kozumplik. Mrs. Yahraus moved, Mr. Betts seconded, to approve the minutes from the January 17, 2023, Regular Meeting and the January 26, 2023, Joint Special Meeting as written. Roll call vote: all ayes; nays, none. Motion carried.

Ordinance No. 2, 2023, titled,

AN ORDINANCE PROVIDING FOR THE TRANSFER OF FUNDS FOR THE CITY OF BRYAN, FOR THE MONTH ENDING FEBRUARY 28, 2023

was presented and read by title only. Clerk-Treasurer Rode detailed the transfers requested to Council.

Included in the changes were times for the semi-annual bulk drop-off as well as the month for the annual rate increase.

She thanked all involved for their efforts.

Fire Chief Pool and Wastewater Superintendent Wygant gave annual reports for the Fire and Wastewater Departments, respectively. Discussion was held at various intervals of the presentations.

Mayor Schlade and Council shared their appreciation of all the grants received and applied for this evening. In addition, they thanked Fire Chief Pool and Wastewater Superintendent Wygant for their presentations.
