

## Investor In Students Survey Prize Draw Competition

  - fully complete the survey in the link provided by Collegiate AC Ltd;
  - be 18 years old or above and be able to prove you are a current student studying in the UK. This will only be requested if you are randomly selected as the winner of the Competition;
  - be a Collegiate AC Ltd resident over the age of 18 years old with a minimum tenancy length of 39 weeks.
