COLLETON COUNTY COVID-19 UPDATE

Colleton County officials have been notified of 1942 total cases of COVID-19 in Colleton County, with 358 current cases. These cases of COVID-19 are in the 29082, 29435, 29446, 29452, 29474, 29475, 29481, 29488, 29929 and 29945 ZIP codes. Colleton Medical Center

Colleton Medical Center will not be vaccinating the general public at this time. Due to limited supplies, they will continue to prioritize the vaccination of healthcare workers within the community. Colleton County School District

The Colleton County School Board of Trustees voted unanimously, during a January 12 special board meeting, to extend virtual learning for Colleton County School District students by one week, due to the increase of COVID-19 cases in the Lowcountry region.

All students will continue to learn virtually until January 22, and will not report to their schools. Information on changes to bus routes and meal delivery schedules will be released as soon as possible on the CCSD website (colleton.k12.sc.us), and through mass emails and phone dialers.

All CCSD teachers and support staff will continue to report to their regular work locations during the virtual learning period.
