Grain procurement fast: CM

Grain procurement in the State is progressing at a fast pace, with Civil Supplies officials having purchased 21,04,233 metric tonnes of various farm products so far, said Chief Minister Chandrababu Naidu on Friday.

After inspecting the grain pur-chase centres at Rythu Seva Centres in Ganguru, Íocated in the Penamaluru Assembly segment of Krishna district, the Chief Minister held a meeting with local farmers. Speaking to the media, he highlighted the losses farmers had suffered under the previous government, which failed to pay them after

"Under the TDP-led NDA Government, payments are made to farmers within 48 hours of grain purchase. In fact, 93% of farmers receive payments within 24 hours. So far, Rs 4,730 crore has been credited to the accounts of farmers across the State," said Chandrababu. The Chief Minister assured that measures would be taken to increase farmers' revenue, adding that the farming community is now in a better position compared to before. He also announced the introduction of the silo system, which will bring storage facilities closer to farmers, allowing them to market their produce at their discretion. This system, he said, would also ensure better prices for stored grain.

World Bank approves \$800 m loan for AP

The World Bank's Board of Executive Directors has approved the \$800 million Amaravati Integrated Urban Development Programme for building Andhra Pradesh's greenfield cap-ital city Amaravati, the international

development said on Friday. The Bretton Woods institution's Board of Executive Directors met in Washington, USA on Thursday and

approved the loan. "The World Bank's Board of Executive Directors on Thursday approved the USD 800 million Amaravati Integrated Urban Development Program aimed at establishing the city as a well-managed, climate-resilient growth centre in Andhra Pradesh that generates jobs and improves the lives of its current and future residents, especially the most vulnerable," a World Bank press release said.

According to the World Bank, the Government of India requested the USD 800 mn loan to develop Amaravati as an economic hub and the state capital of Andhra Pradesh.

The loan has a final maturity period of 29 years, including a grace peri-od of six years, said the World Bank, adding the government has decided to avail the financing in Japanese Yen. Auguste Tano Kouame, World

Bank's Country Director for India, said the multilateral institution will bring global expertise to support the design of city institutions and infrastructure that can create economic opportunities for residents, including omen, youth and vulnerable groups.

"With its urban population expected to double to 950 million by 2050, India aims to build sustainable and liveable cities as growth hubs, and Amaravati offers an exciting opportunity to model this urban transformation," Kouame said.

Low pressure intensifies into depression

The well-marked low pressure area over the Bay of Bengal intensified into a depression on Friday evening. The Meteorological Department, in an update issued at 5:30 pm, confirmed that the low pressure area over the west-central and adjoining southwest Bay of Bengal had moved slightly northwards and concentrated into a depression.

A daily weather report stated that the system is associated with an upper cyclonic circulation extend-



ing up to 5.8 km above mean sea level. It is expected to continue moving northwards and intensify into a depression over the west-central Bay of Bengal within the next 12 hours

Subsequently, the system is likely to move north-northeast, maintaining the intensity of a depression over the next 24 hours. Heavy rain is expected at isolated places in North Coastal Andhra Pradesh over the next 24 hours.

Thunderstorms with lightning are also likely at isolated locations in

the same region during this period. Squally winds, ranging from 40-50 kmph, gusting up to 60 kmph, are expected in North and South Coastal Andhra Pradesh during the next 24 hours.

Light to moderate rain or thundershowers are likely at a few places in Coastal Andhra Pradesh and Ravalaseema over the next seven days. Rainfall occurred at many places in Coastal Andhra Pradesh and a few locations in Rayalaseema in the past 24 hours, the report added

Body found in parcel sent to woman

A shocking incident unfolded at Yendagandi village in Undi mandal, on Friday when a woman, Sagi Tulasi, discovered a human body within a parcel box sent by the Kshatriya Foundation.

Tulasi, a recent recipient of a gov ernment-allocated house site, had sought assistance from the foundation for construction materials. After receiving an initial shipment, she requested additional electrical

supplies. The foundation responded by sending a parcel containing the ill-fated package.

Upon opening the box, Tulasi was horrified to find the severely decomposed body of a 45-year-old man. A ransom note demanding Rs 1.30 crore was also discovered inside.

AP inks MoUs with tech giants for University of Innovation

Andhra Pradesh is making rapid strides towards becoming a global hub for technological advancements with two major agreements aimed at enhancing its deep-tech capabilities. In line with its vision to foster innovation, the State government has partnered with key organisations in the education and technology sectors, marking a pivotal moment in its push to integrate cutting-edge technologies into its growth trajectory.

The Andhra Pradesh government has entered into a Memorandum of Understanding (MoU) with Physics Wallah (PW) an EdTech company, and Amazon Web Services (AWS), to establish the first AI-focused Institute of Eminence (IoE) in the State. Named the University of Innovation (UoI),

s a new era in the Congress party's history just around the corner? Will the party be forced to unshackle itself soon from the ownership of the Nehru dynasty, which has lasted seven and a half decades? Like Bahadur Shah Zafar of the Mughals, will Rahul be the last emperor of the Congress? Will the postdynasty Congress chapter start even before this Lok Sabha's term ends?

One of history's greatest lessons is that dynasties come and go. History proves that even dynasties claiming the lineage of gods could not prevent their political extinction. Hence, the question has never been if the Nehru dvnastv's total control over Congress will ever end, but when? The trajectory of the Congress party over the past few decades and the recent political happenings in the country confirm that the

get people's mandate to rule without a Nehru dynasty member at the helm. Of course, the ability - real or perceived - to lead their party to power is essential to the next rung leaders in any party, paving the way for the dynasty to regain control over the Congress.

But if PV Narasimha Rao could not prove that a nondynasty leader could get the party into power, Rahul Gandhi demonstrated that even a dynasty member could

not guarantee it. On the contrary, as the party's de facto owner since 2014, Rahul proved that a dynasty member could helm the party into its decimation. Meanwhile, the Congress's regional satraps like Mamata Banerjee, YS Jagan Mohan Reddy and Sharad Pawar proved that breaking away from the Congress and freeing themselves of the burden of the Nehru dynasty could result in electoral success at the state level



At the same time, as the fortunes of the Congress under the Nehru dynasty leadership were dwindling, Arvind Kejriwal (AAP) and Chandrasekhar Rao (BRS) formed their parties, leading them to electoral victories in the states. Though the 99 seats won by the Congress in this year's General Election seemed to give the dynasty a muchneeded breather, the party's rout in Maharashtra and Haryana, where it performed decently in the Lok Sabha elections, made the respite short-lived.

The recent rumblings with-in the Congress-led INDI alliance, the proposal to make Mamata Banerjee its leader, and National Conference and Trinamool Congress leaders debunking the Congress's ludi-crous stand on EVMs - all reflect their conclusion that Rahul Gandhi's leadership is becoming a liability for not only Congress but its partners too. Rahul Gandhi's becom-ing the LoP (Leader of the Opposition) further exposed his behaviour as unbecoming of the high office and revealed his lack of political depth and strategy. Additionally, it made his dynasty's record on the

Constitution, Babasaheb Ambedkar, and reservations a liability to the Congress and the entire INDI alliance.

"The best way to predict the future is to create it," said Abraham Lincoln. Except for the vague "Idea of India" slogan, which voters rejected multiple times, and the pursuit of power at any cost - including inviting foreign interference, denigrating India to spite Prime Minister Narendra Modi, fomenting division in society, and championing appeasement politics leading to a perception that Congress is an anti-Hindu party as pointed out by AK Anthony, the dynasty failed in providing an alternate vision to BJP's Viksit Bharat and India First, killing its relevance to Bharat's future. And, that too at a time is near. when Indians, after a thousand years of invaders' rule, are regaining confidence and tak-

ing pride in their Indic roots. Soon, the Congress will either discard the dynasty and reinvent itself to remain relevant, or its state-level leaders will realise they are better off without the suzerainty of the Nehru dynasty and seek their separate paths. Regional Congress leaders know they are in power (only) in Himachal, Karnataka and Telangana, not because of, but despite, the dynasty. The second out-come is more likely given the ancient regime's hold over the central party - in which case Telangana's development will stop being a hostage to the dynasty's thoughtless posturing and demand for funds to fight elections across the country. 'Govt committed to uplift of livestock keepers'

The Andhra Pradesh government is actively implementing special programmes to ensure the welfare of livestock and the economic development of livestock keepers, according to MM Naik, Secretary to the Animal Husbandry, Dairy Development, and Fisheries Department.

Naik held a virtual review meeting with State-level and District Animal Husbandry officials and Divisional-level Deputy Directors to evaluate ongoing schemes and programmes aimed at uplifting livestock keepers.

During the meeting, Naik emphasised the timely execution of all programmes and schemes under the department, stressing the need to reach livestock keepers in remote areas effectively. He warned against any laxity in implementation, stating that negligence or shortcomings would result in appropriate

departmental action. The Secretary directed officials to prepare detailed action plans for January, focusing on key programmes such as medical services and vaccination drives as per schedule, the Sex-Determined and Semer Scheme, and initiatives under the Mahatma Gandhi National Rural Employment Guarantee Scheme. These include constructing Gokulas (cattle sheds) and promoting multiannual fodder cultivation. Other areas reviewed included the progress of the 21st All India Livestock Census, the Pashu Kisan Credit Cards Scheme under the fodder security policy, disease control measures including check posts, and family planning surgeries for dogs.

Observing that the 'revenue sadassulu' scheduled from December 3 to January 9, 2025, will resolve long pending land issues, Naidu highlighted that these meetings will take the onus of returning land to its rightful owners. He said 'revenue sadassulu' received 95,263 petitions until now, attended by up to three lakh people and also reminded that the NDA government has enacted stringent rules to deal with land grabbers.

Further, Naidu promised to update land records and issue passbooks embedded with QR codes for owners to check if a particular parcel of land is under their name or not.

HIKE ON GARMENTS AP Chambers appeals to GST **Council to** reconsider move

PNS VIJAYAWADA

The Andhra Pradesh Chambers of Commerce and Industry Federation (AP Chambers) has appealed to the GST Council Chairperson and Union Finance Minister, Nirmala Sitharaman, to reconsider the proposed increase in GST rates on garments. The proposal suggests raising the GST from 12% to 18% for garments priced between Rs 1,500 and Rs 10,000 and imposing a 28% GST on garments priced above Rs 10,000. In its representation, AP Chambers emphasised the significance of the textile and garment sector to Andhra Pradesh's economy and employment. The organisation warned that the proposed GST hike could adversely affect the sector, which is already struggling with escalating input costs, global market volatility, and declining consumer spending. The increased taxes, it argued, would lead to higher garment prices, making them unaffordable for middle-income consumers and causing a dip in demand.

AP Chambers noted that most businesses in this sector are small and medium enterprises (SMEs) operating on thin profit margins. The additional tax burden could result in closures, layoffs, and significant job losses, further impacting the economy.

ESI Medical College in Amaravati: CITU slams State Govt

SAYS SETTING UP THE MEDICAL COLLEGE IN AMARAVATI, INSTEAD OF UTTARANDHRA, REFLECTS A BIASED APPROACH

The Centre of Indian Trade Unions (CITU) has strongly criticised the Andhra Pradesh government's decision to establish an ESI Medical College in Amaravati, instead of Uttarandhra, which is home to 14 lakh ESI members. CITU State general secretary CH Narasingha Rao expressed his concerns at a press conference held at the CITU office in Jagadamba on Friday. "Setting up the medical col-

lege in Amaravati reflects a biased approach," Rao stated. "Andhra Pradesh does not mean just Amaravati. This narrow policy is unfair and overlooks the needs of other regions." Rao emphasised the need for balanced regional development and reiterated the demand to



establish the medical college in Visakhapatnam, where a 500bed ESI hospital is already under construction in Sheelanagar.

Rao also addressed the ongoing issues surrounding the Visakhapatnam Steel Plant, accusing the Central government of deliberately creating debt to facilitate privatisation. "Instead of saving the steel plant, which was built through

the sacrifices of the people, announcing a new plant in Nakkapalli with RC Mittal is both absurd and insulting," he said. The CITU leader further questioned the State government's commitment to the "The Visakhapatnam plant. Steel Plant has been operational for 30 years. Is it not the government's responsibility to ensure its survival?" he asked. Rao also criticised the State

government's plan to procure electric buses, alleging it was a veiled attempt to hand public assets to private operators. "The government plans to buy each bus for Rs. 2 crore and lease them to private operators, instead of addressing the need for 12,700 new buses over the next five years," he explained. The discussion also covered

the privatisation of the Road

Transport Corporation (RTC), with Rao claiming that the State government is preparing to sell prime RTC lands worth Rs 2 lakh crore. "These lands, including 129 depots, 423 bus stands, and zonal workshops in Vijayawada, Nellore, Kadapa, and Vizianagaram, are being targeted for privatisation under the guise of modernisation," Rao claimed. "This is a conspiracy to dismantle RTC for private gain."

Rao urged workers in Andhra Pradesh to participate in a nationwide protest on December 25 against the Central government's decision to privatise the Chandigarh State Power Company. "This fight is not just about Chandigarh, but about protecting public resources and services across India," he urged.

Four PHCs sanctioned for Eluru dist

PNS FIURU

Union Minister of State for Health and Family Welfare, Prataprao Jadhav, announced that four Primary Health Centres (PHCs) have been sanctioned for the Eluru district under the National Health Mission (NHM). These PHCs are currently under construction.

Responding to a question by Eluru MP Putta Mahesh Kumar during the winter session of Parliament, the Union Minister detailed the funds allocated for hospital construction and upgradation in Eluru district and Andhra Pradesh over the past five years. The Minister stated that six

PHCs were sanctioned for Andhra Pradesh under the NHM scheme, of which five have been completed. Four of these PHCs are allocated to the Eluru district and are in progress. Additionally, four maternal and child health wings were sanctioned for Andhra Pradesh, with three already completed.

Regarding health and well-



ness centres, the Union Minister revealed that 2,727 were sanctioned for Andhra Pradesh, including 107 for the Eluru district, all of which are operational. Under the 15th

Finance Commission, 334 Block Public Health Units were approved for Andhra Pradesh, with 35 completed. In the Eluru district, 15 were sanctioned, with one completed.

The Minister also disclosed that nine Community Health Centres were sanctioned for Andhra Pradesh. Under the PM Ayushman Bharat Health Infrastructure Mission, 26

Integrated Public Health Labs were approved, of which 13, including one in Eluru district, are operational.

For Critical Care Blocks, 24 were sanctioned for Andhra Pradesh, with one allocated to Eluru district. From 2021-22 to 2025-26, Rs 1,271.8 crore was allocated under PM-ABHIM, and Rs 2,600.8 crore under the 15th Finance Commission Health Grant, totalling Rs 3,872.6 crore for strengthening healthcare infrastructure in the state.

The Minister further highlighted the Centrally Sponsored Scheme (CSS) for establishing new medical colleges in association with district referral hospitals, with a funding ratio of 90:10 for northeastern and special category states and 60:40 for other states. Under this initiative, 157 medical colleges have been approved nation-wide, including three in Andhra Pradesh-Piduguralla, Paderu, and Machilipatnam. Among these, the colleges at Paderu and Machilipatnam are operational.

Skill hubs being set up for youth: Minister Parthasarathy

Minister for Housing K Parthasarathy has announced that skill hubs are being established in all 175 constituencies to provide technical training to unemployed youths.

The Minister, accompanied by district Collector K. Vetri Selvi, inaugurated the 'Mega Job Mela' at the IIIT campus in Nuzvid on Friday. Speaking at the event, the Minister reaffirmed the State Government's commitment to creating over 20 lakh jobs in the next five years. He emphasised the Government's goal of making an entrepreneur in every home by providing necessary support. "The Government has prioritised quality education, large-scale employment generation, and entrepreneurship. Efforts are underway to attract world-renowned MNCs to establish units in Andhra Pradesh," the Minister highlighted.

He acknowledged that a new industrial policy is being formulated to attract more investments and announced the conduct of a 'Skill Census.' The Minister revealed that NTPC will set up non-conventional energy units in the State, costing Rs 1.87 lakh crore, which will provide 1.06 lakh jobs. Parthasarathy observed. The Minister further announced that Nara Lokesh had convinced Reliance to establish 500 compressed biogas units at an investment of Rs 65,000 crore in the State. K. 

'Worried parents on ferry planned to throw children in sea water'

PNS NEW DELHI

The panic-stricken parents onboard an ill-fated tourist ferry were thinking of tossing their children into the sea water as a desperate measure after their boat started sinking off Mumbai, but a team of CISF marine commandos stopped them with an assurance that everyone will be saved.

CÍSF constable Amol Savant (36) and his two colleagues became the "first responders" after the December 18 accident. Their patrol boat reached the accident site off the Mumbai coast around 4 pm, and they decided to utilise the "golden hour" for first saving the most vulnerable, including the children.

Fourteen people were killed after a Navy boat rammed into the tourist ferry -- 'Neel Kamal' -- on way to the Elephanta Island from the Gateway of India in Mumbai late Wednesday afternoon.

"We were on routine patrol at some distance off the shore when our walkie talkie crackled to inform us that a passenger ferry was sinking. I asked the pilot (speed boat driver) to go full throttle and we reached the accident site about 3-4 kms away in no time," Savant told PTI here.

He said he was "astonished to see the accident site. But being a trained soldier, I understood what was to be done and how." "We saw people were ready to throw their children in

An abhorrable practice

The SC's observation on witchcraft practices is a timely reminder that women still face humiliation under various pretexts

n a landmark observation, the Supreme Court of India recently described the victimisation of women under accusations of witchcraft as a 'blot on the constitutional spirit.' The case before the apex court, involving egregious acts of abuse and violence against women in Bihar's Champaran district, has brought the spotlight on the persistent issue of witch-hunting in the country. The court's remarks emphasise the urgent need to eradicate such practices that undermine the dignity, equality and human rights enshrined in the Constitution of India. The bench, comprising Justices CT Ravikumar and Sanjay Karol, was dealing with a petition concerning a disturbing incident that occurred in early 2020. Women were publicly assaulted, disrobed, and accused of witchcraft. One of the accused individuals, Lakhpati Devi, along with others, faced charges for these heinous acts. Reportedly there was police apathy towards the victim. The apex court expressed its shock and dismay at the brutality of the acts and the apparent indiffer-



ence of the legal machinery. Such incidents, the court observed, are a direct affront to the dignity and rights of women, particularly in rural areas where equality remains a distant goal. The court highlighted the role of superstition, patriarchy, and social control in perpetuating witch-hunting practices. It called for the eradication of these regressive beliefs, which often target vulnerable women such as widows and the elderly. Indeed, such practices stand in stark opposition to the scientific temper mandated by the Constitution. Unfortunately these are not isolated cases but are rampant in rural India. The Constitution of India guarantees justice, liberty, equality and dignity for all

citizens. Practices like witch-hunting undermine these principles and perpetuate a culture of discrimination and violence against women. What is more shocking is the apathy of the government in such cases who are equal partners in crime. The court reiterated that the responsibility of investigating and adjudicating authorities is heightened in cases involving violations of human dignity. The Supreme Court also criticised the state for not challenging the High Court's non-speaking order, which granted a stay on the proceedings. The bench's observations underscore the need for a multi-pronged approach to address witch-hunting. This includes strengthening laws to explicitly criminalise witch-hunting and ensuring stringent punishment for perpetrators. Besides, promoting scientific temper and educating communities about the illegality and immorality of witch-hunting. But most important is establishing support mechanisms for survivors, including legal aid, rehabilitation, and psychological counseling. The government machinery also need to be sensitised in dealing with such cases. The Supreme Court's remarks serve as a clarion call to address the deep-seated issues of superstition and patriarchy that enable witch-hunting. The victimisation of women under such baseless allegations is not merely a social evil but a constitutional failure.



Revisiting the Places of Worship Act

The Places of Worship Act, 1991, was enacted to maintain the religious status of sites as of August 15, 1947 but there is misunderstandings about its purpose

ow the Places of Worship Act (1991) is being dealt with at present is due to many not being aware of how and why the Act came about. Evidently, the then Prime Minister PV Narasimha Rao (1991-96) in his heart of hearts was a staunch Hindu. He was anxious to contribute to help solving the then existing-or festering-problem at Ayodhya. Most developments that took place at the Janmasthan on December 6, 1992, spoke of Rao's silent participation in the cause of Ram Lalla.

The most clinching evidence of the Prime Minister's contribution was indicated by the facts when I left Ayodhya on that momentous day. It was 5:45 pm; all the three domes of the Babri edifice had been brought down. All the ten walls were still standing and so was the rest of the structure. Soon after we sat in our car to proceed to Lucknow, my comanions and I heard on the transistor radio that the Uttar Pradesh government of then chief minister Kalyan Singh had been dismissed by the Centre, and Governor's rule imposed.

That meant whatever was done thereafter was the handiwork directed by someone at the Centre. At the Centre, even the then-home secretary Madhav Godbole is on record saying that he did not know a thing about what was happening and had learnt about it only through the

radio and television. This author has not met not knows anyone who has claimed that he has seven even a photograph of the edifice walls without their domes. At 10 pm that very night, PM Narasimha Rao addressed the nation on television, wherein he assured the people of India that he would rebuild the Babri Masjid as soon as possible. This gave the impression that the entire edifice had stroved. The walls were tall and thick as was the style of the next 60 hours. Indeed, an the architecture of the 16th century. Incidentally, she added there were consummate numbers of bulldozers in the nearby vicinity, along with their operators. Evidently, all these preparations were deployed to see the end of the Babri edifice over enormous thing to accomplish, in such a short time. 

Philippines: The broken promise of democracy

The resurgence of the Marcoses, the entrenchment of the Aquinos, and the dominance of families like the Dutertes show the enduring grip of oligarchy



he 1987 Philippine Constitution, crafted in the aftermath of the 1986 People Power Revolution, was supposed to mark the dawn of a new democratic era. The ousting of Ferdinand Marcos Sr., after decades of corruption, repression, and dynastic rule, was a victory for the Filipino people, or so they were told. Yet, the Constitution, supposedly a tool for dismanling the oppressive old order, contains a glaring, unimplemented clause: Article II, Section 26, which bans political dynasties. Nearly four decades later, this promise remains a cruel joke, the prohibition nothing more than a symbol of a nation shack-led by its feudal past. Political dynasties thrive unabated, and the Philippines remains trapped in a cycle of oligarchy, where power is passed down like a family heirloom, not earned through democratic means. The rise of Corazon Aquino, the "hero" of People Power, has proven to be a double-edged sword.

While she restored democracy in name, she failed to eradicate the dynastic forces that had long plagued the country Instead of dismantling the Marcos empire and the dynasties that thrived in its wake, Aquino's presidency paved the way for a new set of ruling families to stake their claim on the throne. The irony is staggering: Aquino, the DISARM THE VERY symbol of resistance to Marcos, was unable to disarm the very forces that helped prop up the dictatorship. Her administration's failure to enact meaningful reform paved the way for the Marcos family's return to power, with Ferdinand "Bongbong" Marcos Jr.'s rise in 2022 exposing the unyielding grip of dynastic politics, illuminating the eternal truth behind the words of José Rizal, a true revolutionary executed by the Spanish in ADMINISTRATION'S Manila: "The Filipino is not a slave of the Spanish Government. He is a slave of his FAILURE TO ENACT own people."The Marcoses, who plundered billions from the nation's coffers, are not the only ones to have manipulated the system to their advantage. Under Cory Aquino, the promise of land reform was shattered, epitomised by the Mendiola Massacre of 1987, where farmers demanding land reform were gunned down. The Aquino family, despite their image as the champions of democracy, have blood on their hands, betraying the very

people they claim to defend. The hypocrisy of the political elite is stag-gering, with families like the Marcoses and the Aquinos using their histories of violence and corruption as stepping stones to further entrench their power. But the Aquino-Marcos rivalry is only the tip of the iceberg. In Mindanao, the Duterte family's hold on power predates Rodrigo Duterte's presidency, with a history of death squad killings and iron-fisted rule. As mayor of Davao City, Duterte ruled with an iron fist, silencing dissent and using extrajudicial executions to rid the streets of perceived enemies.

And yet, despite the horrific nature of the crime, justice has been slow and incomplete, as political dynas-ties use their influence to shield themselves from the consequences of their actions. In regions like Cebu and Ilocos Norte, political dynasties such as the Osmeñas, Garcias, and Fariñases manipulate elections and use their wealth to maintain control, treating public office as their domain. This cycle of violence and impunity, where the ruling class prioritises their interests, extends to the economic realm, with families like the villagers growing their wealth through political power. The system persists due to cultural deference to family authority, weak institutions, and pervasive poverty, with voters often coerced into supporting the very dynasties that sustain their suf-

fering. particularly Foreign United States, have long been complicit in this system. During the Marcos era, the US provided crucial support to a regime known for its human rights abuses, all in the name of anti-communism. This foreign patronage emboldened the Marcoses and set a dangerous precedent for other dynasties, who continued to seek validation and support from foreign powers. The interplay between domestic power struggles and international interests further deepens the fractures with-in the Philippines, exacerbating the country's internal divisions. The Philippines' educational system, which fails to foster critical thinking or civic engagement, ensures that the cycle of dynastic rule will continue. Schools produce citizens ill-equipped to challenge the status quo, while the media, often co-opted by powerful families, serves to protect the interests of the elite. Social media, too, has become a tool for dynasties to spread propaganda, rehabilitate their tarnished images,

The current political spectacle cen-tred around Vice President Sara Duterte's public threats against President Marcos, is a stark reminder of how fragile the Philippines' democracy truly is. The alliance between the Marcoses

and the Dutertes, forged during the 2022 election, is now on the brink of collapse. What once seemed like a partnership between the North and south's ruling classes has devolved into a bitter feud, exposing the cracks in a political system built on corruption, nepotism, and violence.

This is not a battle for the people's interests, but a struggle for control between two families, each vying for supremacy in a system that has failed its citizens. This feud is not just political-it has geopolitical ramifications. Marcos' pivot towards the US and his opposition to China's claims in the South China Sea have reignited regional tensions, while Duterte's pro-China stance during his presidency deepened divides within the Filipino elite. This divergence in foreign policy has intensified the rift between the Marcos and Duterte families, as they seek to align themselves with opposing global powers. The Philippines, caught between these imperial rivalries, faces not only internal political decay but external pressures that threaten to destabilise the nation further. As the midterm elections approach, this dynastic battle threatens to unravel whatever semblance of governance remains. Marcos seeks to consolidate power, while Sara Duterte faces the looming threat of impeach-ment. Yet, the Duterte family's influence, particularly in Mindanao, ensures that this battle will not stay within the confines of parliament. The streets could erupt, worsening societal divides. Risks: Regardless of the strategy chosen, it is crucial for companies to address patent infringement risks early in the research and commercialization process. Proactive measures such as in-licensing, cross-licensing, patent pooling, and designing around can help avoid future disputes.

Steps to Minimise Litigation

A systematic FTO search before launching a new product is indispensable for minimizing infringement risks. While an FTO search cannot completely eliminate the possibility of litigation due to limitations in patent databases and search expertise, it significantly reduces potential threats.

Forex reserves drop \$2 bn to \$652.86 bn

ndia's forex reserves dropped by USD 1.988 billion to \$ 652.869 billion for the week ended December 13, the RBI said on Friday. In the previous reporting week, the overall reserves had dropped by \$3.235 billion to \$654.857 billion. The reserves have been declining for the last few weeks, and the drop has been attributed to revaluation, along with forex market interventions by the RBI to help reduce volatilities in the rupee. The forex reserves had increased to an all-time high of \$ 704.885 billion in September. For the week ended December 13 foreign currency assets, a major component of the reserves, decreased by \$3.047 billion to \$562.576 billion, the data released on Friday showed. Expressed in US dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves. Gold reserves increased by \$1.121 billion to \$68.056 billion during the week, the RBI said. The Special Drawing Rights (SDRs) were down by \$35 million to \$17.997 billion, the apex bank said



Cipla faces over Rs 1 crore penalty by GST authority

harma major Cipla Ltd on Friday said a fine of over Rs D1 crore has been imposed on the company by GST authority for alleged inadmissible credit claim. The company has received an order dated December 18, 2024 passed by the GST authority, imposing a penalty of Rs 1,11,94,324 under applicable provisions of the Central Goods and Services Tax Act, 2017, Cipla said in a regulatory filing. "The order has been passed by GST Authority on the contention that the company has availed inadmissible TRAN-1 credit. The GST Authority has ordered for recovery of the same along with applicable interest and penalty," it added. Cipa said based on assessment of facts and prevailing law, it is "of the view that the penalty levied is arbitrary and unjustified". "The company will file necessary appeals with the appellate authority in this regard.

Priority should be restoring inflation-growth balance: Das

PNS MUMBAI

Policy priority should be on restoring the inflation-growth balance, said Shaktikanta Das, former Reserve Bank governor, while voting for a status quo on the short-term lending rate earlier this month.

Das, and three other members of the rate-setting panel -- Monetary Policy Committee -- voted in favour of keeping the repo rate at 6.25 per cent, while the other two members favoured reduction in the rate.

In its December bi-monthly monetary policy, the Reserve Bank of India (RBI) kept repo rate unchanged but cut the cash reserve ratio that banks are required to park with the central bank, as it did a balancing act between inflation management and supporting economic growth.

With India's GDP seeing a sharper-than-anticipated dip in the July-September period to 5.4 per cent -- its slowest pace in seven quarters -- inflation on the uptick and rupee under pressure, the RBI had few choices to make.

"The policy priority at this critical juncture has to be on restoring the inflation growth balance. The fundamental requirement now is to bring down inflation and align it with the target," Das said as per the minutes of the December 4-6 MPC meeting released by the RBI on Friday.

It was the last meeting of the

Sanjay Malhotra has been appointed the RBI Governor, who will chair his first MPC meeting in February.

According to the minutes, in the overall assessment of the outgoing governor, the gains achieved so far in the broad direction of disinflation needs to be preserved, while closely monitoring the evolving outlook of both inflation and growth.

Along with Das, Saugata Bhattacharya, Rajiv Ranjan (Executive Director, RBI) and Michael Debabrata Patra (Deputy Governor, RBI) voted for status quo on interest rate.

External members Nagesh Kumar and Ram Singh, were both in favour of a 25 basis point reduction in repo rate.

As per the minutes, Nagesh Kumar said he believes that a rate cut would help reviving economic growth without worsening the inflationary sit-uation, which may soften with

The RBI, however, added the penalty is based on deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transactions or agreement entered into by IndusInd Bank with its customers

Wicketkeeper-batter Richa Ghosh has urged the Indian women's team not to take the foot off the pedal after their T20I series victory, but to adopt a more aggressive approach when they face West Indies in the upcoming three ODIs.

Ghosh smashed a world recordequalling fastest fifty, reaching the milestone in just 18 balls. The 21year-old, who scored 54 off 21 balls, including five sixes and three fours, joining an exclusive club, that features New Zealand's Sophie Devine and Australia's Phoebe Litchfield. Her innings helped India pile on 217 runs in the third T20I on Thursday.

"We will look to carry the momentum and approach the ODI series and not go easy, our approach should be much harder. It is a new ground and we will try to assess the situations first and plan accordingly," Ghosh told the media here after India won the

series 2-1. Ghosh said she always has had the mindset to play aggressively.

"I have always loved power hitting. I have also seen my father hit big shots. I have worked hard on my fitness and in the practice sessions," Ghosh added.

According to the producer, just as Rangasthalam catapulted Ram Charan's career to new heights, Bachchala Malli is expected to do the same for Allari Naresh. Amritha Aiyer plays the female lead, while Subbu Mangadevvi directs the film.

Story:

Bachchala Malli (Allari Naresh) is a bright student and loves his father (Kota Javaram). One of his father's decisions hurts Malli and a good boy becomes a bad boy with several bad habits and alcoholism. Discontinuing his studies, Malli takes his tractor and gets involved in unnecessary fights every day. Kaveri (Amritha Aiyer), enters Malli's life and he slowly changes back to a good person. But an incident makes him angry and he is back to his bad habits. What is that incident? The village president Ganapathi Raju (Achyuth Kumar) is

holding all the gunny bag business in that area, but due to some differences with Malli, he is planning something against malli? What happened between Raju and Malli, Did Kaveri marry Malli? If you want to know the answers, you have to watch the movie Bachchala Malli movie.

Analysis:

Director Subbu Mangadevvi made his debut with *Solo Brathuke So Better* which was a decent hit. Now, he directed Bachchala Malli with Naresh as the lead. He said in his interviews that the story is inspired by a real character of Bachchala Malli, but he wrote a complete fiction story. When the promotion videos of this film were released, many compared Naresh's character with Pushpa. But those are completely different except for one similarity.

In *Pushpa*, the protagonist is the son of a father's second wife; the first wife's family didn't recognise him as their family. In this movie, the protagonist Malli's father chooses his second wife, and abandons Malli and his mother. From then onwards, he hated his father and the hatred became overboard that he didn't want to tell his father's name.

On paper, director Subbu wrote a good story, but when it comes to the narration on the big screen, he concen-trates only on Malli's characterisation. is very close More than that he showed character to Malli and over stupidity which makes me think called him

that a character like Malli lives in this world? On the other side the director is showing the father is very positive and despite his son's hatred towards him, he loves his son. Somewhere, after sometime, the son should realise, but in this film the realization came only in the climax, but till then the narration, story goes normal and nothing interesting.

Director showed Malli as a very bright student and stood school first and also loved his father. There are a few scenes where the boy showed some maturity when someone scolded his father. And then suddenly, the boy did-n't think a second about his father's gesture and the next minute he decided to hate his father, which may not be agreeable. There is no story to tell with the narration as scene wise. Malli is involved in some fighting or some other issue and the director completely concentrates only on him.

A college girl falls in love with Malli, who always drinks, fights with others with his stupidity, is another reason to not believe this film. The lead pair romantic thread is not coming up nicely. A girl

Though Rao Ramesh's role is small, in the climax scenes, he is the best, especially the emotional scenes. He along with Naresh scenes are the only interesting ones in the film. Hari Teja gets a meaty role and she justifies it. Rohini, Kota Jayaram played as parents and they are very adequate. Praveen, Viva Harsha all supported well. Achvuth Kumar's role is not noticed.

The cinematography is good and also the music is not up to the mark. Here and there the dialogues are good and connected.

Verdict:

Finally, in Bachchala Malli the story is written inspired by a real person, but when you watch it on the screen, you don't feel it as real. Does any person behave with that much stupidity? This question arises when we are watching this film. There are no emotional connections except the climax. Naresh's character didn't get either sympathy or anger or anything, because there is a lack of depth in it. You can make a good emotional family story with the characters in the film, but in the end, Bachchala Malli became a complete dud.
