Says illuminating lives of poor is true welfare PNS 📕 NARASARAOPET Chief Minister N Chandrababu Naidu on Tuesday reiterated that true welfare

lies in improving the lives of the poor, emphasising that a poverty-free society is his primary goal. He made these remarks while actively participating in the distribution of monthly pensions to beneficiaries at Yanamandala in Palnadu district.

Addressing a large gathering after the distribution, the Chief Minister reflected on the hardships faced by the people of the State over the past five years. He noted that the situation had been so dire that many people could not even step outside their homes. Chandrababu Naidu sharply criticized the previous government, saying that the former Chief Minister had moved through streets with curtains on either side of the road while cutting down trees and forcibly displacing people. He contrasted this with his own approach, stating that he remains a simple, accessible leader who prior-itizes the well-being of the people. "I do not have any high command, but the five crore people of Andhra Pradesh are my high command," he declared.

During the event, the Chief Minister personally handed over pension amounts to Talari Saramma and Yedukondalu. Afterwards, he visited Yedukondalu's house, where he prepared coffee himself and shared a cup with the family. He inquired about their wellbeing and later directed officials to provide a Rs 5 lakh loan to Yedukondalu's son for self-employment through the BC Corporation, as well as assistance for building his own house.

Chandrababu Naidu also promised Rs 60,000 as financial aid to Yedukondalu for his tyre shop. To Saramma, whose husband had died of COVID-19, he assured support from the State Government and directed officials to grant Rs 3 lakh as a loan to her family. 

Relief for Perni Nani in AP HC

Former minister Perni Venkataramaiah (Nani) has received relief from the Andhra Pradesh High Court. The court heard a petition filed by Nani under the lunch motion procedure. During the hearing, the court issued an order directing the police not to take any action against Nani until further instructions are given, with the next hearing scheduled for Monday (Jan 6).

Nani had filed a lunch motion petition seeking anticipatory bail in connection with a case related to the Public Distribution System (PDS). The Machilipatnam police had named him as accused number 6 (A6) in the investigation. Nani alleged that the ruling government was targeting him and his family by filing false cases against them. Chief Minister N. Chandrababu Naidu has decided to allocate 10% of the liquor shops in the state to toddy tappers and other sub-communities, directing officials to release a notification for the allocation within a week. Out of the 3,396 liquor shops in the state, 340 will be allotted to various communities, including Goud, Shetty Balija, Ediga,

Gamalla, Kalali, Srisayana, Shegidi, Goundla, Balija, Yatha, and Sondi, based on their population in specific areas. Applicants can apply for and pay fees for any number of shops, but each individual will be allotted only one. The tenure for these shops will extend until September 30, 2026. After reviewing the proposals, the Chief Minister gave the go-ahead for the notification to be issued.

Excise dept cracks down on illegal activities in AP

The Prohibition & Excise Department of Andhra Pradesh has intensified its enforcement efforts, leading to significant action against illegal activities, including illicit distillation, Non-Duty Paid Liquor (NDPL), and the trafficking of Narcotic Drugs and Psychotropic Substances (NDPS).

As per official data, between January 1 and December 31, 2024, the department registered 14,539 cases related to illicitly distilled (ID) liquor and jaggery.

DRONE SHOW, REMOTE-CONTROLLED LIFEBUOYS Tech to meet tradition at Maha Kumbh

Cutting-edge technology will light up the night sky of Sangam during the upcoming Maha Kumbh, as a fleet of 2,000 drones will take off in the holy city of Prayagraj to depict the mythical 'Samudra Manthan' and the emergence of 'Amrit Kalash'.

The Union Culture Ministry on Tuesday said that Maha Kumbh 2025 is set to be a "divine and digitally advanced event", reflecting the "seamless integration" of spirituality and technology.

Held every 12 years, the Maha Kumbh will be organised from January 13 to February 26 to showcase India's rich cultural heritage and spiritual traditions.

The drone show will also depict the emergence of 'Amrit Kalash' (nectar pot), creating a "magical visual narrative in the evening sky" the statement said. The show will further highlight the religious and spiritual significance of Prayagraj, offering a unique experience for pilgrims and locals, it added.



City rings in New Year with spectacular celebrations

New Year's Day celebrations were held on a grand scale in Vijayawada and surrounding areas on Tuesday night. Several event management organisations organised special programmes at various hotels, with a large number of people participating in these events and enjoying the festivities. To ensure safety, the NTR district police took strict measures to prevent untoward incidents on the roads, particularly on state and national highways. All major flyovers in Vijayawada were closed.

A live concert featuring music, food, and fireworks was held at the Babburi Ground in Bhavanipuram, near the Punnami Ghat in Vijayawada. Musician Melodi Brahma Mani Sharma performed at the event, while Geetha Madhuri also attended the New Year's celebrations held at Murali Resort in Poranki, near Vijayawada. Many cinema stars and television personalities, including Sid Sriram, participated in various programmes throughout the city. An open mic event was organised at Café Kubera, and a music and entertainment event

took place at Hyatt Place in Gunadala. The Andhra Pradesh government extended the business hours of liquor shops and bars on December 31, 2024, and January 1, 2025. The Director

General of Police, Ch. Dwaraka Tirumala Rao and NTR District Police Commissioner SV Rajasekhar Babu ordered strict security measures to prevent any incidents. The Vijayawada police were on high alert from Sunday night to prevent road accidents and other untoward incidents. In response, several hundred police personnel were deployed on main roads, and barricades were set up at key junctions to check speeding vehicles. Under the directions of Police Commissioner Rajasekhar Babu, all flyovers, including those at Benz Circle, Kanaka Durga, Prakasam Barrage, and the NHAI Bypass from China Avutapalli to Gollapudi, were closed on Sunday night to prevent accidents. The police issued guidelines to citizens regarding the conduct of celebrations. Additionally, breath analyser tests were conducted to check for drunk drivers.

Meanwhile, several churches in Vijayawada held special prayers on the eve of New Year's celebrations, known as watch night services, to mark the end of the year and the beginning of the new one.

These services were held across various Christian denominations, including Moravian, Methodist, Catholic, Lutheran, Anglican, Baptist, Adventist, and Reformed Christian traditions.

Govts taking consumers for granted on power tariff

iven long-standing inefficiencies in the utilities following unbundling of the power sector, it appears that consumers are being taken for granted by successive governments over power tariff, be it hike or col-

lection of true-up charges. No section of power consumers in society is spared when it comes to periodical increases in power tariff by the government of the day, regardless of the party or grouping in power. In Andhra Pradesh, while




The Telugu Desam Party (TDP) has achieved a milestone in its membership registration drive, enrolling nearly 9.4 million members so far. The campaign, launched by party chief N. Chandrababu Naidu on October 26, 2024, has witnessed an average of 1.5 lakh new members joining daily over the past 63 days.

Initially set to conclude on December 31, 2024, the registration deadline has been extended by 15 days, following an overwhelming response from party workers and the public. Responding to requests from members and leaders, including National General Secretary Nara Lokesh, the party announced the extension to accommodate more regis-



trations during the festival season.

This year's membership drive is being conducted entirely through digital platforms, marking a significant shift from traditional methods. Under Nara Lokesh's leadership, the TDP has spent Rs 138



the coming days.

Nellore City has emerged as the top performer in the registration drive, with other regions also recording substantial participation. The top regions include Nellore City (1,46,966 members), Palakollu (1,44,992), Atmakur (1, 34, 584),Rajampet (1,29,783), Kuppam (1,28,496), Undi (1,14,443), Gurazala

Vinukonda (1,08,839),(1,05,158), Mangalagiri (1,04,122), and Kalyan Durgam (1,00,325).

The extended registration period is expected to further bolster the TDP's base ahead of upcoming elections.

Officials highlighted that 21% of liquor sales occur in the lower price category, but the revenue generated has not met expectations. While 72% of liquor sales in the state are from 20 major brands, the prices of most brands in Andhra Pradesh are lower than those in Telangana. Despite an increase in liquor sales, the lower prices have not yielded the expected revenue. Nevertheless, the CM directed that liquor be made

production, distribution, and sales be monitored using technology to prevent violations of regulations. The CM emphasised that even if it results in a loss of revenue, the focus should remain on public wel-

Officials reported that 8,842 cases had been booked against belt shops in the last six months, and 26,000 litres of illicit liquor had been seized. The Chief Minister also approved an increase in the retail margin for liquor shops. The current margin stands at 10.5%, but liquor shop owners had requested an increase due to losses. After reviewing the situation, the government decided to raise the margin to 14%, aligning it with the rate offered in Telangana.

Additionally, the Chief Minister instructed that liquor be made available at Rs 99 per bottle. Officials highlighted that 21% of liquor sales occur in the lower price category, but the revenue generated has not met expectations. While 72% of liquor sales in the state are from 20 major brands, the prices of most brands in Andhra Pradesh are lower than those in Telangana. Despite an increase in liquor sales, the lower prices have not yielded the expected revenue. Nevertheless, the CM directed that liquor be made available at lower prices across the state to ensure widespread availability.

Addressing the issue of belt shops

(illegal liquor outlets), the Chief Minister took a firm stance. He ordered that liquor production, distribution, and sales be monitored using technology to prevent violations of regulations. The CM emphasised that even if it results in a loss of revenue, the focus should remain on public welfare.

Officials reported that 8,842 cases had been booked against belt shops in the last six months, and 26,000 litres of illicit liquor had been seized. The Chief Minister urged authorities to show no leniency towards belt shops and instructed them to take strict action against illegal liquor sales. To curb illegal liquor production and regulate belt shops, the government will launch a special programme called Navodaya 2.0 in January. The initiative aims to raise awareness about the dangers of illicit liquor, create employment opportunities for those involved in the illegal liquor trade, and bring about positive change in their lives.

Despite having paid the recovery amount, the authorities continued to harass him, adding new charges. Nani's wife, Jayasudha, had already been granted anticipatory bail, but new notices were issued. Nani's family had paid Rs 1.68 crore as recovery, but a further Rs 1.67 crore was demanded by the Joint Collector of Krishna District, who issued fresh notices to Jayasudha.

In the same case, the Machilipatnam 9th Additional District Court, under Judge S Sujatha, granted anticipatory bail to Jayasudha on Monday. In a related development, the Machilipatnam Rural Police arrested four individuals on Monday evening in connection with the case. Those arrested included Godown Manager Manasa Teja, Civil Supplies Assistant Manager Kotireddy, and two lorry drivers, Mangarao and Anjaneyulu. The judge ordered their remand for 12 days.



Govt forfeits medal awarded to CBI inspector

he government has "forfeited" the Union Home Minister's medal for Excellence in Investigation awarded to CBI Inspector Rahul Raj in 2023 who was later caught by the agency red-handed, allegedly receiving Rs 10 lakh bribe and dismissed from the service, officials said. Raj, a recipient of a prestigious medal in 2023, was caught "red-handed" on May 19 while allegedly accepting an illegal gratification of Rs 10 lakh from Malay College of Nursing chairman Anil Bhaskaran and his wife Suma Anil, an official alleged. The couple were also arrested. The CBI swung into action after inputs and surveillance by its internal vigilance unit indicated that one of the support teams constituted on the orders of the Madhya Pradesh High Court to examine the infrastructure in nursing colleges in the state was indulging in corruption. Officials in the know of developments said that CBI Director Sood had made it clear in no uncertain terms that "internal vigilance is prerequisite to external action"



NPCIL invites proposals for small nuclear reactors

ndia's nuclear power operator NPCIL on Tuesday invited proposals from the industry to set up 220 MW Bharat Small Reactors for captive use, replacing the existing coalfired thermal power plants used by the steel, aluminium, copper and cement industries. Bharat Small Reactors are 220 MW Pressurised Heavy Water Reactors (PHWR) with an impeccable safety and excellent performance record, which are compact and tailored for captive use, according to a statement from the Nuclear Power Corporation of India Limited (NPCIL). "NPCIL has today invited Request for Proposals (RFP) from visionary Indian industries for setting up 220 MW Bharat Small Reactors (BSRs) for captive use, said the statement. The nuclear power operator said BSRs can provide a sustainable solution for decarbonization of hard-to-abate industries. It would also help these industries secure economic benefits resulting from savings in carbon emission related taxes, thus increasing competitiveness of their products in the global markets, the statement said. The government plans to deploy 40-50 of these nuclear reactors over the next decade in partnership with the private sector.

No evidence of paper leak in **BPSC** exam: Bihar minister

Amid the stalemate over demand for cancellation of a recent competitive exam in Bihar, a close aide of Chief Minister Nitish Kumar on Tuesday asserted that it has received no evidence, so far, of question paper leak.

The averment came from Vijay Kumar Chaudhary, one of the senior-most ministers in the state cabinet, a day after the chief secretary spoke to a delegation of protesters, in a gesture aimed at breaking the deadlock.

Speaking to reporters, Chaudhary said, "The government could not have acted with greater clarity. The top official gave a patient hearing to the aggrieved party. But, to my information, no evidence of question paper leak has

been furnished so far." 'So, as of now, we hold that there has been no paper leak. This is also the stand of the public service commission. One examination centre had witnessed some disturbances and a re-examination has been ordered for the candidates who were affected," the minister said.

"But obviously, there was a conspiracy. Rumours of question paper leak were spread, but nobody knew where was it leaked, and to whom. Those behind this played with the



future of young students. They must be unmasked," he said.

The minister's statement was in line with the stand taken by the BPSC over the matter.

The Combined Competitive Exams were held on December 13 when hundreds, all of them at the Bapu Pariksha Parisar in the state capital, boycotted the test alleging that the question paper had been leaked.

The commission has since ordered a re-examination for over 10,000 candidates who have been asked to appear for fresh test at different centres in the city on January 4.

However, the commission has also held the view that the exam was held properly at the remaining 911 centres across Bihar with no complaints from over five lakh candidates.

But, a section of aspirants have launched an agitation, holding that re-examination must be ordered for all the centres to ensure "level playing field".

'Naxals trying to expand to new areas without much success'

PNS NEW DELHI

Facing tough action from the security forces, the Naxals are making efforts to seep into new areas along inter-state borders but without any notable success, the latest report from the Union Home Ministry has said.

The government's multi-pronged approach -- anti-Naxal operations by paramilitary and state police and simultaneous development initiatives in Maoist-affected areas -- has resulted in a 48 per cent reduction in violent incidents, from 1,136 in 2013 to 594 in 2023, the report said.

A 65 per cent reduction was also noticed in the deaths of civil-

ians and security forces, which came down from 397 to 138 in 2023 as compared to 2013, it said.

Union Home Minister Amit Shah has said that the country would be free of Naxalism by March 31, 2026.

The geographical spread of Left-Wing Extremist (LWE) vio-lence has shrunk considerably. In 2023, 171 police stations in 42 districts reported such incidents, compared to 328 police stations in 76 districts in 2013, the MHA report said.

'The arc of violence has been



considerably restricted with just 25 districts accounting 91 per cent of the LWE violence," it said. According to the ministry's annual report 2023-24, the CPI (Maoist) continues to be the most potent among the various

LWE outfits in the country, accounting for more than 90 per cent of total violent incidents and 95 per cent of resultant deaths. 'Amidst increasing reverses,

The assassination of Maulvi Khalil-ur-Rahman Haqqani, a key leader in the Haggani network, has sent shockwaves across Afghanistan and the region

he assassination of Maulvi Khalil-ur-Rahman Haqqani, the Taliban's Minister for Refugees and a senior figure in the Haqqani network, has exposed significant fractures within the Taliban leadership and deepened the complexities of region-al geopolitics. Claimed by the Islamic State-Khorasan Province (ISKP), the attack not only highlights the Taliban's internal divisions but also eshapes the broader strategic landscape, especially for India On December 11, 2024, Khalil Haqqani was killed in a highprofile suicide bombing in Kabul. This incident underscored the Taliban's failure to ensure internal security and revealed growing tensions between its Kandahar faction, led by Mullah Haibatullah Akhundzada, and the Haqqani network, headed by Sirajuddin Haqqani. These tensions have been fueled by the Haqqanis' perception of neglect or even sabotage by the Kandahar faction. In response to this crisis, Sirajuddin Haqqani convened an emergency meeting in Gardez with key network leaders to address security breaches and the escalating threat posed by ISKP. This development points to potential fragmentation within the Taliban, which carries significant implications for regional stability and India's security.

A fragmented Taliban could destabilize Afghanistan, creating fertile ground for extremist groups like ISKP. This faction's hostility toward both the Taliban and regional actors, including India, raises the specter of increased attacks targeting Indian interests. The resultant instability might also spill over into Pakistan, indirectly affecting India's border security, particularly in Jammu

Capitalising on 'China Plus One': Will India step up?

As global trade dynamics shift under Donald Trump's policies, India stands to gain from the move by multinational companies to diversify supply chains beyond China

eleasing a report the 'Trade Watch', on December 25, 2024, NITI Aayog CEO BVR Subrahmanyam has suggested that trade policies under US President-elect Donald Trump could result in a potential economic boom for India, driven by significant trade diversion in global trade. He said Whatever Trump has announced so far, which is likely to come up... there are opportunities. We are the man at first slip. The ball is coming in our direction. Whether we hold the catch or drop it is for us to decide. There will be huge disruption, and if we prepare for it, there will be a massive boom due to trade diversion.'

This comes after Trump announced additional tariffs on imports from its biggest trading partners - 25 per cent on Canada and Mexico if they fail to check illegal immigration and drug trade. He also announced a general 10 per cent tariff by the US on all imports and a 60 per cent tariff on imports from China. Meanwhile, the US has also announced restrictions on the export of computer chip-making equipment, software, and high-bandwidth memo-ry chips to China. Trump has also threatened to impose 100 per cent tar-iffs on BRICS (Brazil, Russia, India, China, and South Africa) countries if they try to undermine the US dollar. The US is the biggest importer in the world with a mammoth import valued at US\$ 3200 billion during CY 2022. During that year, its import from China alone was US\$536.3 billion which works out to 16.7 percent of total goods imports.

US goods imports from Canada and Mexico were US\$436.6 billion and US\$454.8 billion or 13.6 per cent and 14.2 per cent respectively. In sharp contrast, US goods imports from India dur-ing 2022 were US\$85.5 billion or a meagre 2.6 per cent of its total goods import. Now, if Trump executes his threat of imposing a 60 per cent additional tariff on imports from China, this will lead to an exorbitant increase in the cost of the latter's goods to American consumers thereby rendering them uncompetitive vis-à-vis simila goods coming from other exporting countries such as India. This should help India capture a big slice of the US import basket currently served by China. This should be possible even if Trump imposes a 10 per cent additional tariff on all its imports including from India. As for Trump's threat to impose 100 per cent tariffs on BRICS countries (India is one of them) in the event of the latter putting into action their so-called 'de-dollarization' plan (De-dollarization is a process of moving away from the world's reliance on the U.S. dollar as the chief reserve currency), this is theoretical. At the 16th summit held on 22-24 October 2024 in Kazan, BRICS leaders, including Russian President Vladimir Putin and Chinese leader Xi Jinping, publicly voiced their commitment to jointly introduce an alternative payment system that wouldn't be dependent on the U.S. dollar. The feasibility of implementing this idea anytime soon is suspect. Second, the US is also hell-bent on taking measures that will undermine the capabilities of China to



boost the production of its goods such as electronics (including smartphones), automobiles etc in which it has a comparative advantage. So, it has imposed restrictions on the export of computer chip-making equip-ment, software, and high-band-width memory chips to China. As a result, China not have much AN surplus to send to the US (and **OVERARCHING** other countries), and India will have more space to boost its REASON export of electronics, automobiles BEHIND etc.Third, European Union (EU) countries have also imposed tar-INDIA iffs on Chinese EVs (electric vehicles) and solar equipment. **'DROPPING THE** CATCH DESPITE

ing to substantial surge in their exports especially in high-growth sectors, India has lagged. Although India has achieved production gains, they have not significantly contributed to domestic value addition, unlike its peer economies.

In India's high-tech sector, while exports surged by 350 per cent between 2017 and 2023, domestic value-added output fell by 18 per cent. In manufacturing, by contrast, during this period, even as domestic value-added grew at 26 per cent, it still trailed behind merchandise export growth of 44 per cent.In electronics, India's share in US imports has grown from 0.2 per cent in 2017 to 2.1 per cent in 2023, courtesy of, the government's push toward high-tech exports. However, competitors like Vietnam, Taiwan, Malaysia, and Thailand dominate, with each holding a substantially higher market share in US electronics imports. An overarching reason behind India 'dropping the catch despite the man at first slip and the ball coming in our direction' is a high-cost domestic environment (this is despite a host of incentives given under the Production Linked Incentive or PLI schemes to industries) which makes our products uncompetitive in the export as well as domestic market. It also explains why our industries demand high protective tariffs and government yields; for instance, it has on the table a proposal for a 25 per cent hike in steel import duties. It is also a major factor behind India's reluctance to join major multilateral trade agreements, such as the Regional Comprehensive Economic Partnership (RCEP) and Comprehensive and

Progressive Agreement for Trans-Pacific Partnership (CPTPP) etc which help the country to better integrate into the global economy and benefit from expanded trade opportunities by facilitating access to markets of their member countries duty-free or at close to zero tariffs. Micro, Small & Medium Enterprises (MSMEs) contribute nearly 40 per cent of exports. But, India not being a part of such trade alliances, they are denied an opportunity to boost exports. At the same time, they suffer due to high protective tariffs on the import of basic materials such as steel. A 25 per cent hike in import duties on steel products - asked by the Ministry of Steel - will impart a deadly blow to the MSME There are four major reasons as to why costs in India are high. First, businesses in basic materials and feedstock such as copper, zinc, aluminium, oil and gas, chemicals, petrochemicals etc are natural monopolies enabling them to set high prices. Second, tax rates are pretty high particularly when it comes to petroleum products which are still taxed under the pre-GST regime. By increasing movement costs, these increase the cost of all goods across the board. Third, power tariffs are exorbitant thanks to excessive State controls on power distribution companies. Finally, industries operate in highly interest-rate environments. India can catapult itself to the position of fully leveraging the 'China Plus One' strategy only if it effectively addresses the present high-cost syndrome. Key infra sectors' growth slows to 4.3 pc

he output of eight key infrastructure sectors slowed down to 4.3 per cent in November 2024 against 7.9 per cent growth registered a year ago, according to official data released on Tuesday. On a monthly basis, the production growth of these sectors was higher than the 3.7 per cent expansion recorded in October 2024. In November, production of crude oil and natural gas contracted. The production growth of coal, refinery products, fertiliser, steel, and electricity moderated to 7.5 per cent, 2.9 per cent, 2 per cent, 4.8 per cent, and 3.8 per cent, respectively, against 10.9 per cent, 12.4 per cent, 3.3 per cent, 9.7 per cent and 5.8 per cent in November last year. However, cement output rose to 13 per cent in the month under review. The growth of core sectors -coal, crude oil, natural gas, refinery products, fertiliser, steel, cement and electricity -- was 4.2 per cent during April-November this fiscal. It was 8.7 per cent in the same period last fiscal. The eight core sectors contribute 40.27 per cent to the Index of Industrial Production (IIP), which measures overall industrial growth.

Angelina Jolie and Brad Pitt reach divorce settlement after 8 years

Angelina Jolie and Brad Pitt have reached a divorce settlement, apparently Angending one of the longest and most contentious divorces in Hollywood history. Jolie and Pitt signed off on a default declaration filed in Los Angeles Superior Court on Monday, saying they have entered into a written agreement on their marital and property rights. The settlement was first reported by People magazine.

"More than eight years ago, Angelina filed for divorce from Mr. Pitt," Jolie's attorney, James Simon, said in a statement. "She and the children left all of the properties they had shared with Mr. Pitt and since that time she has focused on finding peace and healing for their family. This is just one part of a long ongoing process that started eight years ago. Frankly, Angelina is exhausted, but she is relieved this one part is over."

The filing says they give up the right to any future spousal financial support, but gives no other details. A judge will need to sign off on the agreement. An email late Monday night to Pitt's attorney seeking comment was not immediately answered. Jolie, 49 and Pitt, 61, were among Hollywood's most prominent pairings for 12 years, two of them as a married couple. The Oscar winners have six children together. Jolie filed for divorce in 2016, after a private jet flight from Europe during which she said Pitt was abusive toward her and their children. The FBI and the Los Angeles County Department of Children and Family Services investigated Pitt's actions on the flight and deemed no action needed to be taken against him.

A judge in 2019 declared them divorced and single, but the splitting of assets and child custody needed to be separately settled. Soon after, a private judge that the two had hired to handle the case reached a decision that included equal custody of their children, but Jolie filed to have him removed from the case over an unreported conflict of interest. An appeals court agreed, the judge was removed, and the couple had to start the process over.

Anurag Kashyap on leaving Mumbai: 'I'm disgusted by my own industry'

Renowned filmmaker Anurag Kashyap, known for his grit-ty and groundbreaking films like *Gangs of Wasseypur*, has now opened up on his decision to leave Mumbai, citing growing discontent with the current state of the film industry. In a candid interview with The Hollywood Reporter India, Kashyap expressed his frustrations, pointing fingers at talent management agencies and the changing dynamics of filmmaking that, he believes, have stripped away the essence of his craft.

"The joy of filmmaking is sucked



out," Kashyap said. "Now it is difficult for me to go out and experiment as it comes at a cost, which makes my producers think about profit and margins. Right from the beginning, before the film starts, it becomes about how to sell it. That's why I want to move out of Mumbai next year. I am going to the South. I want to go where there is stimu-lation. Otherwise, I will die as an old man. I am so disappointed and disgusted by my own industry. I am disgusted by the mindset."

The filmmaker pointed out the escalating costs of filmmaking,

attributing the issue to rising salaries and profit-driven motives. "The mindset is to remake what's already worked," he remarked. "A film like *Manjummel Boys* would never be made in Hindi cinema but, if successful, would likely be remade in Hindi. They won't try anything new?

Kashyap reserved particular criticism for talent management agencies, accusing them of fostering a toxic culture that prioritises stardom over genuine acting talent. He said, "The first-generation actors and the really entitled ones are very painful

According to Kashyap, these agencies often exploit budding actors for profit, only to abandon them when they fail to deliver. "The onus of finding talent is on you-you have to take a risk and firefight with 50 people. And when the film is made, the agency grabs them and turns them into a star. They will brainwash them and tell


to workshops but to the gym—it's all glam-glam because they have to be massive stars," he explained. Sharing an incident to illustrate

the damaging practices of such agencies, Kashyap recounted how an actor, under the influence of his agency, disappeared but later returned seeking his guidance after being dropped by the same agency. "This is what the agency does—they just make money off you. They aren't invested in building new careers," he said.



"Oh, superstar. One of the best I have seen," Lehmann said quickly, before the question was finished. "He (Jaiswal) and Harry Brook are two next generation players. They are the ones that people will sit back and say they are good players. He played very well in



McDonald backs under-fire Marsh, remains optimistic about Starc's availablity for Sydney Test

Australia head coach Andrew McDonald conceded that Mitchell Marsh has fallen short of expectations with the bat against India but remained optimistic about Mitchell Starc's availability for the pivotal fifth Test in Sydney. Starc's fitness remains the

primary worry for the hosts after the pacer battled through sore ribs from day three of the Boxing Dav Test but still managed to bowl effectively, including claiming the prized wicket of Virat Kohli on the final day.

"Any time you get through the game, it's always a good indicator that you've a chance at the next game," McDonald told reporters after the hosts picked up memorable victory at the MCG to take a 2-1 lead in the series. "It didn't stop him (Starc). Clearly there was a little bit of discomfort early on in spells, but once he got warm it seemed as though he was pretty free. "We'll see how everyone

recovers. Bowling last, it was a pretty attritional game, pretty attritional game, something that we're not used to in the last few years. carrying "Clearly Starcy's something of some description. We'll assess that.

"But other than that, it looks as though we got through pretty unscathed, but (with a) short turnaround recovery important, and we'll assess what the team looks like in Sydney based upon the surface, as we always do."

Australia will regain the Border-Gavaskar trophy for the first time since 2014-15 if they win or draw the Sydney Test.

However, if India win the New Year's Test, they will retain the trophy, winning the series for a record-extending fifth-straight time.

Should Starc be unavailable for the series decider at his home ground, McDonald expressed confidence in Jhye Richardson or Sean Abbott stepping in to fill the void.

"Very confident. Richardson's



here for a reason. So if we weren't his exclusion. confident, he wouldn't be here. However, Mo He's had a heavy week with us in the nets. All indications are he'd

be capable of bowling 40-plus overs if he was called upon. "Sean Abbott's there as well. We feel like, [the] SCG is his home ground, so he will be serviceable if called upon as well. It'll be about assessing our frontline quicks and then making decisions from there."

Starc's fitness issues. compounded by his heavy workload alongside skipper Pat Cummins, have also drawn attention to the limited role of Mitch Marsh as a fifth bowler. Across four Tests, Australia's fifth bowling option Marsh has bowled only 33 overs, a statistic that underscores his

underutilization.

Marsh's contributions with the bat have been similarly underwhelming, with just 73 runs at an average of 10.42 across four Tests (6, 47, 9, 5, 2, 4, 0). These lackluster returns have sparked criticism and calls for

However, McDonald defended the all-rounder.

"He's in a good [head] space. Would you like better performances? There's no doubt about that. Over four Test matches, he hasn't been able to deliver at the level he would like and we would like."

"He's up and about though. We just won a Test match. No, there's no concern. And I think people have probably been reading too much into that.

"We haven't required him with the ball as often as what we would have thought. He bowled again today. There are no injury concerns there.

McDonald insisted that Marsh bowling just 33 overs is simply because the team didn't require him to roll his arm.

"I think to sort of head that down that angle is a little bit unfair. We just haven't required him at


