# I. Legislative Requirement

This document responds to direction set forth in the Infrastructure Investment and Jobs Act (IIJA) (P.L. 117-58, Div. J), which states:

## **Procurement, Construction, and Improvements**

For an additional amount for “Procurement, Construction, and Improvements”, \$429,000,000, to remain available until September 30, 2026: *Provided*, That of the funds made available under this heading in this Act--

(1) \$131,500,000 shall be for housing, family support, safety, and training facilities, as described in the Coast Guard Fiscal Year 2022 Unfunded Priorities List submitted to Congress on June 29, 2021;

(2) \$158,000,000 shall be for shore construction addressing facility deficiencies, as described in the Coast Guard Fiscal Year 2022 Unfunded Priorities List submitted to Congress on June 29, 2021;

(3) \$19,500,000 shall be for shore construction supporting operational assets and maritime commerce, as described in the Coast Guard Fiscal Year 2022 Unfunded Priorities List submitted to Congress on June 29, 2021; and

(4) \$120,000,000 shall be for construction and improvement of childcare development centers:

*Provided further*, That not later than 90 days after the date of enactment of this Act, the Department shall submit to the Committees on Appropriations and Commerce, Science, and Transportation of the Senate and the Committees on Appropriations and Transportation and Infrastructure in the House of Representatives a detailed expenditure plan, including a list of project locations under each paragraph in the preceding proviso: *Provided further*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 4112(a) of H. Con. Res. 71 (115th Congress), the concurrent resolution on the budget for fiscal year 2018, and to section 251(b) of the Balanced Budget and Emergency Deficit Control Act of 1985.

## II. Spend Plan

Table 1 reflects the Coast Guard’s plan for the \$429,000,000 provided in the IJA, including the necessary expenses related to shore construction addressing facility deficiencies; housing, family support, safety, and training facilities; and shore construction supporting operational assets and maritime commerce; as described in the Coast Guard’s Fiscal Year (FY) 2022 Unfunded Priorities List as submitted to Congress on June 29, 2021. Additionally, included in Table 1 is a list of construction and improvement projects for Coast Guard child development centers (CDC).

A portion of the funds for each project, summing to a total of \$1,072,500, will be transferred to the Office of the Inspector General of the Department of the Homeland Security for oversight pursuant to P.L. 117-58, Div. J, Title V, Sec. 501.
