1. Adoption of the draft agenda & minutes

The draft agenda and minutes from 19th July 2024 BDSG meeting were adopted as final. The BDSG meeting minutes are regularly published on the EMA website (<u>here</u>).

2. Draft report on social media data to support EU regulatory decision making

Pyry Eskelinen presented the draft report on Social Media Data exploring the potential utility of such data to support regulatory decision making. The report reviewed scientific literature through the Embase database. Findings were used to identify potential regulatory use-cases for social media data, as well as relevant challenges and opportunities related to their use. In addition, draft recommendations were proposed to the group for consideration and discussion.

The group welcomed the report and discussed the following:

- The report should be considered as an expert report (state of play report) and a careful consideration should also be given to how this report will be perceived publicly, i.e. that the report is a literature review and does not necessarily reflect the views of the BDSG.
- While not one of the proposed recommendation in the report, the group exchanged views on the value to use social media to communicate directly with patients and a possible role to combat misinformation.
- A dedicated discussion on the report findings with patients' representatives, e.g. PCWP should be considered in the future.
- All social media data should not be regarded in the same way as there are different categories of
 social media data (from commercial and quality perspectives) and hence different principles will
 apply to select a social media platform from which such data could potentially be used for evidence
 generation.
- In our current society, a vast amount of data is being shared/generated via social media A BDSG
 position should be established on the potential use of such data, considering their challenges, e.g.
 on data quality, ethical considerations, differences of social media platforms, compliance with data
 protection requirements etc.

Overall, the group noted the potential utility of certain social media data but also of significant hurdles and challenges to use such data.

The BDSG agreed to have a follow up discussion on the potential regulatory use cases and next steps at a next future meeting, pending further detailed comments on the report following the written consultation with BDSG.

BDSG did not support the use of the word 'recommendations', it is proposed to use instead 'points for consideration'.

Action: EMA to update the draft report to reposition the current recommendations as 'points for consideration'.

Action: BDSG members to provide written comments on the draft social media report by the end of September 2024.

Action: BDSG secretariat to schedule a follow up discussion and present the revised draft report.

3. EMRN computing capability survey results

Francois Domergue (EMA) presented the survey results, which was conducted in Spring 2024 to assess the existing demands and computing capabilities of the European Medicines Regulatory Network (EMRN) to analyse data. The questionnaire consisted of 14 questions and was circulated to all National Competent Authorities (NCAs) via IT Directors group and Heads of Medicines Agencies. It focused on human and veterinary data used for regulatory decision making and on the current technical computing capacities. The gathered information will complement future discussions on building a suitable and sustainable strategy of computing capacity within the EMRN.

The group welcomed the survey report and acknowledged that the survey responses showed an appetite within the EMRN for fostering data access and sharing between national agencies and developing analytics capabilities at EU level. The group also commented that BDSG might consider more work on analytics of quality and manufacturing and non clinical data in the future.

The feedback from this survey will be useful to inform the development of the new Network Data Steering Group workplan in 2025. Some of the recommendations/proposals, complementary to the Raw Data pilot report recommendations, will also be considered for the potential drafting of an EMRN data analytics strategy in 2025.

4. Overview of data training offering for the network and next steps

Not discussed. The topic was postponed to the next BDSG meeting on 4 October 2024.
