We have both suitable firewalls in place to protect direct access to our servers, and frequently apply security updates and patches.

Our servers are Linux based and as such are not susceptible to the recent WannaCry ransomware which targets older Windows based systems.

We are dedicated to maintaining secure and resilient networks and services.



REF Compliance Checker and Reporting


By popular demand, we've been working on better supporting REF Compliance reporting.

The latest updates to the Reporting plugin introduce new, more flexible report generating (allowing for school level reports for example), choosing which fields get

included in report exports, and more granular levels of reporting on outputs.

Taking advantage of these features is the latest version of the REF CC plugin, with its new traffic light system for helping to identify different levels of REF compliance.

Our roll-out plan to customers is the 3rd quarter of this year.



Community outreach

As part of our work with the broader EPrints Community we are inviting active members to help co-ordinate the development of the public EPrints releases.

Collaborating with Google

We have been collaborating with the Google Scholar team to ensure that your EPrints repositories are indexed and catalogued by Google Scholar correctly. Earlier in the year we applied some changes to a number of pilot repositories, in

line with our discussions with Google. The pilot has proven to be a success, and we are now happy to roll out the changes to any of our customers repositories.

EPrints 3.4

We are continuing with 3.4 development, and initiating plans for upgrades and rollouts for hosted customers. New features are being curated, such as - new visualisation tools, bookmarks & collections, a more flexible user interface. As well as further support for repositories outside the publications domain.
