

#### Solid Waste Management Programs

**MISSION** - To protect the public interest through solid waste management planning and regulatory oversight of the county's refuse ordinances. We provide efficient and effective collection, recycling, and disposal of solid waste for our customers in an environmentally responsible manner.

**Solid Waste Management Program** is responsible for managing the collection, recycling, and disposal of the more than 1.4 million tons of trash and recyclables generated in Fairfax County each year. Solid Waste Management has implemented programs that allow the county's recycling rate to far exceed state requirements. Most non-recyclable waste is used to produce electricity at a waste-to-energy facility in Lorton. Landfill gas, generated from the county's two closed landfill sites, is collected and utilized as an alternative heating fuel and energy source.

**Environmentally Sustainable Design** is the process of design and construction of objects, including buildings, that places special consideration on reducing the negative impact on the environment. In building projects, the emphasis is placed on optimizing the building performance, thereby contributing positively to the health and comfort of the building occupants and minimizing the environmental impact. The basic objectives of sustainability in both vertical and horizontal construction projects are to reduce carbon emissions, reduce consumption of non-renewable resources, minimize waste, create healthy and productive environments, and comply with the principles of social, economic, and ecological sustainability.

In February 2008, the Fairfax County Board of Supervisors (BOS) adopted a Sustainable Development Policy (Policy) for county capital facilities projects. The Policy established the Leadership in Energy and Environmental Design (LEED©) program and rating system administered by the US Green Building Council (USGBC), as the standard for the design, construction, renovation, and operation of county facilities. Applicable to building development projects undertaken by Fairfax County, the Policy demonstrated the commitment to environmental, economic, and social stewardship through sustainable development practices. The Policy set the goal of LEED© Silver Certification level for projects over 10,000 square feet and established LEED© Certification Level as a goal for projects between 2,500 to 10,000 SF. Since the adoption of the 2008 Policy, the county has made great progress in all areas of sustainability and has exceeded the Policy goals with over 43 LEED© certified buildings, 18 of which are Gold Certified Projects, and one Platinum Certified Project.

In September 2020, the Board adopted an updated policy which further strengthened the sustainability goals by increasing the minimum LEED certification target to Gold, encouraging solar and electric vehicle (EV)-readiness components, and emphasizing renewable energy with either on-site generation or supplemental off-site generation. In addition, the 2020 policy set incremental energy performance improvement and Greenhouse Gas (GHG) emissions reduction targets, with a goal of transitioning to Net Zero Energy (NZE) eligibility by no later than FY 2031.

In July 2021, following its adoption of the Carbon Neutral Counties Declaration, the board further strengthened its green building policy as part of its adoption of the 2021 Operational Energy Strategy. The 2021 policy retains the requirement of LEED Gold from the 2020 update but replaces the minimum energy performance improvement criteria and multi-year transition to NZE with an NZE standard for new construction and major renovations and provisions regarding building electrification.

In addition, the 2021 green building policy reiterates the commitment to an ongoing program for monitoring and analysis of actual building energy performance data; identifying existing buildings as priority candidates for systems recommissioning; recommissioning of priority buildings with initial focus on buildings previously certified by LEED; and for more proactive management of building systems and controls. This commitment helps ensure that new and renovated buildings or facilities perform as intended, designed, and constructed.

As the lead agency for the implementation of the Capital Improvement Program in the county, DPWES continues to apply the Policy and the principles in building,

stormwater, and wastewater projects and programs. DPWES is working in close collaboration with the Office of Environmental and Energy Coordination to implement approved updates to the Operational Energy Strategy which strengthen the Policy criteria and is committed to continue our implementation of the Board's Environmental Agenda through creative, cost-effective solutions.

#### **CAPITAL FACILITIES**

Capital Facilities applies sustainable design and construction principles and strategies in the development of capital projects. The County's green building policy is intended to reduce the consumption of non-renewable resources, reduce greenhouse gas emissions, minimize waste, and foster healthy, productive environments. Capital Facilities implements a variety of strategies across different aspects of its projects.

Site strategies include reducing parking footprint to minimize environmental impacts and evaluating alternate transportation options and parking reduction during project site design. Low Impact Development (LID) and green infrastructure techniques are employed to reduce rainwater runoff volume and enhance water quality, replicating natural hydrology. Early design analysis includes strategies like bioswales, dry ponds, and infiltration trenches to surpass minimum code requirements for stormwater management.

Strategies to reduce energy demand include setting design and energy goals, appropriate building sizing, utilizing passive design opportunities, optimizing the building envelope, and implementing advanced energy metering for real-time consumption data. Efforts for energy efficiency involve installing high-performance building systems, specifying Energy Star Certified appliances, utilizing energy simulation software, and monitoring and verifying building performance through commissioning. Renewable energy initiatives aim to analyze projects for solar feasibility and maximize solar panel installation. Post-occupancy, continuous and retro commissioning ensures performance alignment and promotes energy-efficient practices among occupants.

Water conservation strategies, evaluated early in the design process, include specifying low-flow fixtures for showers, toilets, and faucets. Rainwater harvesting feasibility is assessed for non-potable uses like irrigation. Wastewater reuse strategies are considered for projects in early design stages. Projects adhere to the County's natural landscaping policy, aiming to minimize resource consumption, reduce stormwater runoff, enhance habitat value, and improve soil and plant health. The use of natural landscaping and native species reduces the need for irrigation, and early feasibility studies for green roofs are integrated into each project scope to minimize HVAC costs and reduce heat island effect and stormwater runoff.

Green buildings prioritize indoor environmental quality, benefiting occupants' health, comfort, and overall well-being. Guidelines mandate the use of low volatile organic compound (VOC) products. Green cleaning practices, employing eco-friendly products, aim to minimize negative impacts and protect employees' health. All new projects prioritize optimizing natural daylighting strategies to enhance indoor lighting quality, contributing to increased productivity and reduced absenteeism while enhancing overall building value.

#### SUSTAINABLE DEVELOPMENT PROGRAM

Sustainably produced materials and waste management strategies are embraced for minimizing embodied energy and reducing environmental impacts throughout the building lifecycle. Project requirements prioritize locally sourced materials, and project teams are tasked with implementing waste management plans to minimize landfill and incineration disposal by recovering, reusing, and recycling materials.

All qualifying projects are registered with the US Green Building Council (USGBC) for certification under the LEED© rating system at the early phases of building design. Since the inception of the sustainability program, 43 capital projects have received certifications shown below:

- LEED© certifications by USGBC Total of 43 projects

- ENERGY STAR rated 1
- Green Building Initiative, Green Globes Program- 2

In addition to the LEED© program, Capital Facilities is pursuing multiple additional **sustainability initiatives**, that demonstrate positive energy and environmental impact. These include the following:

#### • Envision Sustainable Infrastructure Rating System


The Envision sustainable infrastructure rating system by Institute for Sustainable Infrastructure, assesses sustainability in the categories of Quality of Life, Leadership, Natural World, Resource Allocation, and Climate and Resilience. Meeting requirements in these key areas contribute to positive social, economic and environmental impacts on a community during the planning, design and construction of infrastructure projects.

To support implementation of county sustainability goals Capital Facilities advocates staff training and certification, and there are forty (40) LEED© and/or Envision trained and certified staff to facilitate and manage these programs.

#### Parksmart Certification Program

Parksmart certification program defines, measures, and recognizes highperforming, sustainable garages, encouraging innovative, solutions- oriented strategies in the design, construction and operations of parking garages and structures.

These initiatives, together with the LEED© program, promote sustainable practices that benefit the community and our built environment.

#### **INTRODUCTION**

The construction projects contained in this report have been substantially completed in FY 2024. Substantial completion means that the facility can be utilized by the agency for which it was constructed even though some minor work may remain or the project is still in the warranty period. The majority of expenditures are included for the projects, but as warranty and final work is completed, there may be additional expenditures processed after this publication.

During FY 2024, DPWES administered numerous A/E and construction contracts, directed miscellaneous construction service contracts awarded by the Department of Procurement and Material Management, and monitored 12 construction funds with FY 2023 appropriations of \$553,481,702.

Detailed project information including scope and cost can be found in this section. The cost breakdown for each project is identified in five major categories:

#### **Land Acquisition:**

Land acquisition and dedication, permanent and temporary easements, right-of-way, land preparation, other land-related costs: land appraisal, legal fees, title, advertisement, and Work Performed for Others for Land Acquisition staff.

#### Design:

Outside consultant costs for architecture and engineering, geotechnical, and Work Performed for Others (staff charges) during design phase.

#### Permits/Fees:

Costs of inspections and all permits required for construction.

#### **Construction:**

Bid amount, change orders, IT costs, temporary facilities costs including lease cost of land, Work Performed for Others (DPWES staff only – not consultant costs; those are typically in "design" as part of the overall A/E contract), legal fees related to construction, and other construction-related costs including survey, demolition costs, and furniture/equipment.

#### **Utilities:**

Utility costs associated with the project construction, paid to utility companies for service on relocation as needed.
