Thus, the Board has authority to sell the property to certain entities, pursuant to the provisions of O.R.C. §3313.41(C); and

WHEREAS, the Harrison County Commissioners, one of the entities listed on O.R.C. §3313.41(C) has expressed interest in purchasing such real estate; and

WHEREAS, the Board now desires to sell said real property to the Harrison County Commissioners pursuant to O.R.C §3313.41(C);

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Harrison Hills City School District, Harrison County, Ohio, that:

Section 1: The Board hereby authorizes the sale of the property referred to above to the Village of Cadiz at a private sale pursuant to and in accordance with the provisions of O.R.C §3313.41(C) for a purchase price to be negotiated by the parties.

Section 2: The Board does hereby authorize and direct the President, Superintendent and the Treasurer of the Board to negotiate a Purchase Agreement and to do all other things necessary in order to accomplish the sale of such real estate, subject to the reservation of mineral rights and the right to remove the same.

Section 3: The proceeds from the sale of the property shall be paid into the permanent improvement fund in accordance with O.R.C. §5705.10.

Section 4: It is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were done in an open meeting of this Board and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public, or otherwise in compliance with all legal requirements.


Items presented by Board Members
