Note from the Executive Director

Recently, the IHSA requested the support of our membership as we navigated the challenges of state legislation proposing to significantly modify the transfer eligibility of students attending IHSA schools. HB 334 was written to establish immediate eligibility for all transfer students as soon as they were enrolled and attending a member high school. The bill would have dismantled current transfer eligibility rules that member schools have agreed to, which encourage students to start and finish their high school years at the same high school. As I have spoken with legislators and received correspondence from high school administrators, coaches, and officials, it is evident that the support of our membership was heard.

The house bill has not been considered for approval on the house floor to date. We will continue to monitor any future progress of the bill and inform the membership of any additional potential impacts on the transfer eligibility of students or other forms of legislation.

We recognize that attitudes on transferring may be changing, likely in part due to the trickle-down affect of NIL and the transfer portal at the collegiate level. As a result, changes to the IHSA transfer by-laws may need to occur. That said, I believe in the system that we have in place for IHSA member schools to originate changes via our annual legislative process, and staunchly oppose any IHSA by-law changes being precipitated by non-members.

The IHSA Staff and Board of Directors thank you for your support in communicating with state legislators your concerns. The Association's strength is built upon the foundation of self-governance by its member schools in writing and voting on by-law amendment proposals. We are thankful for your support and look forward to collaborating on future changes that are best for the Association.

By-Law Breakdown – 3.022: Scholastic Standing

As the end of the 2023-2024 school year draws near, this month's By-Law focus is on scholastic standing for semester eligibility. School administrators should remind students and parents that academic standing at the end of this current spring semester has an impact on eligibility next fall.

Per By-law 3.022, unless entering high school for the first time, a student must have earned 25 credit hours from the previous semester. Credits must have been earned in the semester for which credit is granted or in a summer school program that has been approved by the local Board of Education. Credits earned in summer school must count toward graduation.

A student who has not earned 25 credit hours this spring and/or summer will not be eligible for the entire first semester of the 2024-2025 school year, which includes the entire fall season and start of the winter season.

Officials' Licensing – The Drive for 500

Registration for officials' licensing opened on May 1st.

The IHSA is launching perhaps its most aggressive program in a number of years. The Drive for 500 is the IHSA's goal of licensing at least 500 flag football officials for its inaugural season, which begins in August of 2024. All licenses are one-year in nature. Anyone who was licensed for the 2023-2024 school year must apply for a new license for the 2024-2025 school year. The base registration fee is \$80 and allows an individual to apply for up to two licenses. Each additional sport is \$15 per license.

Individuals who register by May 31st will receive an early registration discount of \$10 resulting in a fee of \$70 for the first sport, \$0 for the second sport, and \$15 for each additional sport.
