<i>1—Article 92—Failure to Obey General order or regulation</i>	SrA	Reduction to E-2, Restriction to JBSA-Lackland for 20 days and a reprimand
<i>1—Article 92—Failure to Obey General order or regulation</i>	A1C	Reduction to E-2, Restriction to JBSA-Lackland for 30 days and a reprimand
<i>1—Article 86—Failure to Go to Place of Duty</i>	A1C	Reduction to E-2, Restriction to JBSA-Lackland for 20 days and a reprimand
<i>1—Article 112a—Drug Offense; Wrongful use of Sched I, II, or III</i>	SrA	Reduction to E-3, forfeitures of \$1,273 pay per month for 2 months (suspended), and a reprimand
<i>1—Article 92—Dereliction of Duty; Willful</i>	4 x A1Cs	Forfeitures of \$1,129 pay per month for 2 months (1 month suspended), and a reprimand
<i>1—Article 92—Dereliction of Duty; Willful</i>	6 x ABs	Forfeitures of \$958 pay per month for 2 months (1 month suspended), and a reprimand
<i>1—Article 121—Larceny; Non-Military Property—\$1000 or less</i>	A1C	Reduction to E-2 (suspended), forfeitures of \$1,074 pay per month for 1 month (suspended), and a reprimand
<i>1—Article 92— Dereliction of Duty; Willful</i>	AB	Forfeitures of \$958 pay per month for 2 months, and a reprimand
<i>1—Dereliction of Duty; Willful</i>	Amn	Forfeitures of \$1,074 pay per month for 2 months (1 month suspended), and a reprimand
<i>1—Article 121—Larceny; Non-Military Property—\$1000 or less</i>	AB	Forfeitures of \$758 pay per month for 2 months (1 month suspended), and a reprimand
<i>1—Article 93—Prohibited Activities with Military Recruit or Trainee by Person in Position of Special Trust</i>	Capt	Forfeitures of \$3,390 pay per months for 1 month, and a reprimand

*UCMJ Art. 15 allows for Commanding officers to offer non-judicial punishment in lieu of trial by court-martial, for violations of the UCMJ. If the forum is accepted by the member, the commander may impose punishment should they determine an offense under the UCMJ was committed by the member.*
