

Citations and References 7th Edition APA Manual: Single and Multiple Authors

No author: Use the article title as author; do not use “anonymous” as author unless the document is SIGNED “Anonymous”. Note that, when the title of an article, chapter, or webpage is used in the absence of an author, **quotation marks are placed around the title in the parenthetical citation.**

Parenthetical in-text citation for three or more authors:

For all citations list the first author followed by "et al." (see examples below)

Ex: (White et al., 2008).

Ex: (Concannon et al., 2010).

Twenty-one authors or more: *List the first nineteen authors, insert three ellipsis periods, and add the last author's name.*

Reference to a chapter in an edited book: *Chapter author's name is inverted; editor's/editors' name(s) is not inverted; for more than one editor use (Eds.). Page numbers are included.*

Carson, J. (2005). Diabetes and cancer; Treatment options. In C. M. Dodge (Ed.), *Current cancer research* (pp. 255-275). Nova Biomedical Books.

Parenthetical in-text citation: (Carson, 2007).

Reference to an edited book: *Editor(s) in author position with name inverted; for more than one editor use (Eds.)*

Roden, M. (Ed.). (2007). *Clinical diabetes research: Methods and techniques*. Wiley-Blackwell.

Parenthetical in-text citation: (Roden, 2007).

Websites, Audiovisual Media, Social Media: The 7th edition of the APA Manual has too many variations to list here. It is best to consult section 10.16 in the APA Manual. Basic formats are below.

Website with author:

Collazo-Carroll, M. (2010, May 22). *Could switching to a vegetarian diet cure my diabetes?*.

Website without author: Use the name of the publisher/sponsor of the webpage.

Online media (tweets, Facebook, Instagram, online forum posts): See section 10.15 in the APA Manual.
