



## PRIVACY STATEMENT

We are committed to handling personal information with due care and in compliance with relevant data protection regulations. In this privacy statement, “we” refers to LLV Fund Management Oy, Lifeline Ventures Fund Management Oy, and the Funds managed by the mentioned management companies.

The privacy statement explains the purposes of handling personal information and specifies the recipients of such information. In addition, it outlines what rights you have regarding your own personal information.

### **Information handling and purpose**

We collect and handle our customers’ personal information to manage and develop the business and fulfill our contractual and legal obligations. The customers consist of investors, portfolio companies of the funds, and other potential investors or investee companies. This privacy statement concerns the natural persons representing or working for the aforementioned.

In addition, employee information and employee candidate information are handled.

### **Recipients of personal information**

Our policy is to disclose personal information to third parties only if it is necessary, either due to legislation or authorities.

In addition, we have established agreements with certain service providers allowing them to process personal data on our behalf. In such cases, we have agreements in place with the service providers to ensure that the information is properly and safely handled.

### **Data processing in third countries**

We utilize certain tools provided by service providers located outside of Finland e.g. Atominvest and Google Workspace. For these service providers an adequate level of data protection is ensured through contracts.

### **Data protection and information storage period**

The access to the information is restricted to individuals for whom the access is necessary.



The information is retained only for the duration necessary for business operations and as mandated by applicable legislation. The length of the storage period varies depending on the type of information.

## **Cookies**

Our website utilizes functional cookies designed to optimize site functionality, such as storing language preferences. These session cookies are temporarily stored on your device during your site visit and are automatically removed once you close your browser.

## **Your rights concerning personal information**

As a customer, you possess the privilege to request access to a copy of the personal information we retain about you, including details on any information disclosed to third-party service providers. For the request we might ask you to confirm your identity.

You are permitted to inform us if you believe that retaining certain information is irrelevant to our operations or if any of the information is incorrect.

You have the right to object to the processing of your information at any time. If seems that there are no legitimate reasons for processing your personal data, we will cease processing your information accordingly.

You have the right to request us to remove your personal information when it is no longer required for us to fulfill contractual, legal, or other obligations. If such a case arises, the information will be promptly removed.

You can withdraw or restrict your consent to marketing or the processing of your personal information completely or partially, where it is no longer required.

Please do not hesitate to complain if you believe we have mishandled your information or violated your rights as outlined in the data protection law.
