2020 LEGISLATIVE REPORT

INTRODUCTION

This Legislative Report includes:

Descriptions of key votes: Numbered explanations of votes taken in the Senate and the House include the action voted on (motion, amendment, passage, etc.), together with the Minnesota AFL-CIO’s position, the vote outcome and vote totals.

Tables showing key 2020 votes: Grids show whether legislators supported or opposed working people with their votes. The numbered columns in the tables correspond to the numbered votes for the appropriate legislative body.

Definition of right and wrong votes: A legislator’s vote is recorded as “Right” (R), supporting the Minnesota AFL-CIO position, or “Wrong” (W), opposing the Minnesota AFL-CIO position. If the legislator was absent or did not vote, “Not Voting” (NV) is recorded.

Lifetime Voting Records: The Minnesota AFL-CIO Lifetime Voting Records of current members of the House and Senate are included on the House and Senate grids in the far right column. Only actual “R” or “W” are counted in calculating the percentage. “NV”s are not used in calculating the percentage.

Notes on how votes are selected to this report: The votes chosen were based on one or more of the following factors. The five factors are: 1) Long standing labor principles; 2) Minnesota State Convention Resolutions; 3) Minnesota AFL-CIO Executive and General Board positions/resolutions; 4) Legislative Priorities (page 2); and 5) issues that arise during the legislative session, for which one or more affiliate unions request assistance,

Votes have been selected for their accuracy as a gauge of legislators’ views. Wide-margin votes are avoided, unless they fit one of the five factors above and there are no other significant votes available on an important issue. The legislature often makes critical decisions about the content of legislation through votes on amendments or procedural motions. These votes frequently reveal a legislator’s position on an important issue more clearly than lopsided votes on a bill’s final passage.

Sources: Information sources used to compile this record include the journals of the Minnesota House and Senate, the text of bills, the publications Session Weekly and Session Briefly, and information provided by affiliates.

2020 PRIORITIES

The Minnesota AFL-CIO represents the shared voice, values, and priorities of our state's Labor Movement. We believe that no matter where we come from, what we look like, or how we pray; all working people deserve the dignity of a safe job with family sustaining wages; the security of affordable healthcare; and the freedom to care for ourselves and our loved ones without facing hardship. These are the values our Labor Movement strives for – not just for union members, but for all working people. Our key priorities for the 2020 Legislative Session reflected these values.

Jobs & Projects Investment

Local communities & public institutions have identified more than \$5 billion in needed construction projects throughout the state. We can create tens of thousands of family sustaining jobs by making a significant investment in our public infrastructure.

Paid Family & Medical Leave

Most working people don't have the freedom to take paid leave to care for themselves or their families. That's why we're co-chairing the Minnesotans for Paid Family & Medical Leave Coalition. Our legislation would provide partial wage replacement for up to 12 weeks of leave and be funded by a small premium split between employers & employees - less than \$2 per week.

Tax Fairness

Progressive taxation, smart budgeting, and wise investments continues to keep Minnesota on strong fiscal ground. Despite regular budget surpluses, lawmakers should resist any attempts to cut taxes for big corporations and the wealthy few. Instead Legislators should consider rolling back the irresponsible corporate tax giveaways in last year's federal tax conformity legislation.

Affordable Healthcare

All working people deserve the dignity of affordable healthcare for themselves & their families. We support policies that will extend affordable and accessible healthcare options such

as making MinnesotaCare a public insurance option on MNSure & holding pharma and insurance companies accountable for exorbitant prescription drug costs.

Raise Labor Standards

In Minnesota, we believe in a level playing field & that everyone should earn a fair return on their work. However, some of our labor standards don't reflect our values. It's time to raise standards for all workers by ensuring the 40-hour work week applies to every worker; stopping employers from fraudulently classifying employees as independent contractors; and, protecting Minnesota's gold standard OSHA program by conforming to federal penalties.

Freedom to Drive

There are approximately 95,000 Minnesotans without a pathway to citizenship. That means these community members do not have access to driver's licenses in the state. By extending the opportunity to earn a driver's license to all Minnesotans regardless of immigration status, we can improve public safety for everyone, grow economic prosperity, and promote community building for all.

Emergency Priorities

When Governor Walz declared a statewide emergency due to the COVID-19 pandemic, the Minnesota AFL-CIO released an emergency set of legislative priorities to protect workers during the pandemic. The subsequent special sessions gave legislators an opportunity to act. The emergency priorities included **Protecting Frontline Workers' Health, Wage Support, Paychecks for Hourly School District Workers, Emergency Paid Time Off, Emergency Bonding, and Maintaining Labor Standards through the Crisis.**

Following George Floyd's murder at the hands of law enforcement, the Minnesota AFL-CIO General Board endorsed the **People of Color and Indigenous (POCI) Caucus' plan for police accountability and reform.**

SENATE VOTE DESCRIPTIONS

1. Prescription Drug Price Transparency

*Senate File 1098 – Passage (April 20, 2020/
Senate Journal Page 5810)*

HF1246/SF1098 – authored by Rep. Kelly Morrison (DFL – Deephaven) and Sen. Julie Rosen (R – Vernon Center) – required drug manufacturers to publicly disclose certain information on drug prices and costs for prescription drugs whose price increases exceed certain limits, and for new prescription drugs and newly acquired prescription drugs whose price exceeds certain dollar amounts.

Minnesota AFL-CIO Position: **Support Passage**

Correct Vote: **Aye**

Final Vote: **Passed 63 Ayes, 2 Nays**

End Result: **Signed into law.**

2. Reopening Unsafely

Senate File 4511 – Passage (May 11, 2020/

Senate Journal Page 6462)

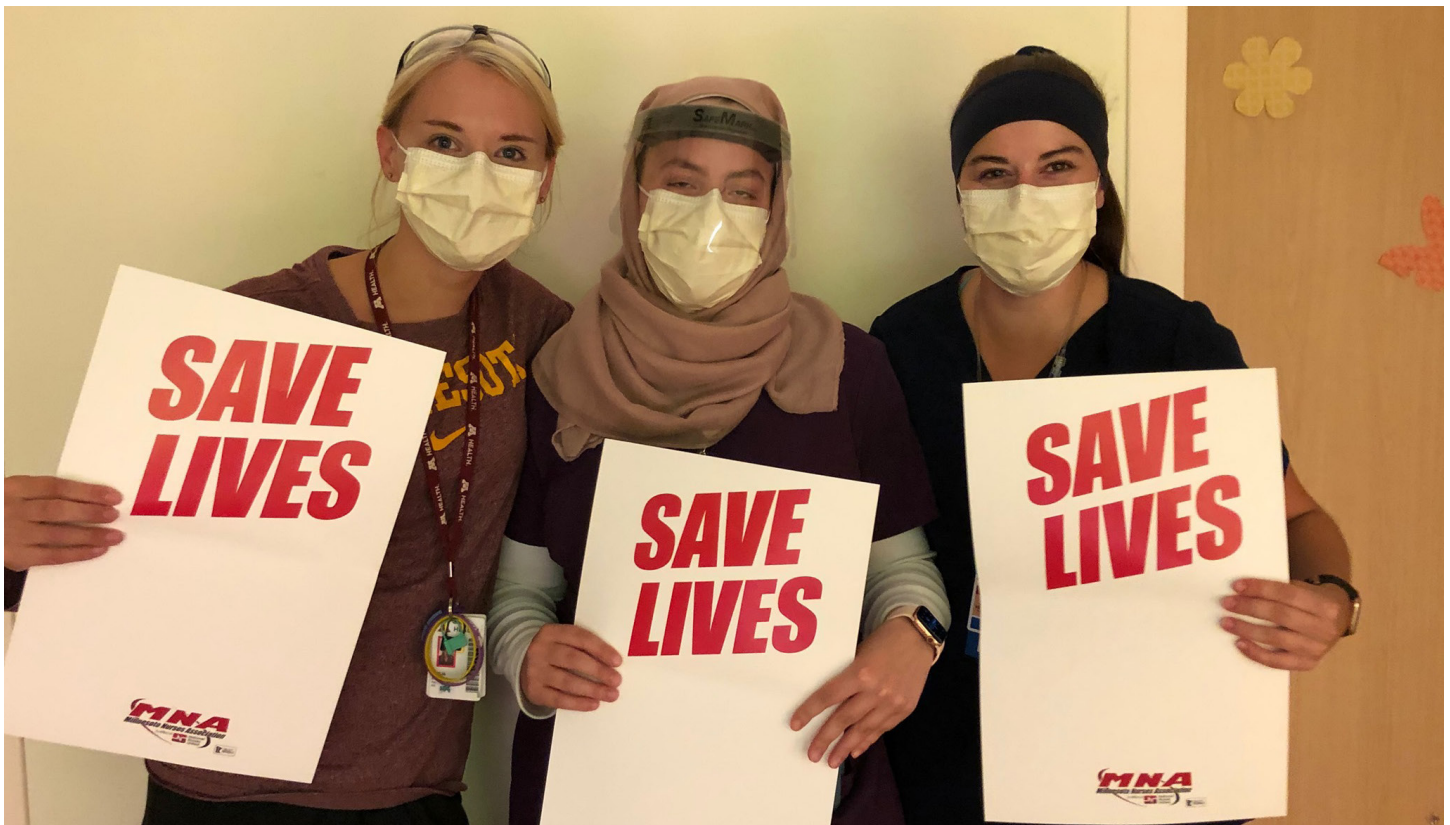
SF4511 – authored by Sen. Andrew Mathews (R – Milaca) – allowed bars, restaurants, and other places of public accommodation to reopen notwithstanding the Governor’s executive orders and without a plan to ensure the safety of workers, without consulting workers, without training workers on any safety plan, without requiring documentation, without protecting workers from retaliation for voicing safety concerns, and without adequate oversight or enforcement of worker safety. A Mathews amendment to require businesses to develop COVID-19 preparedness plans was added to the bill, but this was inadequate to address worker safety and protection.

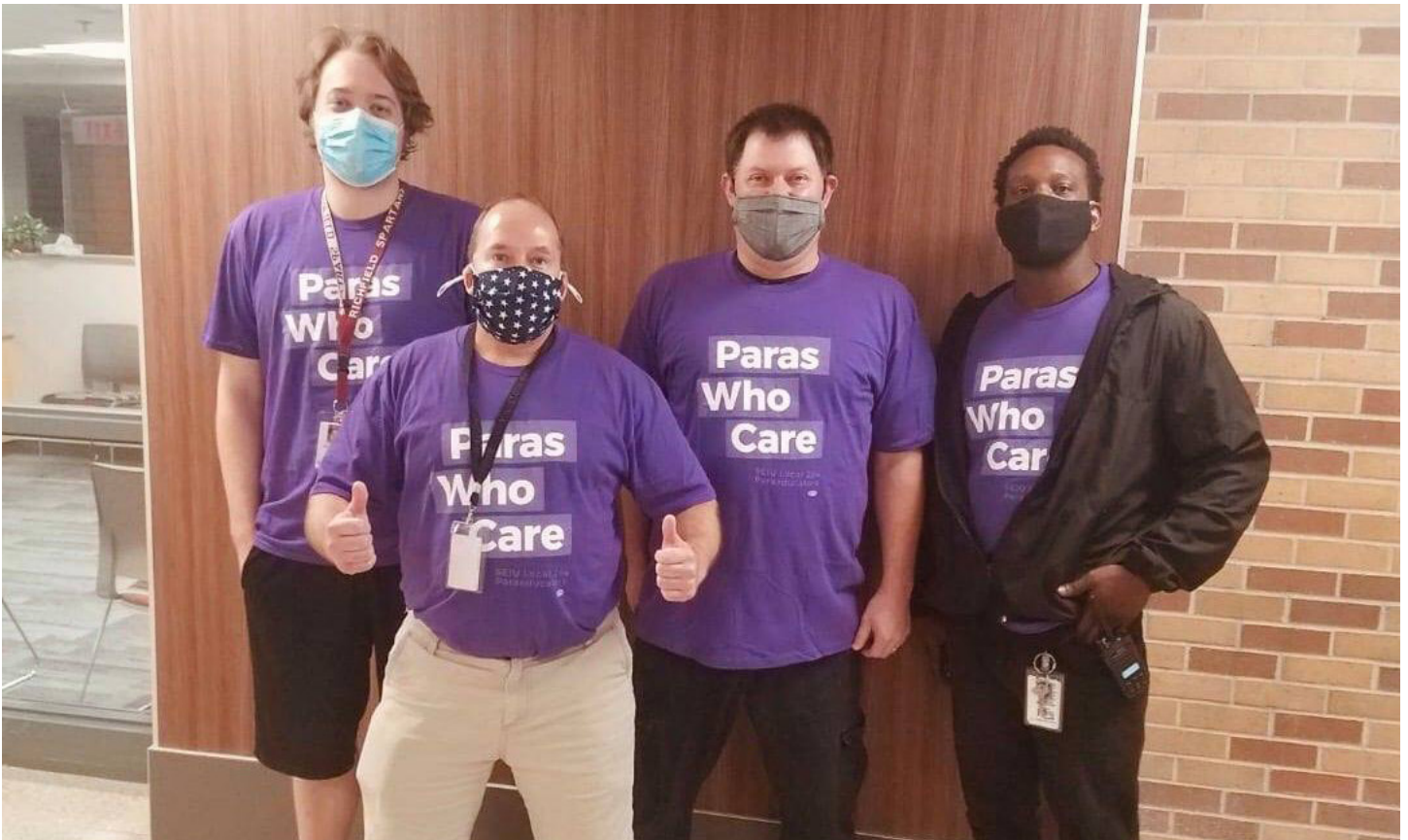

End Result: **Did not become law.**





3. Paychecks for Hourly School Workers

House File 4415 – Nelson Amendment (May 16, 2020/Senate Journal Page 7170)

HF4415/SF4369 – authored by Rep. Jim Davnie (DFL – Minneapolis) and Sen. Carla Nelson (R – Rochester) required school districts to retain and pay hourly employees and contractors during closures related to COVID-19. These essential workers include paraprofessionals, school bus drivers, food service workers, office staff, maintenance workers, and more.

Sen. Carla Nelson (R – Rochester) – offered an amendment to strip the hourly workers provision from the bill.

Minnesota AFL-CIO Position: **Oppose Amendment**

Correct Vote: **Nay**

Final Vote on Amendment: **Passed 35 Ayes and 32 Nays**

End Result: **Did not become law.**

4. Interfering with State Employee Contracts

House File 2796 – Passage (May 16, 2020/ Senate Journal Page 7252)

HF2796/SF2770 – authored by Rep. Leon Lillie (DFL – North St. Paul) and Sen. Mark Koran (R – North Branch) – ratified state employee contracts. The Senate took up a version amended by the Finance Committee that attempted to remove the second year pay increases in the contract. They also adopted a Koran amendment to make ratification contingent on MMB forecasting a budget surplus for the current biennium.

AFL-CIO Position: **Oppose Passage**
Correct Vote: **Nay**

Final Vote on Amendment: **Prevailed 34 Ayes and 33 Nays**

End Result: **The contracts were ultimately ratified.**

5. Terminating the Peacetime Emergency

Senate Concurrent Resolution No. 1 (July 13, 2020/Senate Journal Page 6 – Special Session)

Majority Leader Paul Gazelka (R- Nisswa) offered a resolution to terminate Minnesota's peacetime emergency. This resolution would end the Governor's emergency powers and executive orders, including Executive Order 20-54, Protecting Workers from Unsafe Working Conditions and Retaliation During the COVID-19 Peacetime Emergency. Similar resolutions were offered at nearly every subsequent Special Session in 2020.

Minnesota AFL-CIO Position: **Oppose Passage**

Correct Vote: **Nay**

Final Vote: **Passed 36 Ayes and 31 Nays**

End Result: **Did not take effect.**

6. Police Accountability and Reform

*House File 1 – **Passage** (July 20, 2020/Senate Journal Page 46 – Second Special Session)*

HF1/SF37 – authored by Rep. Carlos Mariani (DFL – St. Paul) and Sen. Warren Limmer (R – Maple Grove) – contained a number of police reforms, including: more effective training on mental health and crisis intervention; tools to cope with trauma; data collection on officer misconduct and use of deadly force; a ban on the use of chokeholds in most situations; a requirement for officers to intervene when another officer is using excessive force; changes to the grievance arbitration process for police officers; and more community input on policing policies and practices.

Minnesota AFL-CIO Position: **Support Passage**

Correct Vote: **Aye**

Final Vote: **Passed 60 Ayes, 7 Nays**

End Result: **Signed into law.**



7. Confirmation of DLI Commissioner Nancy Leppink

Gazelka Motion on confirmation of DLI Commissioner Nancy Leppink (August 12, 2020/Senate Journal Page 17 – Third Special Session)

Without any warning, Majority Leader Paul Gazelka (R – Nisswa) brought up the confirmation of Department of Labor and Industry Commissioner Nancy Leppink, the most qualified person to ever lead the Department of Labor and Industry. She crafted the strongest anti-wage theft law in the nation and worked to make sure employers were in compliance; brought labor and business together to ensure healthcare workers and first responders qualify for workers compensation if they contract COVID-19; provided workers and employers the support they needed to reopen workplaces as safely as possible; and made sure workers were protected from retaliation for reporting unsafe working conditions in the COVID-19 pandemic.

Final Vote: **Failed 34 Nays, 32 Ayes**

End Result: **Commissioner Leppink was removed.**

8. Capital Investment, Tax, and Finance Bill

House File 1 – Passage (October 15, 2020 – Fifth Special Session)

HF1 – authored by Rep. Mary Murphy (DFL – Hermantown) and Sen. David Senjem (R – Rochester) – addressed Minnesota’s jobs and infrastructure needs by making investments in clean water, a healthy environment, and roads and bridges. It totaled \$1.87 billion, including \$1.35 billion in general obligation bonds; \$300 million in trunk highway bonds; and \$100 million for housing. The bill included a tax break for farmers and small businesses. It also provided for \$31 million in supplemental General Fund spending, including costs to state agencies responding to civil unrest; funding to keep the Togo and Willow River correctional facilities open; and \$13 million for a temporary rate increase for personal care assistants during the pandemic.

HOUSE VOTE DESCRIPTIONS

1. Paid Family and Medical Leave

House File 5 – Passage (March 5, 2020/House Journal Page 6853)

HF5 – authored by Rep. Laurie Halverson (DFL – Eagan) – created a statewide program to provide partial wage replacement for up to 12 weeks of leave for working people to care for their own or a loved one’s medical condition or to bond with a new child. The program would be funded with a small premium split between employers and employees – less than \$2 per week.

Minnesota AFL-CIO Position: **Support Passage**

Correct Vote: **Aye**

Final Vote on Amendment: **Passed 70 Ayes and 59 Nays**

End Result: **Did not become law.**

2. Workers’ Compensation for COVID-19 – Presumption for First Responders and Healthcare Workers

House File 4537 – Passage (April 7, 2020/House Journal Page 7115)

HF4537/SF4458 – authored by Rep. Dan Wolgamott (DFL – St. Cloud) and Sen. Jeff Howe (R – Rockville) – provided workers’ compensation

coverage for first responders, healthcare workers, and assistive employees in health care, home care, or long-term care settings who contract COVID-19 by presuming they contracted it on the job.

Minnesota AFL-CIO Position: **Support Passage**

Final Vote: **Passed 130 Ayes and 4 Nays**

End Result: **Signed into law.**

3. Paychecks for Hourly School Workers

House File 4415 – Passage (May 4, 2020/House Journal Page 7946)

HF4415 – authored by Rep. Jim Davnie (DFL – Minneapolis) required school districts to retain and pay hourly employees and contractors during closures related to COVID-19. These essential workers include paraprofessionals, school bus drivers, food service workers, office staff, maintenance workers and more.

Minnesota AFL-CIO Position: **Support Passage**

Correct Vote: **Aye**

Final Vote: **Passed 83 Ayes and 49 Nays**

End Result: **Did not become law.**





4. COVID-19 Economic Security Act

House File 1507 – Passage (May 7, 2020/House Journal Page 8259)

HF1507 – authored by Rep. Zack Stephenson (DFL – Coon Rapids) – contained a number of provisions to help provide economic security for Minnesotans affected by the pandemic, including emergency funding for housing, small businesses, distance learning, and telemedicine. Among the provisions was a 15% temporary emergency rate increase for PCAs and other homecare workers to help pay for paid sick leave, overtime, higher wages, PPE and other sanitizing supplies.

Julie Rosen (R – Vernon Center) – required drug manufacturers to publicly disclose certain information on drug prices and costs for prescription drugs whose price increases exceed certain limits, and for new prescription drugs and newly acquired prescription drugs whose price exceeds certain dollar amounts.

Minnesota AFL-CIO Position: **Support Passage**

Correct Vote: **Aye**

Final Vote: **Passed 99 Ayes and 33 Nays**

End Result: **Signed into law.**

6. State Employee Contract Ratification

House File 2768 – Passage (May 11, 2020/ House Journal Page 8351)

HF2768 – authored by Rep. Leon Lillie (DFL – North St. Paul) – ratified state employee contracts as negotiated.

Minnesota AFL-CIO Position: **Support Passage**

Final Vote: **Passed 74 Ayes and 60 Nays**

End Result: **The contracts were ultimately ratified.**

7. Terminating the Peacetime Emergency

House Concurrent Resolution No. 2 (June 12, 2020/House Journal Page 30 – Special Session)

House Minority Leader Kurt Daudt (R-Crown)



offered a resolution to terminate Minnesota's peacetime emergency. This resolution would end the Governor's emergency powers and executive orders, including Executive Order 20-54, Protecting Workers from Unsafe Working Conditions and Retaliation During the COVID-19 Peacetime Emergency. Similar resolutions were offered at nearly every subsequent Special Session in 2020.

Minnesota AFL-CIO Position: **Oppose Passage**

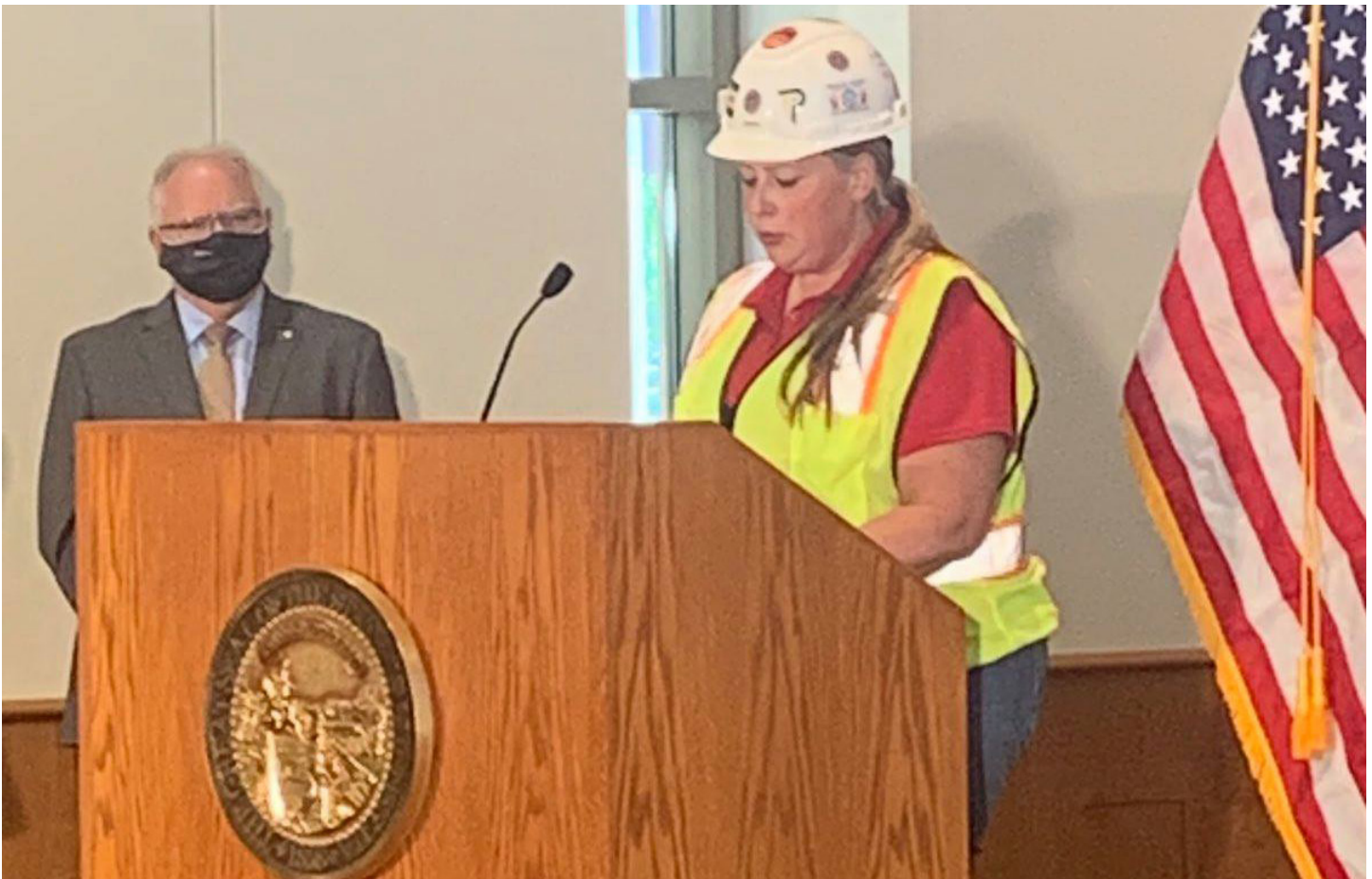
