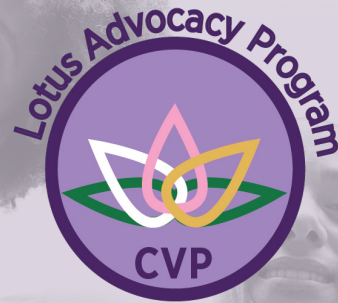

The Center's thrift store provides clients with gently-used household and clothing items donated by the community. Proceeds from the sale of these items go to support all the programs.

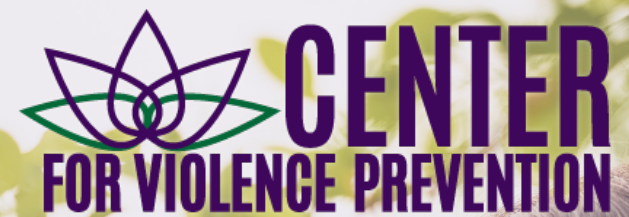

The Center for Violence Prevention offers free supportive services to aid in recovery, healing and justice for victims of interpersonal violence, including **Domestic Violence, Sexual Assault, Human Trafficking and Survivors of Homicide.** Programs and services are trauma-informed and evidence-based and are facilitated by a highly qualified and professional staff. Specialized programs are available to address the unique recovery needs of each victim.

# PROGRAMS

## DOMESTIC VIOLENCE



The Center has been providing emergency shelter and support services to victims of domestic violence since 1990. This issue effects the entire family unit

and often displaces victims and their children, often resulting in homelessness and further victimization. Services are offered to support the recovery and stabilization of victims and children caught up in the cycle of abuse. Specialized programming for children also works to interrupt the intergenerational cycle of domestic violence.

## BRIDGE FORENSIC SERVICES



FORENSIC SERVICES

The Bridge is a community forensic clinic with 24/7 emergency care for patients who have been a victim of sexual assault/rape or strangulation. It provides a safe and comfortable setting with trauma-informed care from an in-house Sexual Assault Nurse Examiner. A soft interview room is also available for law enforcement partners.

## THE TOWER



The Tower, the first specialized human trafficking shelter in Mississippi, opened in 2017 to assist adult victims with their recovery needs. The Tower operates a trauma-informed

program, offering therapeutic and practical assistance to survivors for up to two years to ensure safety, stability and the restoration of autonomy. In addition to residential services, The Tower collaborates with regional task forces to aid in the identification and recovery of victims, as well as the pursuit of those who exploit these victims. A team of statewide Rapid Response Advocates responds to law enforcement, medical providers and other service providers to improve victim access to safety and justice.

## DOMESTIC ABUSE INTERVENTION



Domestic Abuse Intervention Program

Domestic violence offenders may be court ordered to attend this behavior modification program to promote changes in behavior and belief systems that perpetrate abuse. DAIP utilizes

the evidence-based Duluth model over the course of 24 weekly sessions. Volunteer participants may also enroll.

## SEXUAL VIOLENCE



The sexual assault program offers support to encourage healing and recovery through therapeutic resources, medical and legal advocacy and case management. These services are offered to victims of sexual assault regardless of age, gender, or amount of time elapsed since the assault occurred.

Advocates assist survivors in realizing justice for their loved one working through victim compensation, probate, guardianship, media interaction and the criminal justice process.
