As Director, Lt Col Mason directly supports the Pacific Air Forces Commander as advisor on strategic decisions to Headquarters Air Force, U.S. Indo-Pacific Command and thirty-six ally and partner nations. He helps to integrate the Air Component staff to provide synchronized actions for the Commander's strategic communication, aligning the Pacific Air Forces' vision with senior leaders, three Numbered Air Forces, ten Wings and forty-six thousand Airmen. Additionally, Lt Col Mason manages Pacific Air Force's Federal and State Congressional visits and inquires, General Officer strategic calendars, and senior leader speaking engagements.

Lieutenant Colonel Mason, a native of Whitehall, New York, graduated from Siena College in 2008. He was commissioned the same year as a graduate of Rensselaer Polytechnic Institute's Reserve Officer Training Corps program.
