

From the Board President

I'm pleased to update you on a busy year.

Despite a challenging retail environment, General Manager (GM) Ed Powers led the Co-op to achieve yearly sales of over \$5 million. Yet as you'll see in the treasurer's report, we ended the year with a small financial loss. As we move into Fiscal Year 2025, we are determined to bolster the Co-op's resiliency and sustainability amid extreme weather affecting our local producers, customers, and community.

Our Board has two important roles: overseeing the GM through monthly monitoring reports and determining the Co-op's long-term strategy. Last year, we focused on being a good employer by empowering Ed while rigorously evaluating his monthly reports. This year, we've improved the efficiency of our business meetings to allow for monthly strategic conversations.

Moving forward, we have two main priorities:

- Improve communication with member-owners and the broader community. The Co-op newsletter now includes a monthly Board article and executive summaries of meetings. We are exploring additional ways to keep you informed and engaged. We welcome you to our monthly meetings, encourage you to contact us at board@putneyfood.coop, and look forward to resuming in-person events.
- Collaborate with the GM on a strategic plan for the next five years. We'll prioritize understanding our community's needs, assessing our performance, and developing a strategic plan to guide Ed and the Board. Our goal is to position the Co-op for long-term sustainability as a community and economic hub.

We are grateful to the local producers who fill our shelves, the customers who shop with us, and the staff who warmly welcome them. Thank you for being part of our 2,000+ member-owners. I look forward to celebrating with you at our annual meeting and seeing you at the Co-op!

From the General Manager



Dear Member-Owners and Stakeholders

I'm pleased to share that our Co-op has once again demonstrated outstanding sales and a strong commitment to our community. For the second consecutive year, our sales have surpassed \$5 million, a testament to our team's dedication, and the loyalty of our members. While we struggled a bit to make a profit this year due to a slow winter, we are confident that we are on the right path to serving our community even better this year.

As we celebrate our 83rd year in cooperation we have a lot of things to be proud of:

- We are deeply committed to giving back to the community. This year, we have donated over \$4,000 to local charities and community programs.
 These contributions have supported various initiatives, including the Putney foodbank, Putney Community Cares and the Putney Central School.
- Our solar panels are providing over a third of our power needs for the store. We also purchase a large portion of the rest of our power needs from a solar farm.
- Our board works diligently as a cohesive unit, and is always working on how to continue to support the needs of the Putney Community, all while promoting the cooperative model.
- Our membership grew to over 2,000 members last year!
- We have hired 3 former chefs for the deli who are putting out great food daily, and have re-started our theme nights, including 'fish fry fridays', and a burger and pizza night on Wednesdays and Saturdays.

We have big plans for the next few years, including addressing the parking lot, the back of our store's receiving area, and more collaboration with local vendors and the new yellow barn park! We hope that you will join us on this journey, (if you aren't a member already) and tell your friends and neighbors to come to the best little co-op in the country!

From the Treasurer





Our 2024 fiscal year was a challenging one. While the Co-op did once again surpass the \$5 million mark in terms of store sales, we did not surpass last year's sales figures nor see the growth projected in the annual business plan (APB).

The store's margins (the difference between total sales and the cost of goods sold) were also lower than the APB. The biggest factors impacting margins this year were ongoing inflation in the food sector, unseasonable weather in both last summer and winter leading to a lack of tourists, as well as staffing issues. Due to these challenges the Co-op lost \$29,307 (estimated) or .59% of total sales.

While this was certainly not the result we were looking for, the good news is that the Co-op has been able to grow its cash reserves over the past few years and so we are able to absorb this loss without any stress to normal operations. Looking ahead to next year, we anticipate continued challenges with the staffing, as this is an industry wide issue, and so the 2025 APB has a more conservative sales growth from the previous APB. We expect approximately 2% in sales growth and a net profit of \$57,564.

But we see good news on the horizon with the upcoming plans of our longtime neighbors at the Yellow Barn and the opportunities this will bring to the Co-op and the whole Putney community.

The Board is so grateful for the dedication of our GM and employees who have weathered a difficult grocery environment with grace and style!



The Putney Co-op successfully collected donations for the Giving Tree initiative, supporting Putney Winter Cheer which is an annual tradition helping local families and households make the holiday season special. This creates an opportunity for everyone in our community who needs a little cheer to receive a gift card from a local business. We are excited to share some important news about our Round Up program. As part of our ongoing commitment to making a positive impact in our community, we are rebranding the program under a new name: Change For Change. Member-owners will still be able to donate at the register by rounding up their purchase to the nearest dollar amount. Those donations provide meaningful contributions to 3 community organizations selected by your vote! We are excited about this renewed focus on driving meaningful change in our community and encourage you to participate in Change For Change.

Fill the Foodshelf

Twice a year the Putney Co-op facilitates a Putney Foodshelf campaign in which our generous community purchases and donates cases of food that stocks the Foodshelf, helping them to support community members experiencing food insecurity.

Empty Bowls

The Co-op raised over \$1,575 through the sale of handmade bowls in support of Groundworks Collaborative and their Empty Bowls campaign, which benefits hunger and homelessness in our area.




Peggy O'Toole

2024 Voting

In 2024, all member-owners will again have a four-week period when they can vote for Board Directors and on other Co-op issues, either electronically or by paper ballot. The voting period will open on September 15, 2024 and remain open until midnight, October 18, 2024. The Annual Meeting & Celebration will be held from 12-2pm on Saturday, October 19, 2024 and the results announced during the meeting. One Membership, One Vote

- Each membership is allocated one ballot only.
- You must be a member to be eligible to vote.
- Only the designated legal owner of the membership may vote, other household members are not eligible to vote.
- Clearly mark your voting selection with an "X".
