Program Overview

Affordable Connectivity Program (ACP)

The Affordable Connectivity Program (ACP) is a Federal Communications Commission (FCC) benefit program that helps low-income households pay for broadband service and connected internet devices

Eligible households can receive:



\$30 Standard Discount

Up to \$30/month discount for broadband services



\$75 Tribal Discount

Up to \$75/month discount for broadband services for households on qualifying Tribal lands



Device Discount

A one-time discount of up to \$100 for a laptop, desktop computer, or tablet (consumer co-pay of \$10-\$50 required)

ACP benefit is limited to one monthly service discount and one device discount per household

Get Started in ACP

Register with SAM.gov

- **Est. Time:** Allow up to **60 minutes** to complete a new registration
- Register with [SAM.gov](#)* using this [guide](#)
- USAC cannot process reimbursement without an active SAM.gov registration.

Obtain a FRN

- **Est. Time:** Allow up to **15 minutes** to complete a new registration
- Obtain a [Federal Communications Commission Registration Number](#) (FRN)*

Get FCC Approval

- **Est. Time:** **1 – 3 business days** for approval
- Submit an application for [FCC approval](#) to participate in the program
 - Only applicable to non-ETCs; ETCs can submit their ETC designation directly to USAC with their election

Submit Election Notice

- **Est. Time:** **10 minutes** to fill out; **3 – 5 days** to process
- Submit an ACP [election notice](#) to USAC

*Service providers only need to register with SAM.gov and obtain an FRN once – if these steps were previously completed, service providers **do not** need to repeat them for the ACP.

Obtain a Unique Entity Identification (UEI) Number


- Register with [SAM.gov](https://sam.gov) to obtain a Unique Entity Identification Number (UEI)
 - Registration is free
 - UEI is a 12-character alphanumeric ID used in SAM.gov to identify a unique entity
 - UEIs do not expire, but registrations must be updated and renewed annually to remain in “active registration” status
 - USAC will check to verify the UEI is active when reviewing a provider’s election notice
 - A UEI is required for the FCC approval process and to file an election notice

Registering with SAM.gov

- When selecting the purpose of the registration select the “Financial Assistance Awards only” option
- Use the [Entity Registration Checklist](#) to walk you through the process
- You will need the following information to get a UEI
 - Legal Business Name
 - Physical Address (A post office box may NOT be used as your physical address)
 - Date of Incorporation
 - State of Incorporation (Entities outside the U.S. may need to provide alternate information)
 - National Provider Identifier (NPI) – this is for Non-U.S. entities only







Registering with SAM.gov

- Select “Create an Account”
 - Enter your email address
 - Select your email language preference
 - Review and accept Login.gov Rules of Use
 - Click Submit
- You will receive an email to validate the email address
- Follow the instructions in the email to continue the registration process
- Once you are logged in make sure you are on the “[Home](#)” page

Registering with SAM.gov

- Once you have finished creating an account, follow the instructions in the [Entity Registration Checklist](#) to complete the process
- The registration process will ask a series of questions about your entity
- Below are some examples of what will be asked while registering, but this list is not exhaustive:
 - Ownership Details
 - General Information
 - Country of Incorporation, State of Incorporation etc.
 - Financial Information
 - This is your standard Checking or Savings Account that accepts an ACH-EFT Credit; be certain that your bank provides the ACH-EFT ABA Routing Number for your account
 - No payments are issued by paper check, or WIRE Transfer



Registering with SAM.gov

- Below are some examples of what will be asked while registering, but this list is not exhaustive:
 - Points of Contact (POCS) information
 - Size Metrics
 - Locations, number of employees etc.



Registering with SAM.gov

- Service providers are solely responsible for keeping their financial/ACH-EFT information current within the system
- USAC recommends assigning at least two administrators to the registration
 - The admins should keep their accounts active by logging in every 30 days



Registering with SAM.gov

- Can take up to 10 business days once you register for your registration to become active in SAM.gov
- Can check the status of your entity registration using the SAM.gov [status tracker](#)

Check Entity Registration Status

This tool allows you to check the status of your entity registration.



Non-federal users: You may only check the registration status of entities linked to your SAM.gov account.

Federal users: If you need to view registrations that are not publicly available, use the **Search** link in the header menu of SAM.gov, while signed in.

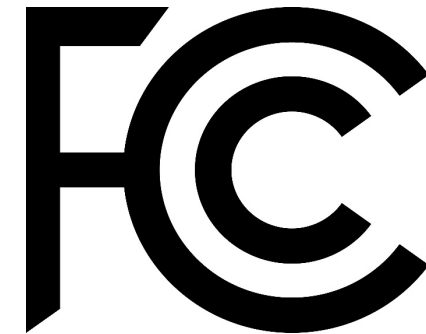

FCC Registration Number (FRN)

A FCC Registration Number (FRN) must be obtained by anyone doing business with the Commission

- The FRN is a 10 digit number which will be required for the FCC approval process and to file an election notice with USAC
- You must obtain an FCC Registration Number (FRN) using the FCC Commission Registration System ([CORES](#))
- If you do NOT have an account in CORES you will need to set one up by creating a username and password

Register for an FRN

- Once you've created an account you will receive an automated email to verify your account's email address and activate your account
- When your account is activated log in to CORES and select "Register New FRN"
- Answer whether the FRN is for an individual or business and whether the address for the contact is within the U.S
- Complete the registration information and click "Submit"
- Once everything is completed you will be directed to a FRN Registration Confirmation page that will show your FRN
 - Print the page for your records

Timeline to get an FRN

- The registration process takes around 15 minutes to complete once you have created an account
- The below information will be asked while registering:
 - The name of the business
 - Type of business
 - Contact Information
 - Taxpayer Identification Number (TIN)
 - For businesses this is an Employer Identification Number (EIN)
 - Password and personal security question/answer for your account



FCC Approval Process

- If your entity is designated as an Eligible Telecommunications Carrier (ETC), then you do NOT have to go through the FCC approval process
 - You will need to send your ETC designation to USAC when filing an election notice
 - An ETC is designated as an Eligible Telecommunications Carrier by either their respective state regulatory commission, or in some cases, by the FCC
- If your entity is NOT an ETC you must complete the FCC approval process
- Once you have started the application you can NOT save a draft
 - Prepare all the required materials before submitting the application

How to Apply – Login

- Applications must be submitted through the FCC’s ACP Application [online portal](#)
 - Log into the system using your CORES username and password
- You can also access the application online by visiting the [Provider FCC Approvals](#) page
 - The “Submit an Application Online” button is at the bottom of the page

How to Apply – Enter Company and Contact Information

How to Apply - Enter Company and Contact Information

Affordable Connectivity Program (ACP)

Broadband service providers should complete this form to obtain FCC approval to participate in the ACP.

The purpose of this form is to allow broadband service providers to submit an application to participate in the FCC's Affordable Connectivity Program (ACP). Providers deemed eligible to participate in the ACP will need to submit a separate election to the Universal Service Administrative Company (USAC) prior to being able to receive reimbursement for providing discounts to eligible households during the emergency period related to the COVID-19 pandemic.

Provider eligibility for the ACP will be determined only after successful submission of this form. Once your application has been reviewed and processed, you will receive an email notification with your FCC approval determination. A member of the FCC may reach out to you for additional information during the review process.

How to Apply – Service Provider Eligibility Questions

- Any broadband provider wishing to participate in the ACP must show an FCC Form 477 filing demonstrating it provided broadband service:
 - Providers that file FCC Form 477 should reference the most recent filing that shows broadband service in the jurisdiction
 - For providers that have no filed FCC Form 477 they should provide other documentation or certification from an authorized employee or representation demonstrating end-user broadband service was offered
 - This can include redacted subscriber bills, publicly available broadband advertising, broadband resale agreements and similar documentation showing the applicant offers end-user broadband service

How to Apply – Service Provider Eligibility Questions

- Demonstration of authority to operate in the jurisdiction(s)
 - A provider seeking FCC approval to participate in the program must list each jurisdiction in which it seeks to be approved to offer ACP services
 - Providers only need to identify the state or territory where it plans to offer ACP service
 - Providers must submit documentation showing their authority to operate in a jurisdiction
 - Ex. Certificate of public convenience and necessity, annual filings to regulators, certificate of good standing, articles of incorporation, or any similar document showing they can provide broadband service in the jurisdiction

How to Apply – Certification Statements and Signature Statement

- Once all of the eligibility questions are complete and supporting documentation has been uploaded you must complete the certification statements
- Read all of the certifications and check the required boxes
- Enter the required fields to complete the signature statement section
- When finished select “Submit” on the right side of the page

How to Apply – Certification Statements and Signature Statement

Certification Statements

- * The Applicant consents to the disclosure of the information included in this application, including the company contact information, with third-parties administering the Affordable Connectivity Program on behalf of the FCC.
- * The Applicant certifies and acknowledges, under penalty of perjury, that if approved will comply with all applicable ACP rules, requirements and procedures, including waste, fraud, and abuse protections. Specifically:
 - The provider will confirm a subscriber's eligibility through either the National Verifier or a Commission-approved eligibility verification process prior to seeking reimbursement for the respective subscriber.
 - The provider will follow all enrollment processes and obtain all certifications as required by the ACP. This includes providing eligible households with information describing the Program's eligibility requirements, one-per-household rule, and enrollment procedures.
 - The provider will interact with the necessary USAC databases including the National Verifier, NLAD, and RAD before submitting claims for reimbursement. This includes the necessary checks to ensure the household is not receiving duplicative benefits.
 - The provider will de-enroll any household it has a reasonable basis to believe is no longer eligible to receive the benefit consistent with ACP requirements.
 - The provider will comply with the ACP's document retention requirements and will make such documentation available as requested to the Commission or USAC.
- * The Applicant certifies and acknowledges, under penalty of perjury:
 - That it will comply with all applicable federal and state laws, including the Americans with Disabilities Act, the Rehabilitation Act, the False Claims Act, the Anti-Kickback Statute and the Civil Monetary Penalties Law.
- * The Applicant certifies and acknowledges, under penalty of perjury:
 - That neither the Applicant nor any other party to the Application is subject to a denial of Federal benefits that includes FCC benefits pursuant to Section 5301 of the Anti-Drug Act of 1988, 21 U.S.C. § Section 862, because of a conviction for possession or distribution of a controlled substance. See 47 CFR § 1.2002(b) for the meaning of "party to the application" for these purposes.
- * The Applicant certifies and acknowledges, under penalty of perjury:
 - That all of its statements made in this application and in the attachments or documents incorporated by reference are material, are part of this application, and are true, complete, correct, and made in good faith.

Common Mistakes – FCC Approval Process

- Providers will need to monitor notifications from the system regarding follow-up documentation requests
 - The email associated with the CORES account and the contact email listed in the application will receive email notifications
- If the documentation is difficult to understand a short (1-2 page) narrative may be required to clarify and solve and reviewer questions

Timeline to Complete FCC Approval Process

- On average it takes less than an hour to complete the application
 - It's important that all of the documentation is gathered beforehand
 - Follow the [ACP Provider Application Instructions](#) and review the [Provider FCC Approval](#) page before starting the application
- If the application is complete, it will be reviewed and approved in 1-3 business days

Submit ACP Election Notice and Documentation

Submit an ACP [election notice](#) and documentation including:

- FCC approval of your company's participation in the ACP (required for non-ETCs and ETCs that wish to participate in states outside their ETC designation)
- ETC designation(s) (required for ETCs)
- Connected device documentation (if applicable)
 - Review USAC's [Participate in ACP](#) page to find more information about connected devices
 - All service provider who offer a connect device must complete the [ACP Device Information Form](#)

Filing an Election Notice

When filing an election notice:

- Read all sections of the form
- The fields are clickable within the pdf
 - Some have hyperlinks to share what information is needed
- All of the fields must be completed unless noted as “if applicable”
 - If the form is incomplete this will delay processing
- The FRN, Employer Identification Number(EIN)/Tax Identification Number (TIN) should all be associated with the same entity filing the election notice

Filing an Election Notice


When filing an election notice:

- The DBA (doing business as) name entered on the election form will be the name that is listed on the [Companies Near Me](#) (CNM) Tool
 - The CNM tool helps consumer find service providers who participate in the program
 - If the DBA name field is left blank USAC will use the name listed in the Provider Name field
- Email the completed form and all required documentation to ACProgram@usac.org with the subject line “ACP Election Form”

Common Election Notice Mistakes

1. Make sure that your SAM registration status is active
 - USAC will be unable to process your election if your SAM registration is not active
 - Check to see if your registration is active using the SAM.gov [status tracker](#)
 - If your status says “Submitted” your application has been received but is still under review
 - SAM.gov will reach out to you by email when you have an “Active” status
 - USAC may ask for a SAM.gov screenshot showing your registration is active

Common Election Notice Mistakes

2. Include your FCC approval number if you are a non-ETC

- If you are a non-ETC or a provider expanding your service area to a new jurisdiction, you must list your FCC approval number
- All FCC approval numbers begin with EBBA000 followed by a four-digit number
- Once your FCC application to participate is approved, you will receive an approval letter by email from the FCC that includes the number next to where it says “Application Number”

3. Include a valid signature at the end of your election notice

- A valid signature for your election notice can be hand signed OR a valid digital/electronic signature
- It **cannot** be a typed signature
 - Your election notice will be sent back if the signature is not valid

Timeline to File an Election Notice

- If all of the documentation/information is prepared it will take around 10 minutes to fill out the election form
- If a fully complete election is submitted with no errors it will take USAC up to 3-5 days to process
 - If the form is not completed correctly USAC will reach out to resolve any errors on the election form
 - If the form is missing information the processing will be delayed
